- b. Middle Fork Sewer Project The Planning District Commission has completed a door-to-door survey of the Middle Fork Sewer project area. For your review and information, enclosed (Att. 10) is a memo from Aaron Sizemore describing the results of the survey. As you can see, as far as his team was able to tell, the community does not have enough support for a sewer project at this time. We met with the "sparkplugs" who presented the original request and petition to the Board. After discussing the results of the survey with them, the consensus of the group was that the folks who had originally signed the petition did so in support of their neighbors more than anything else. They plan to go back to the neighborhood and continue to talk up the potential of a sewer system and should the sentiment of the neighborhood change, we will certainly move forward with a project.

WHEREAS, Smyth County residents who have planned and practiced a home fire escape plan are more prepared and will therefore be more likely to survive a fire; and

WHEREAS, Smyth County residents will make sure their smoke and carbon monoxide (CO) alarms meet the needs of all their family members, including those with sensory or physical disabilities; and

WHEREAS, Smyth County first responders are dedicated to reducing the occurrence of home fires and home fire injuries through prevention and protection education; and

WHEREAS, Smyth County residents that are responsive to public education measures are better able to take personal steps to increase their safety from fire, especially in their homes; and

A meeting of the Smyth County Budget Committee was held at the County Office Building on Thursday, October 6, 2022, at 10:30 a.m.

Atkins District Supervisor Charles Atkins called the meeting to order at 10:34 a.m.

Mr. Utt discussed the following:

- **1.** <u>Budget Amendment #4</u> Mr. Utt discussed the following projects/needs for consideration.
 - ❖ <u>Solid Waste Rate Increase</u> With the recent rate/fee increases, we need to amend the Solid Waste Department budget to get it in line with the new projections. The anticipated increased revenues and expenditures are in the amount of \$300,000.
 - Opioid Settlement Funds This represents the 1st allocation of funding from the state in the amount of \$24,073. Mr. Utt noted that the funds have been allocated toward the opioid clinic in Washington County that has been partnering with the Appalachian Center for Hope.
 - Municipal Utility Relief Funds The Town of Marion has been awarded an additional \$21,686 in URF funding. Mr. Utt said the funds come to the County but must be forwarded to the Town as soon as possible.
 - * <u>Rail Industrial Access Project</u> Now that the project bidding process has completed, the end result will be that Scholle will be responsible for \$331,370, which will be paid to the EDA and then used to pay the contractor. This amount needs to be incorporated into the budget to allow us to move forward with the project.
 - ❖ <u>PILT Subsidy</u> Mr. Utt noted that the County has received notice that they have been allocated an additional \$242,900 this year and will be allocated an additional amount next year from a separate ARPA funding source. Since the County participates in the Federal Payment in Lieu of Taxes (PILT) program, which provides local government with some modest level of revenue for the acreage that is in the national park, national forest, or other national recreation areas and not taxed accordingly. Mr. Utt stated that according to the program, these funds can be used for any general fund-type expense similar to the existing revenues we receive.

After further discussion, the committee made the following recommendation:

- Motion was made by Vice Chair, Rye Valley District Supervisor Lori Deel to recommend approving Budget Amendment #4 as presented in the amount of \$920,029. Atkins District Supervisor Charles Atkins seconded the motion, and it was unanimously approved.
- **2.** <u>**2nd Quarter Appropriations**</u> Mr. Utt reported that the total appropriations for the 2nd Quarter of FY23 are \$29,983,440 and are broken down as follows:

Chair, Atkins District Supervisor Charles Atkins turned the meeting over to Assistant County Administrator Clegg Williams to introduce Emergency Services Coordinator Curtis Crawford.

Emergency Services Coordinator Curtis Crawford presented a slideshow of the construction progress of the various buildings at the site in Chilhowie pointing out they are now at the finishing stages and ahead of schedule. Mr. Crawford then explained his handout showing the funding breakdown. He stated the items in green have been paid for, the items in orange are funded but are awaiting invoicing and the items in yellow need the second-year disbursement to finalize.

Several committee members expressed how impressed they are with the facility and shared their enthusiasm for everything it will offer.

Mr. Crawford invited anyone who has not toured the facility to contact him or David Haynes with Town of Chilhowie to set up a day and time to do so. He stated there will be a ribbon cutting ceremony in November and will send out invitations to everyone to attend.

Park District Representative Dr. Mike Robinson made a motion to recommend disbursing the second-year allocation of \$285,673 to the Smyth County Fire/Rescue Training Academy. Chilhowie District Representative Ronnie Corvin seconded the motion.

To the Smyth County ARPA Committee

Since we last met, progress for our training center has moved at a quick pace and far exceeded our timeline. Working alongside our Chilhowie counterparts, we have moved our projected open date ahead to the November or December time frame. This has not come without obstacles along the way. Cost for goods across the board have increased from our original projections. Increases to equipment occurred monthly over the summer into the fall. This placed our project into an area of cost that was not anticipated.

After the approval of the funds from the County and the Town of Chilhowie, the Virginia Department of Fire Programs approached the project for office space to place a Chief that would have a primary job of coordinating training across the Commonwealth. In meetings between the Town and County, it was decided we could make the contributions to increase the building size to accommodate this change. This change placed the building cost from each entity at \$175,000 and could be absorbed in some of the pricing of equipment. This opportunity to increase the foot print of this facility is well worth the increase.

With the increase of space, the project was also allowed to provide a testing space that can become another form of revenue to the building. We have worked with Pearson VUE to create 3 testing areas that individuals can come and test for certifications. This would include test for water/sewer department personnel, building department personnel, and of course fire and rescue personnel. At this time, the closest testing area is up to an hour or more away. This increase of services follows our project intention of providing the services for certification with in-County resources.

With the projected increases that were provided by the equipment suppliers as well as the increase of building supplies, the project managers (Chief Haynes and I) moved to purchase equipment in the initial funds to decrease the increases that would be incurred from the inflations in cost. Due to these changes we have looked to rearrange the project to best benefit our funding. This placed part of the building that was projected to be purchased in Phase 1 of the project until Phase 2. Because of these changes, the furnishing and flooring of the building will still be needed to complete the project.

We are not asking for additional funding other than the funding requested in the initial request. We have worked hard to reduce cost when possible to offset the increase. It is noticed that a few items will not be able to be purchased with these funds due to increases in cost. Chief Haynes and I have been working to make the plans to find additional funding for these items through grants and other sources. This would include the conversations we have had with the Virginia Department of Fire Programs to provide funds for the tower and other props in the near future.

Our projected start date was to be mid-summer or after. Our contractor that we procured was able to free space in scheduling to begin right after the Smyth County Board of Supervisors approved the funds. We have worked all summer on construction and see our project well ahead of projected timelines. At this time, we are planning the start of a Fire and EMS academy in January. In order for this timeline to be fulfilled, we are requesting the Phase 2 funds to complete the project. This is a great opportunity for our county to house the premier training facility in Southwest Virginia.



MEMORANDANDUM OF UNDERSTANDING

FOR DEVELOPMENT AND USE OF THE SMYTH COUNTY FIRE AND RESCUE ACADEMY

TRAINING BUILDING

This Memorandum of Understanding Agreement ("Agreement") is made as of May 1st, 2022, between Smyth County, Virginia, a political subdivision of the Commonwealth of Virginia (hereinafter referred to as "County") and the Town of Chilhowie, Virginia, a municipal corporation (hereinafter referred to as "Town") (collectively "the Parties").

ARTICLE I

EXECUTIVE SUMMARY

The Town and County have both agreed in the need for a centralized classroom building to further advance the training of first responders of Smyth County and the public safety agencies within. The Smyth County Fire and Rescue Academy ("SCFRA") Classroom Building will be the anchor point of the full training facility currently owned and operated by the Town and is proposed to provide in-person and virtual learning opportunities to all first responders. SCFRA will be funded on a joint venture from the Parties of this MOU. Benefits to the community and the Parties include increased access to higher education and training opportunities, trained public safety workforce, and a more centralized location for the region to receive public safety training. The Classroom Building will assist in the growth of the public safety sector and cultivate a tradition of safety and specialized training in Smyth County. As the volunteerism mindset decreases throughout southwest Virginia, it is imperative to develop a training program that encourages public safety careers. It should be recognized that this will be an important regional facility, partnering with the Virginia Department of Fire Programs and Southwest Virginia Emergency Medical Services Council to offer high quality programs to increase the number of emergency public safety personnel able to serve throughout Smyth County.

ARTICLE II

RECITALS

- The County has agreed to allot \$175,000.00 to the Town to fund one-half to the construction of the Classroom Building using a portion of their allocation of ARPA funding.
- The Town has agreed to allot \$175,000.00 to fund one-half of the construction of the Classroom Building using a portion of their allocation of ARPA

ARTICLE III

DEFINED TERMS

As used herein the following terms shall have the meanings stated below:

Classroom Building: Refers to the building housing classrooms, administrative offices, restrooms, storage, breakroom, and associated spaces. This structure is to be located at 340 Responder Way, Chilhowie, VA in the Northeast corner of the Fire-Rescue Training Center on property currently owned and maintained by the Town.

Fire-Rescue Training Center: Refers to the facility containing structures and props used in the training of firefighters, first responders and emergency medical personnel. These facilities currently include live fire training building, vehicle fire training prop, pump training prop, fire behavior prop, ventilation prop, and other associated equipment.

ARTICLE IV

AGREEMENT

SECTION 1: ACQUISITION

1.1 Ownership and Property Interest of the Parties.

- 1.1.1 Ownership of the Property. The Town shall retain ownership of the property. No course of conduct or actions by the County will entitle the County to any ownership or title in the property, or any portion thereof.
- 1.1.2 Ownership of the Classroom Building. From the completion of the Classroom Building forward, the building, including training props, will be considered to be jointly owned by the Town and County and both shall share in the operational and maintenance costs as described further in this agreement.
- 1.1.3 Succession of the Town. In the event that the Town moves to no longer operate the Fire-Rescue Training Center, the County will be given the right of first refusal to assume full ownership/operations, and the agreement will be renegotiable with new ownership of the Fire-Rescue Training Center.

SECTION 2: DEVELOPMENT

2.1 Administration. The Town shall administer all construction contracts for the necessary infrastructure and other site improvements; and shall have the usual rights of an owner of a public construction project, including the authority to approve changes and make payments. The Town shall enter into all construction, supply, and other contracts for the work to be performed and materials to be supplied in connection with the Fire-Rescue Training Center and construction of the proposed classroom building.

- 2.2 Reimbursement for Specific Site Work. The Town shall be responsible for all necessary work and materials associated with site preparation, including necessary infrastructure, grading, drainage, and building pads or right-of-way improvements for the Fire-Rescue Training Center. In the event the Town is required to improve any portion of the Fire-Rescue Training Center site beyond the original plans for the classroom building, it is agreed that the County shall be consulted to determine its reasonable proportionate share.
- 2.3 Changes. The Town shall have sole right to require and pay for enhancements and upgrades to any facilities within the Fire-Rescue Training Center site. While the Town may consult with the County for direction or advise, the County will have no authority or right to demand or order changes to the training site or props associated (other than those mandated by State law in the course of development) and shall not be responsible for costs associated with such enhancement or upgrades unless other agreements are made.
- 2.4 Project Management. The Town shall furnish a representative to perform usual and customary functions of a project manager. The County, may, at its discretion and at no cost to the Town, furnish a representative who may consult and cooperate with the Parties regarding site specific improvements only.

SECTION 3: OPERATION AND MAINTENANCE RESPONSIBILITIES

- 3.1 Facilities Inspection, Testing, Repairs, and Planned Maintenance Needs. The Town shall be responsible for all preventative maintenance, required maintenance, required inspections, required testing, and repairs to the Fire-Rescue Training Center. All approved work associated with any inspections, testing and all repairs and maintenance needs for the Fire-Rescue Training Center shall be completed and coordinated by the Town through its usual and customary procurement process. At the end of the fiscal year, the Town will invoice the County for one-half of the preventative maintenance, required maintenance, required inspections, required testing, and repairs annual cost.
- 3.2 Utilities. The Town shall be responsible for all costs associated with necessary utility services for the Fire-Rescue Training Center, including, but not limited to, electrical, gas, water, and phone services. At the end of the fiscal year, the Town will invoice the County for one-half of the annual utility cost.
- 3.3 Insurance. The Town shall provide and maintain in full force liability and property damage insurance through their common insurance carrier. At the end of the fiscal year, the Town will invoice the County for one-half of the annual insurance cost.

- 3.4 Janitorial, Office, and General Supply. The Town shall provide the general supply of janitorial and general day to day operations supply for the Fire-Rescue Training Center, included but not limited to, cleaning, cleaning supply, office supply, and general supply. At the end of the fiscal year, the Town will invoice the County for one-half of the annual supply cost.
- 3.5 Large Procurement Purchases. Any larger or planned maintenance issue that occur, or any cost over \$5,000.00, shall be presented to the Parties during their annual budget development process for further consideration.

SECTION 4: GENERAL TERMS

- 4.1 Conflict Resolution. The Parties desire to resolve any dispute between them as quickly, inexpensively, and efficiently as possible, avoiding the expense and delay of court proceedings. This applies to every potential dispute between the Parties. Consequently, the Parties agree to the following sequence of procedures to resolve such disputes:
- 4.1.1 Negotiation. When either party feels a dispute has arisen, the Party shall notify the other Party in writing of the nature and details of the dispute. Within fifteen (15) days, a meeting shall be held between the Parties to begin a good faith attempt to negotiate a resolution. During this procedure, the Parties shall communicate directly with each other in an effort to reach an agreement which serves the best interest of both Parties. This is considered an administrative prerequisite which must be done prior to mediation or arbitration as set forth below.
- 4.1.2 Mediation. If negotiation as proved in Section 4.1.1 does not resolve the dispute, the Parties shall submit the matter to a neutral private mediator to facilitate further negotiations between the Parties and, if possible, to resolve the dispute upon mutual consent of the Parties. The cost of the mediation shall be borne equally between the Parties.
- 4.1.3 Arbitration. If the dispute does not resolve pursuant to the procedures set forth in Sections 4.1.1 or 4.1.2 above, then the Parties may submit the matter to binding arbitration under Virginia Law. The arbitration may be conducted in Smyth County, Virginia. The fees and costs of the arbitration shall be borne equally by the Parties. The prevailing party shall not be entitled to the recovery of its attorney's fees or costs. Each party shall bear the expense of its own counsel, experts, and preparation and presentation of proof, in connection with all proceedings.

- 4.2 Time of Essence. Time is of the essence with respect to the performance of each and every term, condition, and obligation of this agreement. Each of the Parties shall execute and deliver all such documents and perform all such acts as reasonably necessary, from time to time, to carry out the matters contemplated by this agreement.
- 4.3 **Termination.** The current conditions, restrictions, environmental of the property are assumed to provide for the feasible development of the SCFRAB. The Parties acknowledge that this MOU and any subsequent agreements may be terminated upon thirty days written notice based on the sole discretion of either Party between the time this MOU is signed. During the first five (5) years, if a notice is provided for termination, the Parties will meet to discuss the procedure of termination and the financial procedures to disengage further obligations. The cancellation of the MOU based upon the above circumstances will result in no penalties or damages to any parties after the first five (5) years.
- **4.5 Incorporations of Recitals.** The recitals set forth above are true and correct and are incorporated into this Agreement as though fully set forth herein.

Mr. Crawford discussed the process history and said that bids were due back no later than November 1, 2022. Mr. Crawford discussed current radio tower site and site building configurations. RE: Middle Fork Road Wastewater Assessment (Survey)

Dear Mr. Utt,

The Mount Rogers Planning District Commission ("PDC") conducted public outreach efforts throughout July and August, regarding the sought-after wastewater project in the Middle Fork Road vicinity. Residents of the area were first notified of the assessment by mail in July. A public meeting was held on the evening of August 1, 2022, at Chilhowie Christian Church. After limited attendance, the PDC administration went door-to-door for additional results. Door-to-door surveys were conducted on two separate occasions and all serviceable households were visited at least once.

Following these three events, survey results were compiled and placed on a map that represented the project area. Sixteen citizens told assessors that they were not interested or had no desire to connect to a public wastewater system. Many of these residents were pleased with the septic systems they currently use. Fifteen households were undecided about the public utility. Ten households confirmed their interest in the service and were willing to sign a user agreement with the provider. The number of residents against the project outweighs the residents in favor of the service. In conclusion, the findings are not enough to support a public utility grant application.

The PDC is thankful to Smyth County for the opportunity and future endeavors alike.
