Rich Valley Agricultural and Fair Association, Inc. (The Fair) — Application for Special Use Permit to expand a non-conforming use: Mr. Williams explained The Fair's application for a Special Use Permit to expand a non-conforming use on their property identified as Tax Map

Nos. 19-A-51, 19-A-36B and 19-A-36C, located at 325 and 329 Long Hollow Road in Saltville. He stated The Fair applied for a similar application in 2010 and is now requesting additional activities be allowed. He spoke about his discussion with The Fair regarding the necessity to continue following the County's Music Festival Ordinance for musical concerts. He referenced the relevant Zoning Ordinance sections. Notice of tonight's public hearing was advertised in the Smyth County News & Messenger on March 14 and 21. Additionally, a first class mailing was sent to each of the applicant's adjoining property owners and he did not receive any comments.

Mr. Lenny Robbins was in attendance representing The Fair to address questions and concerns. He stated The Fair does not yet have any of these activities booked but would like to offer them should the opportunity arise; they are just planning ahead. He was questioned about the days and hours of operation. He stated that they only intend to offer six or seven events per year and the proposed events would be held on Friday and Saturday nights. Regarding a closing time, he said they hope to be done between 12:00 midnight and 1:00 a.m. He stated The Fair would continue to work around other activities and fairs in Smyth County and would comply with the additional requirements in the County's Music Festival Ordinance. CPV – Letter of Substantial Accord: Mr. Williams explained this matter has been before the Planning Commission and Board of Supervisors previously. He recapped the history of CPV, the County's Comprehensive Plan and CPV's request for a Letter of Substantial Accord. Ridgeview Contractors, LLC (Ridgeview) — Application for Special Use Permit to operate a Service Business: Mr. Williams explained Ridgeview's application for a Special Use Permit to operate a Service Business on property they are leasing from Brandi Heath identified as Tax Map No. 55-A-14, located at 585 Fox Valley Road in Marion. He referenced the relevant Zoning Ordinance sections. Notice of tonight's public hearing was advertised in the Smyth County News & Messenger on September 12 and 19. Additionally, a first class mailing was sent to each of the applicant's adjoining property owners and he did not receive any comments.

Carol Hash of Ridgeview Contractors, LLC was present to address questions and concerns. She stated the Ridgeview is contracted by VDOT for five years to provide traffic control for work on I-81. After five years their contract can be renewed yearly. They are scheduled to work Monday through Friday usually from 6 a.m. to 6 p.m., they have three full time employees, five trucks with crash cushions and two service trucks. They are also responsible for responding to

accidents along I-81 that requires traffic control 24 hours a day . The dwelling is essentially used as a dispatch and for paperwork but typically no one is there. Maintenance of vehicles is conducted elsewhere.

Marivene Slemph, Algie Crouse and Susan Massey all spoke in opposition with concerns about increased traffic of oversized vehicles and the beauty and tranquility of Fox Valley Road being disrupted by “commercial uses.”

There was discussion regarding the rodeo and service business approved by the Board for Seth and Brandi Heath on the other end of Fox Valley Road. It was explained that those applications were approved in the past and the Board and Commission could only address the application for Ridgeview. Mr. and Mrs. Heath were present and explained their service business is for snow removal along I-81, not traffic control, and the two businesses are two separate entities.

No one else spoke on the application.

Chairman Wade Blevins and Chairman Sparks closed the joint public hearing at 7:20 p.m.

Chairman Sparks reconvened the Commission at approximately 7:31 p.m. and opened the floor to the Commissioners for comments or questions.

Recommendation on the request by Ridgeview Contractors, LLC. request for a Special Use Permit to operate a Service Business: Commissioner Graham Davidson Jr. made a motion to recommend the Board approve the Special Use Permit requested by Ridgeview Contractors, LLC to operate a Service Business with the following restrictions: only six (6) commercial trucks with crash cushions for the business and two (2) service trucks are permitted on the premises, this does not include personal vehicles. The property is identified as 585 Fox Valley Road in Marion; Tax Map No. 55-A-14; and is zoned Agricultural/Rural. Commissioner Hazel Wagoner seconded the motion.
