<u>JMB Investment Co., LLC — Application for Map Amendment</u>. Mr. Williams explained JMB Investment Co.'s intention to seek a map amendment to rezone the five tracts of land from Agricultural/Rural to Commercial. The five tracts combined contain approximately .86 acres and are identified as Tax Map Nos. 71F-6-1, 71F-6-2A, 71F-6-3, 71F-6-4 and 71F-6-5. Mr. Williams made reference to the applicable state and county code sections as well as pointed out it's designation as Commercial/Industrial in the County's 2013 Comprehensive Plan's future land use section. He stated with their application, they submitted the required fee and notice of the public hearing was advertised in the Smyth County News & Messenger on January 14 and 21. Additionally, a first class mailing was sent to each of the applicant's adjoining property owners. He stated the office had not received any phone calls or written correspondence regarding the application

Tim Dunaway was present representing JMB Investment Co. LLC. He stated Dollar General is proposed to be constructed on the five tracts referenced by Mr. Williams. He acknowledged the site is located in the floodplain and they were working with engineers to comply with floodplain regulations. He addressed questions about storm water runoff and VDOT entrances.

No one else spoke on the application.

<u>Thornton and Star Sexton – Expansion of Non-conforming use Special Use Permit request</u>. Mr. Williams stated Thornton and Star Sexton established Sexton's Inc, a welding shop prior to the adoption of the Zoning Ordinance. He explained their welding shop is a non-conforming use; therefore, they are requesting a special use permit for the construction of an addition to their business. He stated notice was advertised on January 14 and 21 in addition to letters being mailed to all adjoining property owners. He said he had not received any questions or comments.

Mr. Sexton was present and apologized for constructing a 40' x 50' addition to his shop without first obtaining the necessary permits. He presented a petition signed by neighbors supporting his business.

On Thursday July 20, 2017, the Smyth-Wythe Airport Commission voted unanimously in favor of Mr. Brandon Farmer to build a garage on his property of 641 Knight Road, Rural Retreat, Va. As long as he abides by the requirements placed by the Federal Aviation Administration by installing and maintaining an obstruction light in accordance with FAA Advisory circular 70/7460-1L Change 1, Obstruction Marking and Lighting, red lights – Chapter 4,5(red), and 12. Any failure or malfunction of its position, should be reported immediately to (877)487-6867 so a notice to airman (NOTAM) can be issued. As soon

as normal operation is restored, notify the same number. There is no need for a generator in the event of a power outage at this time.

In compliance with State Code §15.2-2204 and §11-110 of the Airport Safety Zoning Ordinance, Mr. Williams stated notice of the hearing was published in the Smyth County News on Saturday, July 15 & 22.
