

## **New Somerset Tennis Courts Coming Soon**

The complete renovation of Town tennis courts is scheduled to begin on or about Monday, June 13th. Renovation will include a new Nova Pro Bounce surface, new fencing, new

windscreens, a new keylock security system, and improved drainage.

Work is expected to take 4-5 weeks. With luck we'll be playing on our courts again by mid July. In the meantime, we have arranged reciprocal privileges with the Somerset House condominiums. Please note the following instructions for using their courts:

- **Reserve court time** 72 hours in advance by calling **301-654-6780**.
- Present your **Somerset tennis card** at the gatehouse for admission.
- Sign the **required waiver** the first time you play.
- There are only nine **visitor parking** spaces. Best to walk, bike or carpool.
- **Guests** are OK as long as one player is a Somerset tennis-card holder.
- **Instructors** are not OK.

There are blackout times. We are NOT allowed to use their courts on Saturdays 10:00 a.m. to 11:30 a.m., Sundays 3:30 p.m. to 5:00 p.m., Mondays 5:00 p.m. to 6:30 p.m., Tuesdays 8:00 a.m. to 9:30 a.m., Wednesdays 3:30 p.m. to 5:00 p.m., Thursdays 8:00 a.m. to 9:30 a.m., Fridays 3:30 p.m. to 5:00 p.m.

#### **Maximizing Resources**

As most know, Somerset was recently named America's second-snobbiest city — for those of 20,000 residents and under — by the national website AreaVibes. (http://www.areavibes.com/library/10-snobby-small-towns-america)

While I took that news with a grain of salt and a sense of humor, it did lead me to once again be mindful of how resource-laden we are, especially since the "snobby index" included ease of accessibility to art galleries and theatre. Thankfully, no one who is rational would truly believe that just because you have a nice house and good schools around means you are a snob. No one I know in Somerset thinks he or she is any better than others just because they have a beautiful house and excellent education. And this was the kind message I gave to all the media mavens who called me for comment after the survey came out. I also reminded everyone of how much our folks "give back."

On the other hand, I paid more attention to a different study that was actually more provocative. This one, from Emily Bianchi of Emory University and Kathleen Vohs of the University of Minnesota, found that those with more resources spent less time socializing with others, including neighbors, and more time alone. While the study made sense when I read the details, I was happy to realize that the conclusion was clearly not applicable to Somerset. Because we are a municipality with many programs and frequent communication, e.g, the Town Journal and the Town website, we have many opportunities to get to know our neighbors

better, create friendships and plan get-togethers. Activities the Town funds, like the swimming pool, tennis courts, swim team, special events and public meetings help foster our wonderful sense of community that apparently doesn't happen in most other "snobb" places!

I feel very grateful knowing that what the Council, staff and I do every day leads to many benefits for our townspeople. I highly recommend that everyone review these two studies and give them some thought. I hope they will make you feel even more proud of where you live.

# **New Kensington Middle School Could Impact Somerset Students in 2017**

Over the last five months, the PTA at Somerset Elementary School has been involved in active discussions with the Montgomery County Board of Education (BoE) about an important boundary issue concerning a new Bethesda-Chevy Chase middle school. This new school will open in Kensington in 2017. Decisions about which students will attend the new school versus Westland will be made by the end of this year.

A boundary study, authorized by the Board of Education in 2015, projected increasing enrollment at Westland Middle School resulting in a space deficit escalating to 579 slots in 2017-2018. The new B-CC Middle School under construction in Kensington will have space for 930 students. The seven elementary schools involved in this boundary study were clustered into 10 different options on the basis of the following criteria: minimize distance; promote comparable race/ethnic demographics; promote comparable ESOL and Free and Reduced-price Meals demographics; and consider availability of public transportation and future housing developments. Only option number 9 includes Somerset ES in the B-CC Middle School cluster, and it is one of the least popular among all parents. Specifically, Option 9 would send students from Somerset ES to the new B-CC middle school, while students in Bethesda ES and Chevy Chase ES, who are north of Somerset, would have to come south past Somerset to Westland Middle School. PTA representatives from the seven schools are currently members of the Advisory Committee, and they had until June 1st to turn in their position papers for the final evaluation.

Later this month, the committee will send a report to the Superintendent who will make his recommendations for the Board of Education's final decision. November will be the critical time when the Board of Education will hold public hearings before making their decision, and this is exactly when we, parents, should submit our opinions.
