## On My Mind

### Civility and Respect, Again

Last month I wrote about how important it is for us all to speak up where there is injustice. This month I want to applaud a Town resident who has done just that.

While we continue to be shocked by some of the language used in the national discourse these days, unfortunately we will have to learn to adjust to this abuse for the next four years – and respond appropriately. However, I am sad to report that even in Somerset not everyone is as respectful of people's differences as I would like.

Last summer at one of our Town facilities, apparently, and for whatever reason, a resident chose to be "extra loud" on a number of occasions and to use what I would consider to be inappropriate references to the diverse ethnic backgrounds of some of those present. I was told that witnesses to these instances were highly offended and one of them, gratefully, reported this to Town leadership.

This presented somewhat of a dilemma because we always allow free speech, per the First Amendment. Fortunately, our Somerset rules are written in such a way that allowed us to apply them in this instance and to reprimand this individual, but perhaps not to the extent that satisfied those allegedly offended.

It is my hope, however, that by using my mayoral bully pulpit here, I can encourage all Somerset residents to be sensitive and respectful in their speech at all times, especially in public spaces in Town. We must learn to understand each other better in order to build an even stronger community.

I want to thank this resident for the persistence in bringing this matter to my attention. I am confident that such persistence will eventually bring positive results

## Helping Hand . . . Lend One or Accept One

Take a look at a back page of your Town Journal. There, every month, you will see an image of two slender, gray hands. One reaches up hopefully, while the other reaches down with intent to clasp and help. The small four-line notice that follows tells Somerset residents that a helping hand is just a phone call away . . . be it for a ride to the doctor or a prescription pick-up at the pharmacy.

How does Helping Hand work? Well, it's a two-pronged operation comprised of volunteer helpers and those needing help. You can be both. I signed up to be a volunteer, which, simply put, means that my email address went on a list of volunteers. I am notified, along with 30 other volunteers, when one of our town residents asks for an assist. For example, the email might read, "A neighbor needs someone to take her to an appointment at the Fernwood medical complex on Wednesday, Feb. 3 at 1:00 p.m. The appointment will likely last one hour." No name, phone number or address is given. Only when you respond to the request by calling a program facilitator will you be put in touch with the neighbor making the request. The two of you will arrange the details.

### Income Tax Code for the Town of Somerset

With tax season here, this is just a friendly reminder to make sure you mark the Town of Somerset as your local jurisdiction on your tax returns. This will help to ensure Somerset receives its appropriate allocation of income tax revenue. In addition to marking Town of Somerset, please mark the appropriate tax return code for Somerset, which is **1610**.

### Tennis Passes for 2017

2017 tennis passes are now available in the Town Hall. The cost per household for 2017 is \$25.00 for a family pass. Please stop into the Town Hall to secure your pass if you intend to use the courts this year.

#### **Door-to-Door Solicitation**

I periodically receive messages concerning door-to-door solicitation in the neighborhood. Applicants can get door-to-door vendor licenses from Montgomery County. However, they should clearly present their badge and information concerning their license. Door-to-door solicitors should be reported to the Montgomery County 2nd district in the interest of safety. The Police Department has the ability to check that the solicitor has a permit. The contact info for the Montgomery County 2nd district is **240-773-6700**. Email is **2DCommander@montgomery countymd.gov.** The non-emergency police phone number for all of Montgomery County is **301-279-8000**. In an emergency, dial **911**.

### Winter Season Reminders Snow Removal

Mulheron Tree Experts will again be the Town's contractor for snow removal. Regarding sidewalk cleaning, please be advised that the Town Code now authorizes our contractor to maintain the public sidewalks in the community. If individual property owners would still like to assist with the clearing of the sidewalk adjacent to your property, please feel free to do so. It would ultimately help the



complete operation.

#### **Snow Plows**

Please be mindful of the plows that clear our roads by doing your best to keep cars parked in driveways instead of on the streets. This enables the plows to do a better job.

### **Odd Jobs Helpers**

Please keep in the mind that the "odd jobs" list of potential helpers can be distributed to Town residents upon request. If you are interested in hiring someone for snow shoveling or maintenance around your property during the winter months, take a look at this list. You can also view the list by logging into the new Town website with your unique username and password.

### **Batting Cage**

The batting cage located at the Town Hall has been closed from December through February. The cage will open again in early March.

### Sled Hill Rules on Cumberland

- The Town Ordinance was amended last winter with respect to how long the hill shall remain unplowed: 24 hours after a substantial snowfall. After this time period, the contractor will plow and salt the roadway.
- Sledders: sled at your own risk! The Town of Somerset does not monitor the sledding hill. It is the responsibility of parents to supervise children. The sledding area is on Cumberland Avenue from Surrey Street west to 4902 Cumberland Avenue.
- Sledders: Be courteous to those who live on Cumberland.
- Sledders: Respect parked cars and private property.
- Motorists: Drive carefully! Children sledding! The street is officially open.
- Motorists: Enter from top of hill and depart downhill. Vehicles are not permitted to travel up Cumberland from Devon Lane.
- Residents on Cumberland: Please consider parking cars in your driveways when sledding is occurring.

# Temporary Signs in the Right of Way and Private Property

Please keep in mind that commercial signs are not permitted to be placed in the Town Right of Way. To place temporary signs on your private property, a permit is required from Montgomery County. ## Let's Get Ready for Swim Team!

The Basics The **Somerset Dolphins** compete in the Montgomery County Swim League (MCSL). The team is open to any Town resident, 6-18 years of age, who can pass the deep-water test and is assessed by the coaches, in their sole discretion, as being water-safe for the team. The team practices every afternoon after Memorial Day and each morning and afternoon after school is out. There are two meets a week from mid-June through July. All swimmers compete in Wednesday night meets. Competitive Divisional Swim Meets occur every Saturday morning where the top three swimmers in each event (top six in freestyle) compete. There are social events throughout the season, including pizza parties, a pasta potluck, a dessert contest and breakfast with the coaches. At the end of the season we celebrate with a banquet including trophies, skits and a slide show. Our swimmers range from "just for fun" to highly competitive - everyone is welcome and everyone has a chance to participate, have fun and be recognized.

### The Minis

Minis are the developmental team for little swimmers who cannot pass the deep-water test. Mini swimmers are between 4 and 7 years old and must be able to put their face under water. They practice three days a week after school is out. There is one Mini meet and Minis are encouraged to attend all social events, including the banquet.

### Parent Volunteering

Unlike soccer or basketball where one or two parents coach and organize, swimming requires participation from all parents. It takes at least 20 volunteers to run a home swim meet. If you are not a rep, official, in automation, clerk of course or announcing, you should plan on working concessions or timing. We will send out volunteer options for sign-up, but if you do not volunteer you will be assigned. You don't have to attend in person and you can send a substitute, but if your child is swimming you should expect to have a job.

From maintaining the budget and presenting it to the Town, meeting weekly with the League, organizing meet operations, hiring and managing coaches or planning to feed the masses at concessions, this group works hard to make it all run smoothly. Being on the list comes without obligation. You may go weeks or months without responding due to your own busy life and obligations. Requests vary. Over the years, I have brought meals (even frozen ones from Trader Joe's) to post-op patients, taken a wheelchair-bound neighbor to his office, another to chemo at Georgetown University Hospital, and babysat a sick husband while his wife went out for a quick run. It's been fun and rewarding. I have struck up friendships with people I would never have met otherwise. Know this: Just because you help someone once, does not mean that you become their "go-to" helper the next time round. If they need help again, they must once again call a facilitator.

Harder for me was asking for help. After shoulder replacement surgery last year when I couldn't drive to my physical therapy sessions, I exhausted other options before picking up the phone and calling Helping Hand. To think of oneself as a "helper," but not someone who ever needs help, is sheer arrogance, I finally concluded. I called and a kind man named Jim gathered me up and delivered me to my appointment and home again. Next time, I won't hesitate. Since then, I have talked to several people who have been reluctant to ask for help. Once they understood how Helping Hand works, they embraced the program.

We are a lucky, lucky Town to have Helping Hand, and lucky again to have three dedicated facilitators who will sign you up to be a helper and take your request for help when you need it. ## New Lawn Care Law

On January29th, Stan Edwards from the Montgomery County Department of Environmental Protection educated

a group of Somerset residents on the new County Lawn Care Law that will take effect in January, 2018. This law states that potentially hazardous pesticides (includes insecticides, herbicides and fungicides) cannot be used to treat residential lawns or playgrounds. Montgomery County will implement a "pesticide free" parks program. There are exceptions to this law, as certain invasive plants can warrant targeted pesticide use. Agricultural lands, athletic fields and golf courses are not subject to this law. The purpose of this law is to protect the public health and welfare of its citizens, especially children who are most vulnerable to the harmful effects of these substances. For this reason, the Town of Somerset limited the use of pesticides on town land back in 2013.

A panel of landscapers, including John Shorb from Shorb Landscaping, Edamarie Mattei from Backyard Bounty and Matt Glover and David Wray from Wray Brothers also addressed the group. They all concurred that the law will not greatly affect their lawn-care services. They are already following the Maryland Fertilizer Law that limits the amounts of nutrients that can be applied to lawns and their main strategy is to test the soil, aerate and add compost, reseeding when necessary. They also emphasized that grass should not be cut too short and that applying infrequent deep watering is preferable to use of a daily sprinkler. They were clear that they listen to their customers' desires. If you want a sustainable lawn and a lawn without pesticides this year, speak up to your landscaper!
