

**STEUBEN COUNTY RECOMMENDED SPECIAL PROBATION CONDITIONS  
FOR JUVENILE SEX OFFENDERS**

The \_\_\_\_\_ Circuit/Superior/Probate Court hereby imposes the following special probation conditions upon \_\_\_\_\_ in Cause No. \_\_\_\_\_.

The special conditions checked below apply to you as a result of you sex offense adjudication and should be initialed by you after you have read these conditions or after these conditions have been read to you. Violation of any of the special conditions checked below can result in modification/revocation of you probation and detention.

\_\_\_\_\_ 1. You shall register with local law enforcement as a sex offender within seven (7) days of being released to probation supervision if ordered by the Court, in accordance with IC 11-8-8-5(b)(2) and IC 11-8-8-7(g).

\_\_\_\_\_ 2. You shall attend, actively participate in and successfully complete a court-approved sex offender treatment program as directed by the court, pursuant to IC 31-37-19-17.4. Prompt payment of any fees is the responsibility of you and/or your parents, and you must maintain steady progress towards all treatment goals as determined by you treatment provider. Unsuccessful termination from treatment or noncompliance with other required behavioral management requirements will be considered a violation of your probation. You will not be permitted to change treatment providers unless the court gives you prior written approval.

\_\_\_\_\_ 3. You shall not miss any appointments for treatment, psychotherapy, counseling, or self-help groups without the prior approval of you probation officer and the treatment provider involved, or a doctor's excuse. You shall comply with the attendance policy for attending appointments as outlined by the court. You shall continue to take any medication prescribed by you physician.

\_\_\_\_\_ 4. You must complete any evaluations when/if recommended or ordered during your treatment program. Such evaluations may include but are not limited to psychological testing, clinical interviews, specialized offense-specific tests and polygraphs.

\_\_\_\_\_ 5. You shall be required to inform all persons living at your place of residence about all of you sex offense-related adjudications. You shall notify your probation officer of any changes in the home situation (i.e. marital status, pregnancy, etc.) and educational status.

\_\_\_\_\_ 6. Your probation officer must approve of any employment and may contact your employer at any time. Before you become employed, your work site must be approved by your probation officer. You are prohibited from working as a babysitter, including babysitting for siblings, family members and children of friends.

\_\_\_\_\_ 7. You shall have no unsupervised contact with children under the age of \_\_\_\_\_ or children who are physically or mentally handicapped. Supervised contact requires that supervision be provided by a responsible adult who is aware of your offense.

\_\_\_\_\_ 8. You shall have no contact with your victim or victim's family unless approved in advance by your probation officer and treatment provider for the benefit of the victim. Contact includes face-to-face, telephonic, written, electronic (including instant messaging and internet chat rooms), or any indirect contact via third parties.

\_\_\_\_\_ 9. You must have permission from your probation officer before participating in extra-curricular activities such as, but not limited to, youth groups, Boy Scouts, Girl Scouts, Cub Scouts, Brownies, 4-H, YMCA, YWCA, Church groups, or youth sports teams and you must inform the activity's leader of you adjudication.

\_\_\_\_\_ 10. You shall not access the internet or any other on-line service through the use of a computer, cell phone, iPod, Xbox, Blackberry, personal digital assistant (PDA), pagers, Palm pilots, televisions, or any other electronic device at any location (except school computers under adult supervision) without prior approval of your probation officer. This includes any Internet service provider, bulletin board system, e-mail system or any other public or private computer network. You shall not possess or use any data encryption technique or program.

\_\_\_\_\_ 11. You shall not view or possess obscene matter as defined by IC 35-49-2-1 or child pornography as defined in 18 U.S.C. 2256(8), including but not limited to: videos, magazines, books, DVDs, television programs and material downloaded from the Internet.

\_\_\_\_\_ 12. You shall submit to substance abuse evaluation and follow all recommendations of your treatment provider at your own expense.

\_\_\_\_\_ 13. You shall not travel alone after \_\_\_\_\_pm (including but not limited to driving, walking, bicycling, etc.) unless given permission by your probation officer or accompanied by a probation-approved supervisor.

\_\_\_\_\_ 14. You shall not be present at any parks or public beaches where children are known to congregate, schools, school-sponsored activities, amusement parks, playgrounds, day care centers, or any other place designated by your probation officer unless given written permission by the Court or your probation officer.

\_\_\_\_\_ 15. You shall allow your probation officer and/or probation computer service representative, to conduct periodic unannounced examinations of your home computer(s) equipment or other electronic equipment with access to the internet. Such examinations may include retrieval and copying of all memory from your computer(s) and other electronic equipment, and any internal or external peripherals to ensure compliance with your special probation conditions, and/or removal of such equipment for the purpose of conducting a more thorough inspection. Your probation officer may have installed on your computer(s) or other electronic equipment, at your expense, any hardware or software systems to monitor your computer use.
