

ORDINANCE O-32-2016

AN ORDINANCE PROHIBITING THE OPERATION OF SPECIALIZED MOTOR VEHICLES, INCLUDING LOW-SPEED AND UNDER-SPEED VEHICLES, MOTOR SCOOTERS, CAB-ENCLOSED MOTORCYCLES, AND MINI TRUCKS ON ANY STREET, HIGHWAY OR ALLEY WITHIN THE VILLAGE OF STRASBURG, OHIO. HOWEVER LOW-SPEED SPECIALIZED VEHICLES (MODIFIED GOLF CARTS) SHALL BE PERMITTED TO BE OPERATED ON ALL STREETS, HIGHWAYS AND ALLEYS WITHIN THE VILLAGE OF STRASBURG, OHIO, EXCEPTING NORTH AND SOUTH WOOSTER AVENUE, PROVIDED THAT LOW-SPEED SPECIALIZED VEHICLES MAY CROSS WOOSTER AVENUE, BUT ONLY AT THE LIGHTS AT THE INTERSECTIONS OF FIRST STREET (EAST AND WEST) AND SECOND STREET (NE AND NW) WITHIN THE VILLAGE OF STRASBURG, OHIO, EFFECTIVE DECEMBER 31, 2016, AND DECLARING AN EMERGENCY.

WHEREAS, Substitute Senate Bill 114 as passed by the General Assembly of the State of Ohio has permitted the operation of specialized motor vehicles, including low-speed and under-speed vehicles, motor scooters, cab-enclosed motor cycles and mini trucks under certain terms and conditions in the State of Ohio; and

WHEREAS, it has been determined by the Village Council of the Village of Strasburg, Ohio that the operation of these specialized motor vehicles is not in the best interests of the residents of the Village of Strasburg, Ohio, excepting the operation of low-speed specialized motor vehicles (modified golf carts).

NOW, THEREFORE, BE IT ORDAINED by the Village Council of the Village of Strasburg, Ohio, as follows:

SECTION 1: That no specialized motor vehicles, including low-speed and under-speed vehicles, motor scooters, cab-enclosed motorcycles, and mini trucks, shall be operated on any street, highway or alley within the Village of Strasburg, Ohio, except as set forth in Section 2 below.


SECTION 2: Low-speed specialized motor vehicles (modified golf carts) shall be permitted to operate on all streets, highways or alleys within the Village of Strasburg, Ohio, except they shall not be permitted on North Wooster Avenue or South Wooster Avenue except to cross Wooster Avenue at the traffic lights at First Street and Second Street North. Further, the operation of low-speed specialized motor vehicles (modified golf carts) is conditioned upon them being "street legal", and meeting all of the requirements of the ORC that apply to other motor vehicles in the State of Ohio, including, but not being limited to the requirement that the operator must have a driver license, the vehicle must be registered, display license plates, and shall be equipped with headlights, tail lights, brake lights, turn signals, rearview mirrors, and any other item required of motor vehicles within the State of Ohio, and must be registered with the Strasburg Police Department.

SECTION 3: All Ordinances or Resolutions, or parts thereof, inconsistent with the terms of this Ordinance are hereby repealed.

SECTION 4: This Ordinance is hereby declared to be an emergency measure, and its immediate passage is necessary for the preservation of the public peace, health, safety and welfare of the citizens of the Village of Strasburg, Ohio, for the reason that in order to regulate specialized motor vehicles as described herein as to operation on the streets and highways of the Village of Strasburg, Ohio, this legislation must be passed prior to December 31, 2016. Provided this Ordinance receives the affirmative vote of two-thirds of the members elected to or appointed to Council, it shall take effect and be in force immediately upon its passage and approval, with an effective date of not later than December 31, 2016.







ORDINANCE O-16-2017

AN ORDINANCE AUTHORIZING THE INSPECTION OF LOW-SPEED SPECIALIZED MOTOR VEHICLES (MODIFIED GOLF CARTS) BY THE VILLAGE OF STRASBURG; ESTABLISHING A FEE AND PROCEDURE THEREFORE; AND DECLARING AN EMERGENCY.

WHEREAS, by Ordinance O-32-2016, the Village of Strasburg authorized limited operation of low-speed specialized motor vehicles (modified golf carts), to be operated in the Village of Strasburg; and

WHEREAS, by Ordinance O-32-2016, "street legal" requirements for the operation of said low-speed specialized motor vehicles (modified golf cars) were established; and

WHEREAS, it has now been determined by the Village of Strasburg that authorization for the Strasburg Village Police to conduct the investigation contemplated by Ordinance O-32-2016 is appropriate and should be established, and a fee set therefore.

NOW, THEREFORE, BE IT ORDAINED by the Village Council of the Village of Strasburg, Ohio, as follows:

SECTION 1: That the Strasburg Police Department is hereby authorized to conduct the inspection of low-speed specialized motor vehicles (modified golf carts) which are permitted to be operated on streets, highways and alleys within the Village of Strasburg, Ohio, provided they meet the requirements and exceptions set forth at Ordinance O-32-2016, and established therein. The inspections shall be conducted in accordance with the inspection sheet attached hereto.

SECTION 2: All inspections shall be conducted by the Strasburg Police Department at the Strasburg Police Station, and individuals wishing to have a low-speed specialized motor vehicle (modified golf carts) inspected for the purposes of being designated

“street legal” and meeting the requirements of Ohio law and Strasburg ordinances, shall do so by contacting the Strasburg Police Department to establish a date and time for said inspection, which shall be conducted in accordance with the attached inspection sheet.

SECTION 3: Upon the inspection taking place a fee of \$25.00, payable to the Village of Strasburg, shall be paid to cover the additional cost connected with the inspections set forth herein.

SECTION 4. All Ordinances or Resolutions or parts thereof inconsistent with the terms of this Ordinance are hereby repealed.

SECTION 5. This Ordinance is hereby declared to be an emergency measure, and its immediate passage necessary for the preservation of the public peace, health, safety and welfare of the citizens of the Village of Strasburg, Ohio, for the reason that in order to allow for the inspection of low-speed specialized motor vehicles (modified golf carts) in the Village of Strasburg in accordance with Ordinance O-32-2016, it is necessary to have a procedure in place, together with a fee therefore, for inspections to be done by the Strasburg Police Department so that the operation of low-speed specialized motor vehicles (modified golf carts) in the Village of Strasburg is done in accordance with all applicable provisions of the Ohio Revised Code, and appropriate Strasburg Village Ordinances, which inspections shall be conducted in accordance with the inspection sheet attached hereto. Provided this Ordinance receives the affirmative vote of two-thirds of the members elected to or appointed to council, it shall take effect and be in force immediately upon its passage and approval.




