Any other proxy heretofore given by the undersigned for said meeting is hereby revoked. This proxy shall be governed by and voted in accordance with the provisions of sections 607.0721, and 607.0722, Florida Statutes.

The landowner shall not be entitled to cast any vote based upon a parcel owned by that landowner for which any assessment imposed by the district is delinquent at the time of the vote.

This proxy is to continue in force from the date hereof until the conclusion of the Annual Landowner's Meeting and any adjournment or adjournments thereof, but may be revoked at any time by notice thereof, in writing, filed with the board Secretary of the Sun 'n Lake of Sebring Improvement District.
