# REPORT FROM THE SUB-COMMITTEE ON FORMER TOWN HALL

Tom Boyd- Gave a photo presentation documenting the degradation of the Old Town Hall Building.

Mayor Hartman- Read aloud the four building options and alternatives, including costs, recommended by Pennoni for the Old Town Hall.

# **PUBLIC COMMENT (For comments including consent agenda items)**

- Rae Voss, 201 Skylar Court
  - O Discussed the roads in her development of Seneca Reserve and asked if there has been any consideration from the Committee to adopt the roads. Residents of the neighborhood are paying out of pocket for services to plow but are tax paying residents. Questioned the possibility of roads being damaged while they are paved, how often this has happened historically, cost to repair... as this was the reason presented at last meeting for the reluctance of the township to plow before the roads were turned over.
- Raymond Ward, Old Indian Mills Road
  - Feels Town Hall has fallen into bad shape, wants to know why it has become so neglected. Stated his opposition to shared services, claims they are unconstitutional, and a form of maladministration.

#### • Rick Franzen, Tabernacle Historical Society

 Spoke on behalf of the Historical Society in opposition to the Old Town Hall building being demolished. The building has a rich history and is a keystone to the town's social and political events.

# John Druding

Is against the changes imposed by the DEP for Wharton State Forest, has started a
petition against proposed road closures.

# • Gary Cohen, Carranza Road

 Opposed to the proposed DEP shutdown of Wharton State Forest Roads. Has had family here for generations and has enjoyed the forest, agrees with protecting the forest by enforcing current laws, not implementing new ones.

# • Tim McGarvey, Shamong

 Urging the committee to put together a resolution against the overreach of the DEP. Also does a radio show spreading awareness on the issue for anyone interested.

# • Joe McNally, Flagstone Drive

 Asking again if there has been any discussion on an economic development committee. Feels that bringing cannabis cultivation to Tabernacle would be beneficial in helping to generate revenue to offset costs of new township projects.

#### • Mike Broadbent, Skylar Court

o From Seneca Reserve urging the Committee to take over the roads in the development. Urges the town to evaluate all of Rockwell's work before releasing the bond. -Maryalice Brown, Township Administrator, addressed Seneca Reserve neighbors to let them know that the reports and studies have been received from Rockwell, and the basins have been approved. Mr. Gray from CME will be invited to the next meeting regarding any questions and anticipates the township taking over the roads at that time.

#### • Dr. Maria Schultheis, Schultheis Farm

Following up from her presentation at the October 2023 Committee meeting. Has
only received the ordinance currently in place regarding cannabis. Feels that
allowing cannabis cultivation would be good tax revenue for the town.

#### • Lance Saunder, Valerie Way

O Appreciates the update on Seneca Reserve. Wanted clarification on whether the town outsourced snow removal or if it was all done in house. -Maryalice Brown, Township Administrator, clarified that the township does snow removal through Public Works, but in the event of a large storm, there is a local landscaper contracted to help.

# • Jason Howell, Pinelands Preservation

Spoke about the Wharton State Forest map, the original map was from 1966 and the parks service is trying to produce an accurate map to better accommodate anyone who visits. There is a public process under way now and urges people to please share your comments on the places in the forest they use.

# • Stuart Brooks, Moores Meadow Road

- Commented on the state of the old Town Hall building, wants to know what work has been done to stabilize it during the last 3 years. Urges the Committee not to rush into making a decision.
- Had questions regarding the bridge near Moores Meadow road that remains damaged, and when repairs are to be made.

# • Ron Wiggins, Powell Place Road

 Hunts in Wharton State Forest and is urging the committee to reconsider road closures inside the forest. Asks that the Committee please listen to what the townspeople want.

#### • Fran Brooks, Moores Mead Road

- Took issue with an agenda item regarding Tabernacle Athletic Association, wants to know who will be paying these fees? The Township built the snack stand but does not receive any revenue for it.
- Feels that any employee who takes courses paid for by the Township should be made to compensate the Township for those fees.
- o Had questions regarding the GIS meeting on the agenda.

# • William Redman, 23 Hawkins Road

 Would like the Committee to create a resolution against DEP road closures in Wharton State Forest.

#### • Dave Benson

O Stated that if the DEP does pass the road closures, he would like to thank all who stood up against it. Would like to see the roads remain open.

#### • Lynn Hedden, Tabernacle Athletics Association

Spoke in regard to the snack stand that is used by the TAA, the stand was primarily built by grants and community partners that donated time and resources. The TAA pays for usage of lights and gas from money it generates through snack sales. Volunteers 20 hours a week to help maintain and run the association and the stand. The only thing the Township pays for is liability and insurance for the fields. Also announced that a scoreboard is being donated by TAA to the fields in memory of Rick Sozio who was also a volunteer to the TAA.

#### • Donald Gerber, Zimmerman Road

Spoke about Old Town Hall, his family has lived here for generations and were members of the United American Mechanics who helped build Town Hall. Stated that the Town Hall was meant to serve the community and the building is part of Tabernacle History and is opposed to its demolition.

#### • Ryan Jeffery, Hill Road

O Demands that the Committee acts on behalf of the public, they have sworn an oath of office and should be held to it.

- Jaimie Wood
  - Supports everything Lynn Hedden stated. Also added that she supports a new map for Wharton State Forest, as an EMS responder it would be very helpful.
- Bruce Pittman, 27 Lakeview Drive
  - Opposed to road closures in Wharton State Forest, it would be a shame for future generations to not enjoy the forest.
- Heather McGarvey, Shamong
  - Supports open trails in Wharton State Forest, feels that New Jersey is overtaxed, and political overreach has got to stop.

#### **Discussion on Former Town Hall**

- Committeeman Sprague
  - Disappointed to learn of another study done on town hall, the money spent is a
    waste in his opinion. Misunderstood the subcommittees creation, was under the
    impression it was only for the new building. Wants civic groups and residents to
    be involved in the subcommittee.
- Bill Burns, Solicitor
  - O Pointed out that the minutes that were voted on earlier reflect the subcommittee was formed by Committeeman Sprague to include the old and new building and approved spending of up to \$5,000 for a study. Asked if any changes needed to be made to the approval of the minutes.
- Committeeman Sprague
  - States that he misspoke.

#### • Committeeman Moore

• Asked if Tom Boyd could explain what the timeline for building degradation looks like, and if the building has been deemed an unsafe structure.

# Tom Boyd, Construction Official

 Read the uniform construction code regarding unsafe structures. Let the Committee know that the choice was up to them, but this issue has been known for at least 2 years now and without any action the building will continue to deteriorate.

# Deputy Mayor Stone

• Feels that the money issued for the study was well spent, and that putting off any action previously has resulted in the building degradation seen now. Made motion to demolish town hall, immediately put up safety fencing around the premise and authorize administration to move forward with what needs to be done.

# • Bill Burns, Solicitor

 Motion for Resolution 2024-46 to demolish 163 Carranza Road, immediately install safety fencing on the perimeter of the building and authorize the administration to move forward on bids has been made.

#### • Committeeman Moore

o 2<sup>nd</sup> the motion to demolish, it is a very difficult decision but seeing the state of the building it is what needs to be done.

# • Committeeman Sprague

Stated that this has been kicked around a long time and feels that this topic needs more discussion, suggested waiting until the upcoming workshop meeting to explore this more.

# A RESOLUTION TO DEMOLISH THE CURRENT STRUCTURE LOCATED AT 171 CARRANZA ROAD, TO AUTHORIZE THE TOWNSHIP PROFESSIONALS AND TOWNSHIP CLERK TO DO ALL THINGS LEGALLY NECESSARY AS WELL AS TO INSTALL A SAFETY FENCE AROUND THE STRUCTURE

WHEREAS, as per the Township Committee's request, RYEBREAD Architects provided a report, dated October 1, 2021, which identified structural concerns of the former Tabernacle Township Town Hall located at 171 Carranza Rd, Tabernacle; and

WHEREAS, on May 18, 2022, the Construction Official issued an unsafe structure notice deeming the property unfit for occupancy; and

**WHEREAS**, in June 2022 Township staff were moved out of the former Town Hall into temporary facilities due to the unsafe structure status; and

WHEREAS, during the Township Committee meeting on February 26, 2024, the Construction Official presented evidence of additional structural concerns and further degradation of the former Town Hall, the Construction Officials presentation included a photos that detailed the current condition of the former Town Hall;

WHEREAS, the Construction Official stated that the former Town Hall was a public safety concern and recommended that immediate action be taken.

**NOW, THERFORE, BE IT RESOLVED**, by the Township Committee of the Township of Tabernacle, County of Burlington, State of NJ, in an effort to protect public health and safety, that the current structure located at 171 Carranza Rd be demolished, BE IT FURTHER RESOLVED that the Township Professionals as well as the Township Clerk are authorized to do all things legally necessary to move forward with the demolition and to protect the public health and safety; and

**BE IT FURTHER RESOLVED** that the Township Clerk be authorized to have temporary, safety fencing installed around the structure.
