Uniform Municipal Excess Weight Permit

Permits are *not* required to travel Quarry Hill Road, Graniteville Road to #773, (former Rock of Ages Tourist Center), Websterville Road, Pitman Road, Parker Road and Sterling Hill Road from Quarry Hill Road to #169, (MacAuley Meats building) *as long as they are not exceeding State weight limits.*

This permit gives approval to travel the following roads with loads not to exceed the state highway weight limits:

Farwell Street, Pine Hill Road, Plainfield Brook Road, Windywood Road, Cummings Road, Hill Street (city line to West Cobble Hill Road), East and West Cobble Hill Road, Airport Road, Upper Prospect Street (from Airport Rd. to Morrison Road), Morrison Road (from Allen Street to Airport Road), Bridge Street (from #47 Reynolds & Son to Allen Street), Allen Street (from Morrison to #219 Booth Bros./Hood Dairy) Church Hill Road, Graniteville Road (from #773 former Tourist Center to Cogswell St.), Cogswell Street..

If it becomes necessary to travel other than the above-mentioned roads in the Town of Barre, you are required to have this permit amended (in writing) to include those roads.

This permit does not allow trucks on Gregoire Street, Middle Road, Holden Road, or on the Bridge Street bridge. Do not attempt to drive up Sterling Hill Road off of Route 14. Use Quarry Hill Road to reach Rock of Ages and Wilson Industrial Park.

List primary destination points within Town of Barre: _____

Truckers must use the shortest route off of permitted roads to reach destination points on unpermitted streets.

This approval shall be effective until March 31, 2025. This approval shall cover only this vehicle bearing the company name

The holder of a permit shall be liable for any damage to highways or bridges and **is required to furnish the Town of Barre a valid Certificate of Insurance** in the following amounts: a minimum of \$100/\$300,000 Personal Injury Liability Coverage and \$100,000 Property Damage Coverage.

1. Permit is valid for up to one year expiring on March 31.
2. You must include a valid certificate of insurance in the amount of a minimum of \$100,000/\$300,000 Personal Injury Liability Coverage and \$100,000 Property Damage Coverage.
3. Please include \$5.00 for each single vehicle application, or \$10.00 for a fleet permit.
4. Permits must be carried in the permitted truck.

Special weight limits which are higher or lower than legal limits for highways or bridges within your jurisdiction must be on file with the Vermont Department of Motor Vehicles.
