# Town Forest Logging



Last fall the Town and its professional consulting forester, Jeff Smith of Butternut Hollow Forestry, advertised for logging bids. Five loggers answered the call. In November the Selectboard awarded the first town forest logging contract to George deNagy. Mr. deNagy offered the highest return (payment) to the Town. The \$11,110 return is based on Mr. Smith's estimated quantity for ten categories of forest products ranging from hardwood sawlogs to firewood. The actual payment to the Town will depend on the quantity of product in each category.

Logging work started in early January and is limited to two areas near Littlejohn Road. One area is between Littlejohn Road and East Barre. The other area is across Littlejohn Road in the Donahue Road/Littlejohn Road corner of the town forest. Logging is to be completed by the first of April.

It is advisable to stay off the trails in these areas this winter. The VAST snowmobile trail will remain open, however. The logger must (by contract) cut felled tree tops so no part is more than 3 feet off the ground and must minimize brush across recreation trails. The snowmobile trail is to be left in as good or better condition than before the harvest. Millstone Trails Association (MTA) volunteers will clear remaining brush from trails.

The cutting impacts about 1/7<sup>th</sup> of the town forest. There are many miles of trails in the town forest that can be used this winter. (See related article on this page.)

Mr. Smith has offered to conduct a logging education tour on Saturday, February 27. The public is invited to tour some of the logging area with Smith and learn about the how, why and whats of logging. Any town residents interested in the town forest or in logging (owners of wood lots) are welcome. Meet at the Waterman Street water storage tank at 10:00 a.m. Dress warm and ready to walk in the woods (on trails). The tour should end 12:00 - 12:30 p.m.

# **Open Appointments**

Deputy Health Officer: Letters of interest are being accepted for the deputy health officer (DHO) position. The DHO handles cases when the health officer (HO) is not available. Health officer and DHO work is on a call-by-call basis. Typically the HO and DHO receive fewer than 10 calls per year, of which about half require follow up and written reports. Training is available and the VT Department of Health provides a very useful handbook. Health officers and DHO's enforce VT's rental housing code, respond to dog bite cases and enforce state law about improper disposal or storage of trash. A \$400 per year stipend is paid. Town residents interested in this important position should submit a letter of interest addressed to: Selectboard, P.O. Box 116, Websterville, VT 05678. A short resume would be helpful. The appointment officially is made by the VT Department of Health. For more information visit the Department of Health website at www. healthvermont.gov/local/tho/tho.aspx.

**Phoenix House**: The memorandum of understanding (MOU) about the Phoenix House in South Barre created a Community Relations Working Group. The Group includes one position

Meetings normally last less than 1 2 hours. The Selectboard will appoint the South Barre resident member. # ANNUAL DOG LICENSE(S) ARE DUE



Do you own a dog? Does the dog live in Barre Town? If you answered yes to both questions then by Vermont law (20 VSA Sections 3541-3591, 3801-3813) you are required to license your dog/wolf-hybrid annually in the Town of Barre.

#### What do I need to license my pet?

- Have a current rabies certificate on file with the Town Clerk's Office or provide the office with a copy of the certificate at the time you license.
- 2. Pay the license fee (\$10.00 for a spayed or neutered animal and \$14.00 for an animal that is not fixed).
- 3. Remember the deadline to license your dog(s) is April 1, 2016. If your pet is found to be unlicensed after April 1, 2016 you can be fined (\$35.00).

The Town Clerk's Office has mailed a postcard reminder to the pet owners who have a rabies certificate on file but will expire before April 1, 2016.

Dog license renewal forms will be in the mail by the end of January for the calendar year 2016. Be sure to check the license information carefully (make corrections if necessary), sign, enclose your payment, and return to the Town Clerk's Office in the envelope which is provided.

# ELECTION DAY ANNUAL SCHOOL AND PRESIDENTIAL PRIMARIES

This year on March 1st the polling place should be busy. In addition to the normal school issues (budget items and electing school directors for Barre Town Elementary & Middle School plus Spaulding Union High School) there will be a Democratic and Republican Presidential Primary elections.

Since Presidential Primaries only occur every 4 years, residents tend to forget that in order to vote in a Presidential Primary election you must declare a party – by Vermont law.

In the 1979 Adjourned Session of the Vermont General Assembly, Act No. 199 (which became effective on May 6, 1980) was passed setting out the procedures and requirements for the Presidential Primary in Vermont to be held on the first Tuesday in March in all Presidential election years.

Furthermore Chapter 57 of VSA Title 17, section 2704 provides: A person voting at the Presidential Primary shall be required to ask for the ballot of the party in which the voter wishes to vote and an election official shall record the voter's choice of ballot.

So why was the law passed? The Secretary of State's Office was not real active in elections at the time of passage. However, their research led to the understanding that declaring a party was a compromise reached after the National Republican and/or Democratic parties threatened to not "count" the Vermont Presidential Primary unless there was some form of party identification recorded for the election.

Campaign Finance Requirements for Local Officials

With local elections in March and May, a reminder of the recent changes to the campaign finance law. Candidates must register and submit reports via the Secretary of State's Campaign Finance website (http://campaignfiance.sec.state.vt.us). All reporting for campaign finance can be found on this website.

Local candidates for office who spend or raise over \$500 are required to register with the Secretary of State. Candidates who reach this threshold must submit reports of expenditures and contributions 30 days prior, 10 days prior and two weeks after the local election. A final report must be filed within 40 days of the election, but can be filed at any time. The report due 10 days after the election can be a candidate's final report. Candidates who do not spend or raise over \$500 are not required to report. Local candidates may only accept \$1,000 from a single source (individual or PAC). Political parties are allowed to donate unlimited amounts to candidates.

A person or group that spends over \$1,000 to influence the outcome of a public question are also required to register and report expenditures to the Secretary of State. These reports are due 30 days prior, 10 days prior and two weeks after the local election.

In addition to campaign finance reports, anyone that spends over \$500 on a "mass media activity" (newspaper ad, radio or TV ad, or electronic communication or mailing) must file a Mass Media report. These reports can always be filed on the Secretary of State's Campaign Finance website.

# Trow Hill Playground Redevelopment

Barre Town, the Recreation Commission, and several residents have been working to revitalize the Trow Hill Playground since August, 2015. Boy Scout Zach Bullock earned his Eagle Scout rank by leading a number of improvements, including upgrading the picnic shelter, making benches, and removing 11 truckloads of brush along the fence. The basketball court was resealed, a basketball net replaced, and the fence repaired.

The Imagine Dragon play structure, \$22,895 (sale price, including shipping), has already been delivered and will be installed in early summer.

The next step is to purchase and install more play equipment. Over 125 schoolchildren, teenagers, and adults from Trow Hill and beyond have provided input on what playground equipment to purchase, mostly as part of a survey conducted at Trow Hill Grocery last Halloween. Based on the



survey results, the Recreation Commission shortlisted equipment to purchase and install in 2016, including a large structure for 5-12 year olds, a zipline-style ride which was the overwhelming favorite of the survey, new swings, a spring rider, a tunnel for toddlers, and more benches. Much of the equipment will be accessible.

In December Barre Town requested bids for this equipment, plus shipping, and installation. Two bids were received. UltiPlay of Massachusetts was selected as the lowest cost vendor with strong references and environmental record. The vendor, Town staff, and volunteers working on this playground will be finalizing the phase 1 and fundraising plan in February.


Cash and in-kind donations are sought for concrete, asphalt, use of small machinery, and more play equipment for phases 1 and 2, and volunteers are needed to staff fundraising events and participate in the supervised community-build of the equipment.

If past practice is followed the 2016 Citizen Budget Tour will be on Saturday, February 20. Participants are asked to gather in the Municipal Building (149 Websterville Road) between 7:30 a.m. and 8:00 a.m. Hot and cold morning beverages along with muffins and doughnuts are provided. The tour begins at 8:00 a.m. with visits to departments located in the Municipal Building. A handy dandy Budget Tour booklet is provided to describe facilities and departments, and highlight recent acquisitions, projects and changes. Key budget facts are listed.

On the ride between facilities citizens can discuss with Budget Committee members or Town Manager whatever interests them.

#### **Budget Committee**

The 2016 Budget Committee started meeting on January 26 and probably will meet until March 29. Per the Town Charter, the Committee has ten members, the five selectmen and five appointed citizens. This year the selectboard appointed Bob Nelson and Paul White. The Town Clerk-Treasurer appointed Bill Wolfe. Those three citizens selected Joanne Cyr and Val Vallerand to round out the committee.

Committee meetings are held from 6:30 p.m. to 8:00 p.m. on Tuesday nights in the Municipal Building. The public is welcome to attend. Topics to be discussed are listed on the Selectboard meeting agenda. (The board meets at 8:00 p.m. when the Budget Committee finishes its meeting.) Selectboard meeting agendas are posted at Hannafords, Graniteville General Store and Trow Hill Grocery. The agendas also are posted on the town website (click on Boards and Commissions and then Selectboard). When the town manager completes a proposed fund budget it is posted on the town website. See www.barretown.org/Pages/gen/budgetin.

The Budget Committee has a critical role in town budgeting. According to the Town Charter the Committee makes the final decision about seven of the nine fund budgets. The Committee sets the amount of the proposed General Fund and Highway Fund budgets which are placed before the voters for approval in May.

# Barre Town Middle and Elementary School



The Barre Town community, many years ago, educated its children in small school buildings. These school houses were located in Lower Graniteville, Trow Hill, Upper Websterville, Upper Graniteville, South

Barre, Lower Websterville, and East Barre. At the current EMS station on Rt. 302 there was a building called the Spring House School. What used to be the Brookside School is now Bates & Murray on Rt. 14, the East Montpelier Road. In 1964 a committee was appointed to consolidate the schools and town residents then voted and decided to merge all of these neighborhood schools into one location. The doors to Barre Town Elementary School opened for the very first time in late summer of 1966.

We are excited to announce that the fall of 2016 is Barre Town School's 50<sup>th</sup> Anniversary! Barre Town School takes great pride in the community support we have received over the

# Filing Your Homestead Declaration

Every Vermont homeowner must file the Homestead Declaration HS-122 every year, regardless of whether they file a state income tax return. The deadline to file HS-122 with the Vermont Department of Taxes is April 15. If you or a family member own and occupy a home as of April 1, 2016 file the HS-122 to avoid a penalty. The elderly might still be living in their home but not need to file a state income tax return. Check to see if they are submitting the HS-122 form.

The form is available from the state's website www.tax.vermont.gov to print or file online. If you miss the April 15 deadline file anyway. If you do not file the form at all you will be charged the higher non-residential tax rate for the education part of the tax bill. Barre Town's non-residential tax rate this year is 1.7341, while the residential or homestead tax rate is 1.4056.

# Low Interest Home Improvement Loans



Barre Town homeowners, there is a great opportunity to get some of those expensive, nagging, and necessary home improvements done! Downstreet Housing and Community Development (formerly Central Vermont Community Land Trust) offers special low-interest loans for quali-

fied homeowners. Downstreet Housing administers these loans for Barre Town providing all the necessary review and oversight. Downstreet Housing can be a little more lenient than commercial banks. Downstreet Housing has a very low denial rate. If homeowners fall just outside of the usual parameters to qualify they may be eligible for a loan from this program.

Loans may be used for housing improvements such as weatherization projects, roof repair, heating system upgrades, and access modification for the elderly or disabled just to name a few. To be eligible a Barre Town resident must have a household income that is 80 percent or less of the Washington County median income. That means that somebody with a household income of around \$59,000 or less and a family of four may be eligible, or a single individual who has an income of \$41,000 or less.

#### **Project Updates**

Route 110 and Mill Street Intersection in East Barre: The intersection of Route 110, Mill Street, Old Route 302, and Bianchi Street in East Barre has been a challenge for many years, largely because the sharp angle between Mill Street and Route 110 makes northbound traffic on Route 110 hard to see. Also, too many roads converge at that one intersection. The State of Vermont seeks to improve it and has contracted with engineering firm VHB to redesign the intersection. VHB has developed a conceptual plan and is seeking public input on it. The firm made a presentation during the January 5th Selectboard meeting and a large color printout of the design can be viewed at the Barre Town offices. Key features of the draft redesign are:

- a) Shifting the Mill Street approach so that it is perpendicular to Route 110, improving sight lines for Mill Street traffic entering Route 110;
- b) Changing Bianchi Street to one way, eastbound only, to reduce the amount of traffic at the intersection;
- c) Narrowing the Old Route 302 approach to provide better definition for traffic leaving and entering Old Route 302;
- d) Adding a new sidewalk on the north side of Mill Street between Summer Street and Route 110, and a pedestrian crossing to connect the new sidewalk to the existing sidewalk on the Rt. 110 bridge.

The next steps are to develop preliminary plans based on public input received this winter and spring; acquire rights-of-way in 2017, finalize plans in the summer of 2018, and contract for project work in fall of 2018, with construction planned in 2019. The project is currently estimated to cost \$300,000 and will be paid for by federal and state dollars, with no costs to Barre Town. #### (Cont'd - Project Updates)

East Barre (Cobble Hill) Water line: The plans for this project are nearly complete. There will be three construction phases. This spring, the section from the north side of the roundabout to Hillside Avenue will be constructed by the Town's DPW crew at an estimated cost of \$25,000. In 2017 the next phase will extend 8" pipe from the end of Mill Street at Rt. 110 across Old 302, to the Jail Branch. Estimated cost is \$20,000. The stream crossing will not be constructed until 2018 or later, and may include a pedestrian bridge as part of the project. This is estimated to cost \$90,000 to \$100,000. Mill Street Sidewalk in East Barre: The Town continually seeks to improve pedestrian mobility in Barre Town. Accordingly, it began a project in 2006 to construct a sidewalk on the east side of Mill Street, from the Town of Barre Fire Department building to Websterville Road and around the corner up to the post office. The project is estimated to cost \$197,500 and is funded with federal (80%) and Town of Barre (20%) dollars. Once the Route 110 project, above, is complete, Mill Street will have a continuous pedestrian facility between Websterville Road and the Route 302 roundabout. Also, a small section of sidewalk will be constructed in front of the East Barre Library, a crosswalk will connect that short section with the main sidewalk on the eastern side of Mill Street, and a crosswalk will connect the northeastern end of the new sidewalk to the existing sidewalk on the western side of Mill Street north of Summer Street. The project will improve drainage on some properties and reduce the likelihood of vehicles driving over another property. The Town must now obtain permanent easements from affected property owners before the construction process can begin. For more information, contact Elaine Wang, at ewang@barretown.org or 479-9331.

South Barre – Bridge Street Water Line: Barre City anticipates upgrading the 2 inch water line on Bridge Street with an 8 inch line as far as the access to the mobile home park. This upgrade in capacity will allow Barre Town to install a fire hydrant at the entrance to the mobile home park. The Town would pick up the cost of the hydrant with the rest of the expense being paid for by the City.

Bridge Street Sidewalk in South Barre: Another Barre Town road that needs a sidewalk is Bridge Street between Route 14 and the bike path. The bridge already has a sidewalk on the north side. Barre Town began this project in 2011. The project is estimated to cost \$164,400, is funded with federal (80%) and Town of Barre (20%) dollars, and is overseen by the Vermont Agency of Transportation. Project alternatives were presented to the Selectboard on August 25, 2015, which decided that the sidewalk should be constructed on the north side of Bridge St. The conceptual plans were submitted to VTrans on December 11, 2015 and include a 3 foot bike lane on the north side of Bridge Street. The Town also plans to add pavement and stripe a 3 foot bike lane on the south side of Bridge Street. Thus the Bridge Street sidewalk project has also provided an opportunity to advance the Barre Connector (aka Semprebon) Bike Path. **Rt. 14/Bridge Street Intersection:** This project managed by VTRANS is still slated for construction in 2017 as described in the February 2015 newsletter. The news is that Barre City will replace 1500' feet of water line from Jockey Hollow to just south of the intersection prior to the state's project for the Bridge Street - Route 14 intersection. This work was made necessary by the amount of road cut required by the Route 14 project. These costs will not be borne by the Town of Barre.

Solar Farms: Malone Properties' 500 kw solar farm, at Wilson

Industrial Park is complete but not yet online. Five more projects are undergoing the Vermont Department of Public Service review process. The locations and developers are Beckley Hill Road (Novus Energy), Pine Hill Road (Novus Energy), Morrison Road (Novus Energy), Osborne Road (Aegies Re-



newable Energy), and Cummings Road (Sun Common). The first four are proposed 500 kW arrays; Cummings Road is a proposed 150 kW. For more information, call the Barre Town Planning and Zoning Office at 479-2595.

Stormwater Grants: Two grants from the State of Vermont Ecosystem Restoration Program have been awarded to study stormwater in Barre Town. The Central Vermont Regional Planning Commission (CVRPC) will study all major sources of stormwater and their impacts on water quality in Barre Town, Barre City, and Plainfield. The Friends of the Winooski River (FWR) will study the Quarry Hill and Sterling Hill watersheds to identify and prioritize stormwater management practices that would reduce localized flooding and infrastructure damage, and protect water quality.
