TOWN BUDGET

On May 13 Barre Town voters will go to the town



school gym to elect town officials and to vote on 20 financial articles. Headlining the list of financial articles are the General Fund (GF) and Highway Fund (HF) budget proposals.

For more information about registering to vote, early voting ballots, sample ballots and to

learn about the election of town officials, see the articles on page 3.

The budget committee (5 selectmen and 5 citizens) met every Tuesday night from January 28 to March 25. During this 9 week span the committee reviewed the town manager's proposed budgets for the GF, HF, Sewer, Water, Equipment, Ambulance, Cemetery and Building Funds. In the course of studying these budgets the committee heard from department heads, Barre Area Development and Aldrich Library.

The GF(83%) and HF (92.1%) are supported mostly by property taxes, thus these budgets are presented to voters for approval. The 6 other budgets are supported by utility customers (S,W), are internal service funds (E, B), or are

special revenue funds (A, C).

Together the proposed GF and HF budgets equal \$5,925,716, which is \$165,335 or 2.87% more than the current budgets. Both proposed budgets are balanced - new revenues equal proposed spending. The Grand List (source of property tax revenue) is expected to grow .66%. With this scant growth in tax base the tax rate will increase 3.88¢.

The current year budgets are not balanced. The Selectboard applied \$72,120 cash balance to the GF and used a \$72,000 grant award for the HF. Offsetting these non-tax revenues is equivalent to a 2.4¢ tax rate. Comparing current budgets to proposed budgets, a 1.48¢ tax increase would be needed.

The proposed fiscal year '14-'15 GF is \$3,316,816, a figure \$91,965 or 2.85% greater than the current year. The GF tax rate would increase 2.35¢. No major changes in town operations or services are planned. Staffing would stay the same (total of 48 full-time town employees). Spending changes in the 3 major divisions of the GF are similar: Administration and Finance (+ 2.29%), Public Safety (+ 3.46%), and All Other Departments (+ 2.36%).

Biggest changes in the proposed GF budget are: 1) + \$51,160 in he per capita fee paid to the Ambulance Fund; 2) - \$30,486 in debt service due to payoff of the library bond; 3) - \$25,000 in fire department capital improvements; 4) + \$24,340 for health insurance premiums; and 5) - \$14,270 for Cemetery Fund transfer (tax subsidy). Not surprisingly, the department totals with the largest changes are: Ambulance (+\$51,160, +14.5%); 2) Employee Benefits (+\$36,460, +8.5%); 3) Debt Service (-\$31,680, -43.6%); 4) Inter fund Transfers (-\$13,585, -2.6%); and 5) Fire (-\$14,385, -4.2%).

Notable items in the budget are \$15,000 to complete rebuilding the Upper Websterville Playground, \$4,700 to start improving the East Barre Bike Path from Millstone Boulevard toward the town office; and \$1,130 to offer payment by credit card, debit card or e-check.

The HF total is \$2,608,900 which is an increase of \$73,370 or 2.89%. The tax rate would increase 1.53¢ for this balanced budget. No staffing changes are planned. Special projects of note are: 1) Peloquin Road (and vicinity) drainage improvement, \$8,451; 2) local share of Quarry Street/Rt. 14 intersection project, \$8,000; and 3) guardrail installation along a section of Richardson Road and section

of Clark Road, \$5,000.

For a list of the paved road projects planned in this budget see the article on page 7.

Major changes in spending are: 1) paving program (+\$63,300, +10.2%); worker's comp insurance (+\$11,610, +4.3%); 3) salt purchase (-\$8,400, -5.39%); and streetlights (-\$6,835, -7.4%).

A budget booklet featuring more explanation, summaries of the GF and HF, Warnings for the Town Meeting and Annual Election of Officers, and the budget tour guide will be available soon. Look for it at the town offices, Hannaford's, Quarry Hill Quick Stop, Graniteville General Store, Lawson's Store, Trow Hill Grocery, Morgan's East Barre Market, and Brookside Country Store. It will be posted on the town website under Publications. Be on the lookout for the Selectboards budget presentation on CVTV the week of May 5.

Three new non-profits petitioned to be on the Annual Election ballot: Washington County Diversion Program (\$2,500); Prevent Child Abuse Vermont (\$1,200); and Vermont Center for Independent Living (\$2,000). Last, the Selectboard proposes to increase the elected auditors' wage rate from \$10 to \$13 per hour. This increase is projected to cost \$225 per year.

Green Up Day



A Vermont tradition, Green Up Day is May 3, the first Saturday of May. Individuals businesses, scout troops, clubs, church organizations, families and neighborhoods can participate when it is convenient for them.

Volunteer coordination is handled by the town manager's

office. Stop by, call (479-9331) or email (offices@barretown.org) the manager's office, which keeps a list of volunteers and a map showing areas where volunteers intend to clean up. The VT Green Up bags, latex gloves and tickets to the free BBQ are available in the office. The volunteer sign-in sheet is posted on the website (www.barretown.org/Pages/dept/waste.html).

Last year volunteers collected 3.4 tons of litter (that is a lot of lottery tickets, candy wrappers and water bottles!) and 119 tires. A small contribution from many people makes a difference.

Green Up work can be done to fit the volunteer's schedule. Some volunteers start before Green Up Day and might work on their selected area over several days. Some are busy on Saturday and prefer to work on Sunday.

Green Up Coordinator Brenda LaFirira and Girl Scout Troops 30568 and 3357 organize and offer the BBQ

Open House - Public Works Garage

Last fall the Selectboard appointed a committee of 6 town residents to research the feasibility of moving the entire public works operation (maintenance garage, truck garage, fuel tanks, salt and sand storage) plus the Wilson Recycling Depot and lawn waste site to the former Pike land across from the Wells-Lamson Quarry. The board also asked the committee to make a recommendation for using the current DPW yard at 129 Websterville Road, if the former Pike property isn't feasible.

The committee determined the former Pike property isn't feasible because of costs. Bringing utilities to the site would be expensive. Re-building assets (fuel pumps, salt building, sand storage, fencing) the town has at 129 Websterville would add on a large amount. Vehicle storage and vehicle maintenance buildings also would have to be built. The committee developed a plan for 129 Websterville Road such that a new maintenance garage could be built there and the recycling center could be moved to that lot. That plan would accomplish two of the board's objectives - sell the existing vehicle maintenance shop at 79 Pitman Road and sell the lot used for the recycling center. The plan also includes (possibly as the last step) replacement o the existing truck garage at 129 Websterville Road.

To acquaint residents with conditions in the truck garage the selectboard is holding two Open Houses coinciding with events at 129 Websterville Road. On April 26th from 9 am to 1 pm while the household hazardous waste collection is underway, residents may go in the garage to learn more about the building and the possible DPW facilities project. The same opportunity will be offered on Saturday, May 10th from 8 am to 2 pm during the bulk trash collection. You do not have to use either service to visit during the Open House.

The board plans to hold a public hearing about the possible project during its meeting on May 20, 2014.

Retiring & New Town Employees

Ed Lindgren retired on March 31st after 6 years as the bookkeeper for the Town of Barre. Ed was quickly able to learn the accounts payable, payroll and accounting systems. He devoted many hours to streamlining the procedures needed to make the system much more efficient. He also created several new data bases that allow for much easier and quicker access to financial information.

He will continue on in a part-time capacity to train the new bookkeeper. After that, his next goal is to log as many hours as possible touring on his motorcycle.

Annual Town Elections

As is customary in Barre Town our annual elections are held the first Wednesday in May (Open Town Meeting) and the second Tuesday in May for the Election of Officers and Voting by Australian ballot.



The Open Town Meeting (Wednesday, May 7th) is held at the Selectboard Meeting Room in the Municipal Building and begins at 7:30 pm. This year the items being voted on include: setting the property tax and sewer due dates; asking for approval to apply the State tax credits pro-rata (deduct the credit amount from the total amount and divide the remaining balance into 4 installments); to seek approval for the Selectboard to sell real estate; and present the Wendell F. Pelkey Citizenship & Service Award. Immediately following the Open Meeting there will be a presentation/overview of the proposed budget.

The Annual Election of Officers and Voting by Australian ballot will be held on *Tuesday*, *May 13th* at the Barre Town Middle & Elementary School Gymnasium. Polling hours are 7:00 am to 7:00 pm.

The items appearing on the ballot include the usual: Election of Selectboard members, Town Auditor, Moderator, and Town Constable; voting on budgets (General Fund/Highway Fund); a Cemetery appropriation; elected officer wages; and numerous not-for profit entities.

There was a last minute wrinkle this year when preparing the warning for ballot voting. Selectboard member Jeff Newton (term to expire May 2015) resigned. Our Town Charter has a law instructing how to fill a vacancy. The Town Attorney was consulted and I was advised to place this vacant seat on the ballot. Therefore, when you review the ballot please note there are 3 Selectboard seats available. However, only 2 seats will have a candidate name. The third, vacant, seat could be decided by write-in votes. I say could because the law is clear that in order to win the seat a person must receive at least 30 votes. So if no write-in candidate receives 30 votes then there will be no winner declared for that seat. If that should happen the Selectboard would appoint an individual to fill the vacant seat. Otherwise, the write-in candidate who receives the most votes, over 30, will win the race.

The deadline to register to vote is Wednesday, May 7, 2014 at 5:00 pm. Early ballots are available. To request an early ballot telephone the office at 479-9391 or email dkelty@barretown.org. Visit our website (www.barretown.org) to view the ballot.

House Number Signs Available

Barre Town emergency services are in the process of heightening the awareness about the importance of having easily



identifiable house numbers. A house number is often referred to as an E911 number. Having a house number that is 4" high and located where it can be seen day or night from the road can mean the difference between life and death. We ask that everybody consider the location of their house number and ask yourself, would I be able to see this number if I didn't know where it was located?

Too often critical time is lost due to numbers: not being there, hung too far from the road to read, being covered by something, or being on a mailbox either grouped with other mailboxes or the mailbox is not easily associated with a house. Shared driveways are another area of potential confusion. Please check your number and make sure it can be seen and that it is big enough. Properly displaying your house number not only makes sense, it is required by Town Ordinance.

4" x12" green reflective signs with your house number on it using white reflective numbers. Holes can be drilled if desired.

The cost of the sign is \$10.00 and can be ordered through the Town Manager's Office. You can call for a form (479-9331) or print one off from the Town website, www.barretown.org. All forms should be turned into the Town Manager's Office by mail at P.O. Box 116, Websterville, VT 05678, or dropped off. If you are not sure what your house number is you can contact the assessor's office at 479-2595.

Cycling on Vermont Roads

It may be annoying to share the road, but it's the law. Perhaps it is partially so because those of us who live and drive on Vermont roads are often challenged by limited space, potholes and unmarked or undesignated shoulders or bike and pedestrian lanes.

However, rules in our state, and therefore community, mandate that we learn to e good neighbors. Rights and responsibilities of both drivers and cyclists are clearly defined in enforceable laws. Courtesy may be the bottom line, but accepting and protecting each other transcends ethics.

Drivers have an obligation to use care and defer to vulnerable users. This is defined as pedestrain, wheelchair, bicycle or other non-motorized means of transportation, equestrian or those driving or herding animals. Drivers are to slow down until it is appropriate to pass the vulnerable user safely. Failure to do so results in a penalty of 4 points and \$156 fine. Furthermore, drivers are prohibited by law from any form of harassment, threat or intimidation. The penalty for following too closely is 4 points and \$271 fine; for throwing objects is 4 points and \$386 fine.

Cyclists, on the other hand, have equally designated rules of the road. While it is permissible for cyclists to travel in a traffic lane, they must do so with consideration of and for the traffic. Cyclists should ride to the right (but not squeezed onto the shoulder of the road unless there is a specific bike lane), should ride two-abreast only when traffic permits and never going up a hill with poor visibility for oncoming traffic cresting the hill, <u>use approved lights at night including a highly visible flashing red light from the rear</u>, employ hand signals and obey traffic laws. A cyclist failing to comply with Vermont Bicycling Laws is subject to fines from \$70 to \$214 depending on the infraction.

There is some misunderstanding about bicyclist and bike paths. Cyclists are NOT required to use bike paths and are, in many cases, prohibited from riding on sidewalks.

Cycling is increasing in popularity both as a sport and as a means of transportation. A bicycle friendly municipality invites visitors who in turn leave behind tourist dollars.

It is in the best interest of our community to share the road, and to do so safely. For more information go to www.vtbikeped.org.

Traffic Safety Advisory Committe - By Harry Hinrichsen

February 2014: Committee voted to recommend Selectboard consider installing advanced intersection advisory signs indicating a side road left or right for both the outbound and inbound traffic on Plainfield Brook Road. There should also be 18" x 24" distance advisory placard for 250' mounted below the intersection sign.

March 2014: Committee proposed revisions to the current Guardrail Policy. The policy would upgrade the language to include construction standards relating to State of Vermont (VTRANS) and ASSHTO standards. Additional review will follow at the April meeting.

SPRING BULK TRASH COLLECTION

Saturday, May 10 from 8 am to 2 pm at the DPW Yard, 129 Websterville Road the town is offering a bulk trash drop-off service. The service is for town residents serving their home. The kind of debris or junk accepted are: mattresses, plastic toys, porcelain fixtures, carpets, pool liners and covers, siding, windows and doors, wooden and plastic furniture, home remodeling demolition material, and shingles. Small pieces of sheetrock, plaster and roofing shingles must be in containers. Siding and lumber must be in easily handled lengths. Loads of loose (not in containers) roofing shingles will be parked at the side and unloaded when no one is in line to be off-loaded.

Fees are charged. The schedule is shown below. Residents are welcome to make multiple trips. Residents should have a tax or utility bill with them to verify residency.

Lawn Waste Site Leaf Disposal

The town lawn waste site is located near the top of Holden Road, which intersects with Graniteville Road in front of Rock of Ages. Residents may take organic waste from their trees, lawns, vegetable and flower gardens, shrubbery and hedges. Examples of lawn waste include grass clippings, leaves, hedge clippings, tree branches and garden plants. Brush is piled at one end of the site. Branches or logs larger than 5" in diameter should be separated and placed in the free firewood area.



The site is open $Wednesdays\ 3\ pm-6pm$; $Thursday\ 9am-noon\ and\ Saturdays\ 8\ am-noon$. Volunteers monitor the site on Wednesdays and Thursdays. More volunteers are welcome; contact the town manager's office about volunteering.

The brush is chipped into wood mulch and is free for residents to take. The grass, leaves and other vegetation is composted and is free for the taking.

Look for the site to open Wednesday, April 30. Usually it is open through the first week of November.

The monitors are there to prevent improper dumping and to answer questions, not necessarily to unload user's car or truck. Bring tools to load mulch or compost. Take bags, boxes and plastic home. Lumber and building demolition materials are not accepted.

CVSWMD Collection in Barre Town

The Central Vermont Solid Waste Management District is kicking off our 2014 special collection season in Barre Town again this year, with a household hazardous waste collection at the Barre Town Garage on Saturday, April 26, 9 am - 1 pm. A fee of \$15 per carload for district residents, or \$75/carload for out-of-district residents will be charged.

Things are a little different this year, thanks to a recently passed paint stewardship bill, which puts the job of collecting unused paint in the hands of its manufacturers. That means, paint is no longer collected as a household hazardous waste, so you can leave it at home during the April 26 collection, and bring it to the ARCC (Additional Recyclables Collections Center, 540 North Main Street, Barre). See our website for details, www.cvswmd.org/arcc-additional-recyclables-collection-center.

What is hazardous waste? Examples include: Bleach products (including tub, tile & toilet cleaners and laundry soaps), drain openers, oven cleaners, floor wax, solvents, tar, adhesives, pesticides, aerosols, moth balls, spray paints, gasoline, kerosene, used or contaminated oil, degreasers, polishes, transmission fluid, and brake fluid.

Some notes on what to expect at the hazardous waste collection: Please remember that the items in your car may seem like normal household items to you, but they are indeed hazardous wastes, and are treated as such. That means, for everyone's safety, please remain in your car, and let our specially trained contracted crew handle all materials.

Why is there a fee? Our fee represents a small fraction of what it costs CVSWMD to collect hazardous material. We offer the reduced fee as a service to our residents. Out of district residents must pay a much higher fee because they do not contribute to the cost through their tax dollars. Any resident of any district town may attend our special collections.

District towns include: Barre City, Barre Town, Berlin, Bradford, Calais, Chelsea, East Montpelier, Fairlee, Hardwick, Middlesex, Montpelier, Orange, Plainfield, Tunbridge, Walden, Washington, Williamstown, and Wood bury.

As always CVSWMD encourages people to get together with friends and family to share carloads in order to save on the fee, gas and mileage.

5 Kilometer Races

Two Central Vermont Runners 5K (3.1 miles) races will be offered again this year. On *Saturday, May 17* the Barre Town Spring Run will be held in the town recreation area. Registration is at the picnic shelter. The course covers the entire length of the bike path and finishes on the track. Registration begins at 8:30; race time is 9:00. The registration fee is \$5.00.

On Sunday, July 27 the Barre Heritage Festival 5K Trail Run will be held. Registration is held on the field across from the Millstone Lodge on Littlejohn Road. The course uses town forest trails. Registration starts at 10:00; race time is 10:30.

Millstone Trails RockFire Festival

The Millstone Trails Association will be sponsoring the third annual RockFire festival on the Millstone Hill Trail network the weekend of $June\ 27^{th} - 29^{th}$. Part of the Festival will be held on the Town of Barre Forest. Throughout the weekend the trail network will be featuring 8 to 12 art installations. Several new granite sculptures adding to those produced as part of the last two Festivals, will be unveiled up at The Grand Lookout. On both Saturday and Sunday there will be guided nature walks and historic walking and tractor/wagon tours as well as free admission to the Vermont Granite Museum at Millstone Hill.

The highlight of the festival will once again be the 2 mile FireWalk, with the designated trail being lit by over 1000 luminaries and over 40 bonfires as well as over a dozen live performances. The FireWalk will be held from 9:30 to midnight on Saturday the 28th and will be preceded by a concert held on the grounds of the Lodge at Millstone Hill starting at 7 pm.


The admission to the concert is \$10 and to the FireWalk \$20 or \$25 for both. To compensate for any inconvenience, all Websterville residents will be offered up to three tickets at half price. To take advantage of this we ask Websterville residents to pre-buy their tickets by visiting the Touring Center at 34 Church Hill Road. You will need to bring a copy of your Websterville Fire District bill to show proof of residency – M.T.A.

Tennis Lessons

The town Recreation Board is offering tennis lessons this summer. Three, 2-week sessions for children (grades 4-12) and for adults will be offered. Kelly Cleveland, Spaulding High School's Girls Tennis coach, will be the instructor.

The first 2-week session starts *June 24*; the second starts *July 8*; and the final session starts *July 22*. Student's lessons are in the morning from 9:00 - 10:30. Adult lessons are from $5:30 \ pm - 7:00 \ pm$. All lessons will be on the courts in the town's recreation area.

The fee is \$60 for a full 2-week session. Registration for just one week is possible, in which case the fee is \$35. Print out the form, or go to the town manager's office for a form. Ms. Cleveland asks that people bring the form and meet her at the tennis courts on *Thursday*, May 22nd or 29th from 5:30 – 7:00 pm.

The picnic shelter in the recreation area is a popular spot for reunions, parties, showers and club or business picnics. It is reserved most weekends during the summer; calls already have been coming in. If you are thinking of using the picnic shelter for an event call *Tina Thurston at 479-9331* or email offices@barretown.org to check availability and reserve the facility.

New this year, the town will send a reservation confirmation (certificate) to groups that reserve the shelter. Groups are advised to take the confirmation certificate to the event with them, in case another group claims to have a reservation.

For smaller gatherings, especially for younger children, two alternatives are the playgrounds in South Barre (Wilson Street) and East Barre (Pleasant Street). There are no restrooms or water at these two sites.

Youth Track Team

Barre Town and Barre City Recreation Departments once again are jointly sponsoring the Barre Youth

Track Team. The team is growing each year. Last year's team did very well at the state meet in St. Johnsbury. The team is for boys and girls age 7 - 14. At the meets young athletes can compete in both track (running) and appropriate field events – softball throw, running long jump, and others.

<u>Municipal Building Access For Those With</u> Disabilities

In accordance with State and Federal law the Barre Town Municipal Building is equipped with an elevator to help persons with disabilities access the following municipal offices: Manager, Clerk/Treasurer, Zoning, Assessing and



Engineering. This elevator also provides access to the meeting room and is located in the white Annex portion to the rear of the building. There are two handicap parking spaces directly in front of the Annex rear entrance. When you enter the hallway the elevator is the door on the left of the stairs and clearly marked.

Instructions for use of the elevator: Push and hold the call button to summon the elevator to your location. Once inside, push and hold the call button until you arrive to the second floor. These instructions are also posted in the elevator.

Section 504, Regulations of the Americans with Disabilities Act requires that all law enforcement agencies install a TTY (teletypewriter) device so that the deaf and hard of hearing individuals should be able to make both incoming and outgoing calls to police agencies, if hearing persons are permitted to make such calls. The TTY device enables the hearing impaired to use the phone by reading what is being typed by the caller on a small screen and to respond by typing back. In accordance with this regulation the Barre Town Police Department is equipped with a TTY device. Part of this Section also requires public entities which provide emergency telephone service to be accessible to deaf callers. Telephone emergency services, including 911 services, shall provide direct access to individuals who use TTY and computer modems. In accordance with this regulation, 911 is equipped to help the deaf and hard of hearing people.

Barre Town Police Department

We are starting a police department series in the newsletter. Since the idea came up, I decided it is good to have everyone learn more about our community police department. I will have a series of articles in the upcoming newsletters about the police department.

To start with let me give you a little information on the department:

We are staffed 24 hours a day. We have one officer on each shift except for overlap once a week where two officers are on duty.

The Police Department is made up of the Chief, the sergeant, and six full-time officers. We have eleven part-time officers. The animal control officer is attached and supervised by the police department as a separate unit.

To become a police officer a person must submit an

application, pass the written test, take the Minnesota Multiphasic Personality Inventory test at the Vermont Criminal Justice Training Council (VCJTC) before advancing in the application process. A committee reviews the applications to make sure they meet the requirements set to become an officer. Those requirements are a high school diploma, the ability to pass the VCJTC physical fitness test, hold a valid drivers license, and have no felony convictions. An oral board is set up to interview the candidates. Upon completion of the oral board, the top three candidates will be selected to be interviewed by the Town Manager and Chief of Police, who will select a candidate to be the new full-time police officer. Before finalizing the hiring the candidate must take and successfully pass a physical exam, polygraph and psychological test.

It can take a considerable amount of time to hire a new police officer, but it is important that the right person is selected for this position.

In the August edition of the newsletter we will be talking about training at the full-time police academy.

Property Value Assessments

This is the time of year for the town assessor to begin determining the new property values of those properties that have been modified since April 1, 2013. Modifications are determined based on building permits, owner notifications, and visual inspections. The assessor will visit those properties to determine the change in value. Property owners should take the opportunity to confirm that the information on their property card is accurate. Owners should verify building dimensions and lot size for example. Notify the assessor when sheds, decks, and porches have been removed because building permits are not required for removal.

The 2014 abstract of individual lists (proposed Grand List) will be lodged (filed) with the Barre Town Clerk in June and change of appraisal notices will be sent that same day. Notices must be sent to each property owner whose value has changed since the previous year. The notice will include information on the grievance process and the deadline for filing a written grievance. A written grievance must be received by the Assessor's Office within 14 days from the date the abstract of individual lists is lodged with the town clerk.

Taxpayers are encouraged to contact the Assessor's Office during the *fourteen-day period* to arrange an informal meeting to hear an explanation of the methods used in establishing values, and to ask questions. *Please call 479-2595 to make an appointment*.

The Assessor's Office will begin scheduling grievance hearings fourteen days after the abstract of individual lists have been lodged. Taxpayers will be allowed sufficient time to make their case during the hearing. A decision will probably not be made at that time; a Result of Grievance Notice will be mailed within seven days of the close of grievance hearings. It will include the decision of the assessor with respect to the grievance hearing, and instructions on appeals to the Board of Civil Authority from this decision. Property owners will have fourteen days from the date of mailing of the result of grievance notice in which to appeal to the Board of Civil Authority (BCA).

If the owner remains unsatisfied with the ruling of the BCA, the owner may appeal the decision to the Vermont Tax Department, Division of Property Valuation and Review. Instructions regarding the grievance and appeal process can be found in the Vermont Statutes, Title 32, Chapter 129 and 131.

Grievances and appeals are expected, and an important part of the assessment process. They will be handled professionally and in a timely manner.

Payments by Credit Card is Coming!

Annually, provided all the budgets (school and town) have passed, property tax and sewer bills are mailed to property owners no later than July 14th. With the release of

the bill(s) comes the same question with more frequency each year.....Can I pay by credit card? Now, I can finally say yes!



Beginning July 1, 2014, you will not only be able to pay by credit card but also be able to do it 24 hours a day via the Barre Town website (www.barretown.org) using a new on-line payment system.

There are <u>fees</u> (see table below) <u>for using</u> the credit card or on-line payment method. They are based on the dollar amount paid and the type of payment method selected. There will also be a service charge assessed for insufficient funds and/or returned items.

Payment Type	Fee per transaction
E-check	\$1.00 per transaction
Debit/Credit Cards	2.75% or if under \$100 = \$2.75 + 50¢
NSF/returned items	Charged an additional \$35.00

The payment amount will show up on your monthly credit card statement and will include the transaction fee. The Town will accept credit card or on-line payment for items such as property taxes, sewer charges, water bills, ambulance billings, permits, licenses, and much, much more. When making a payment(s) on the due date be sure to do it before midnight. Any payment made after that time will be considered <u>late</u> and assessed a late charge in accordance with the Town Charter.

For those of you who chose not to use a credit card or the on-line payment services the Town will continue to collect taxes using our current methods: 1) paying in person, 2) mailing your payment, 3) depositing your payment in the drop box located at the front of the building, or 4) by using our Direct Debit program.

Paying on line is definitely convenient and easy. Just a few clicks and you are done. Remember the service does not start until July 1, 2014.

What Not to Flush!

It is important to note that disposable does not mean flushable. Even the cleaning wipes and baby wipes that are described as "flushable" do not dissolve. These disposable or flushable wipes instead are likely to accumulate in the sewer lines which cause clogs and back-ups.

Other items which can cause clogs are: dental floss, paper towels, feminine hygiene products, cotton balls, bandages, syringes, chewing gum and unused or out of date medicine. Please do not flush these above mentioned items, but instead place them in the trash.

When emptying heavy grease or oils from frying pans or other cooking and baking pans pour it into a small metal can and then through it in the trash. This will help avoid sewer plugs and clogging the sewer line in your house trap or downstream once it has cooled off.

Please consider this information when using any of these products and dispose of the waste properly in the trash rather than flushing it down the toilet or the drain.
