November Special Town Meeting

November 4 is the state's general election day. Voters will elect a governor, state senators, a member of the U.S. House of Representatives, and more state officials. Because of a vote on July 29 stating the selectboards intent to call for a Special Town Meeting on November 4, town residents likely will vote on 5 town articles.

Leading the list of town articles will be an article about joining the regional public safety authority with the City of Barre and City of Montpelier. It was this issue that prompted the Selectboard to announce its intention to call for a Special Town Meeting. The board expects to approve the Special Town Meeting Warning at its meeting on August 26. The Warning could include 4 Town Charter amendments; one each for 4 sections of the Charter.

The selectboard will hold public hearings about the regional public safety authority and Charter amendments on October 7 and 21.

The Town Charter sections that might be on the ballot are 3, 7, 33 and 34. The Town Charter can be read using a link on the town website (www.barretown.org/Pages/charter.html). Section 3 is about warning Town Meeting and elections. The amendment in 3 (a) would change the requirements for warning an election and town meeting. It is proposed to revise Sec. 3 to be consistent with recent VT Open Meeting Law amendments and a Selectboard policy in response to those state requirements. (See article page 6).

Section 7 describes the process for seeking election to town office. Because of changes in federal and state election laws, the time period for submitting nomination petitions has to be pushed back by 15 days (15 days sooner).

Section 33 spells out tax rate and billing procedures. This section currently states that if voters decide taxes will be due in more than 1 (but not more than 4) installment the installments amount shall be equal. Because the state now requires tax rates be calculated to the ten thousandths of a penny and requires that income sensitivity credits be deducted from the gross property tax bill, the annual amount due isn't always equally divisible by 4. The proposed amendment will simply state the installments will be as equal as possible.

Revisions to the last section (34) also were prompted by an amendment to state law Section 34 is about the Board of Abatement. The Charter currently requires the B.o.A. to find reason (listed in state statute) to abate a tax or fee. Any late fees, penalties and interest due could be abated at the same percent as the principal or base charge. State law was changed to allow abatement of just late fees, penalties and interest. Other changes in this Section update the requirements for giving public notice of B.o.A meetings and attempt to reduce confusion about the B.o.A's assignment, specifically over authority to abate assessments charges, or other levies.

Municipal Tax Rates

On July 1 the Selectbord set the fiscal year (FY) 2014-2015 tax rates. The sewer use fee and water rates were adjusted on June 24. The first property tax and sewer bill payments were due August 15 and hopefully were paid on time.

Education is the largest percent of the overall property tax rate. The state Department of Taxes provides the education tax rate for both homestead and nonhomestead (business) properties. The Selectboard must use the rates supplied by the Tax Department.

The Selectboard determines the General Fund, Highway Fund and Local Agreement tax rates using voter approved budgets, amount of the town taxable Grand List and cash balance. This summer the Selectboard applied the equivalent of $1 \notin$ on the tax rate (\$60,900) of cash balance to the General Fund tax rate. The GF, HF and Local Agreement rate comprise the municipal tax rate.

Shown below are the municipal tax rates since 2010 – 2011:

The 2014-15 municipal tax rate went up 3.3¢ or 3.8%. Since 2010-11 municipal tax rates have increased 4.37¢. For a typical Barre Town homeowner whose home

is assessed at \$175,000, the municipal tax bill has gone up \$76.47 over 4 years or \$19.11 per year. The 5.14% tax rate increase over 4 years is an average annual increase of 1.28%.

Over the years, even decades, the municipal tax rate has grown and fallen. Below is a simple match quiz used at this year's open Town Meeting. *Match the tax rates to the years:*

The sewer use fee for 2014-15 went up \$6 or 2%. Barre Town water system customers are seeing a 5.2% increase in their water consumption charge.

PAYMENT by CREDIT CARD is on it's way!

Due to unforeseen programming issues, the payment by credit and debit cards, as well as e-check has been delayed. I am assured by the programmers that the system should be up and running no later than end of August, 2014.

Just as a reminder there will be fees (see table on page 3) for using the credit card or on-line payment method. They are based on the dollar amount paid and the type of payment method selected. There will also be a service charge assessed for insufficient funds and/or returned items.

The payment amount will show up on your monthly credit card statement and will include the transaction fee. The Town will accept credit card or on-line payments for items such as property taxes, sewer charges, water bills, ambulance billings, permits, licenses, and much, much more. <u>When</u> <u>making payment(s) on the due date be sure to do it before</u> <u>midnight.</u> Any payment made after that time will be considered late and assessed a late charge in accordance with the Town Charter.

For those of you who chose not to use a credit card or the on-line payment services the Town will continue to collect taxes using our current methods: 1) paying in person, 2) mailing your payment, 3) depositing your payment in the drop box located at the front of the building or 4) by using Direct Debit program.

Electronic Devices and Driving



Beginning October 1^{st} , the use of a handheld electronic device (including cell phones) while driving on a Vermont highway is prohibited. Violations of this new law will result in fines from \$100 to \$500 per incidence in addition to potential points

added to a driver's record. Hand held electronic devices can only be used when it is necessary for a person to communicate with emergency services or law enforcement under emergency circumstances. House Repair Loans

Central Vermont Community Land Trust continues to provide housing rehabilitation loans to qualifying town residents. With several programs available, including the Barre Town Housing Rehabilitation Program, CVCLT can provide low interest loans to fix up homes including weatherization repairs. Loans must be used for rehabilitation to resolve health and safety issues such as weatherization, structural problems, or system failures making your home more comfortable and maybe reduce heating costs. Displaying your Building Numbers

Barre Town continues to offer building numbers at a minimal cost. As part of our effort to better identify properties for emergency services, the Town is able to supply 4" x 12" green reflective signs with your building number. Holes can be drilled for hanging purposes if desired. The cost of the sign is \$10 and can be ordered through the Town Managers Office. You can call for a form (479-9331) or print one from the Town website, www.barretown.org. All forms should be turned into the Town Manager's Office by mail at P.O. Box 116, Websterville, VT 05678 or dropped off. If you're not sure what your building number is you can contact the Assessor's Office at 479-2595.

Having an easily identifiable building is a critically important part of helping emergency service providers find you in an emergency. Building numbers must be displayed where it can be seen day or night from the road. Please consider the location of your building number and whether it is easily identifiable.

EMS Monthly Training in July

The Barre Town EMS department hosts training for all EMS employees every third Wednesday each month. Area



ambulance services and first response squads are invited each month as a way of enhancing their own training opportunities with interesting and timely topics by knowledgeable staff and guest lecturers.

The EMS Department hosted a lecture on Pediatric Emergencies presented on July 16th by Jonathan

Snow, Critical Care Paramedic and Instructor/ Coordinator for the New England EMS Institute in Manchester, NH. The lecture was well attended by BTEMS personnel as well as personnel from several area services and FAST squads.

The Emergency care of children requires specific knowledge, equipment, skills, and resources. A child's physiologic response to a critical illness or injury differs from an adult's for such conditions as shock and prolonged respiratory distress. The causes of catastrophic events, such as cardiac arrest, are different from those of adults. In children, the signs and symptoms of distress may be subtle, and EMS providers are required to know the differences.

In keeping with the pediatric theme, Barre Town EMS will host a training on the Signs of Abuse and Neglect, and Mandatory Reporting to be presented on August 20th by John Bouthillette, APS Program Chief, Department for Children and Families (DCF).

FALL BULK TRASH COLLECTION September 20, 2014

That town dump day is coming up. You know, that collection of big stuff at the town garage, where the school buses are parked; it is Saturday, September 20. If you've been busy making home improvements or if you have unneeded items laying around the basement, garage or tool shed, do some summer's end cleaning up. The bulk trash collection is a great, less expensive way to dispose of old furniture, mattresses, carpet, large plastic toys, building material, pool covers and liners, and other large items.

The service is offered from 8 am -2 pm on Saturday, September 20 at 129 Websterville Road. Service is for town resident's home use only. Bring a tax or utility bill to verify residency. Fees are charged (See below).

Small pieces of sheetrock, plaster, roofing shingles, and any other material or items must be in containers. Siding and lumber must be cut to easily handled lengths. Loads of loose (not in containers) roofing shingles will be parked at the side and unloaded when no one is in line to be off-loaded. Plan your load for efficient off-loading and be sure it is properly secured.

LEAF DISPOSAL



This fall, when it is time to clean up the lawn, there is an alternative to burning leaves and to raking them into ditches and drainageways. Leaves and tall grass often are dry in the fall. A little wind could spread the fire creating a wildland fire. No one needs that.

The lawn waste site on Holden Road is open Wednesdays 3 pm – 6pm; Thursdays 9 am to noon, and Saturdays 8 am to noon. On the weekends of October 11,12; 18, 19; and 25, 26 the site will be open Saturdays from 8 am to 4 pm and Sundays noon to 4 pm.

To haul more leaves, chop them once with the lawnmower. Laying a tarp or sheet of plastic in the truck bed will reduce off-loading time. Please don't leave plastic or any bags at the site.

HOUSEHOLD HAZARDOUS WASTE – CVSWMD Collections

The Town of Barre is a member of the Central Vermont Solid Waste Management District (CVSWMD), which means Barre Town residents can use CVSWMD's sponsored collections in any town. The CVSWMD is holding three more special collections this year:

- ~ Saturday, Sept. 6 paint, battery, fluorescent and CFL bulbs at Bradford Town Garage
- ~ Saturday, Sept. 27 household hazardous waste (HHW) at Bradford Town Garage
- ~ Saturday, Oct. 11 HHW at VT Department of Labor, Montpelier

All collections are open 9 am – 1 pm. PBF collections are free. For residents, the HHW fee is \$15 per car. For more information visit the CVSWMD website at *www.cvswmd.org*.

SCHOOL STARTING SAFETY TIPS

NO PACA

Another school year at Barre Town Middle and Elementary School started August 26. School is getting underway in surrounding towns, too. With the start of a new school year we would like to remind you of a few safety concerns.

Keep in mind there will be more traffic in the morning and afternoon as parents, teachers, and children are headed to and from school. You should plan your time accordingly. Many crashes happen because people are in a rush and their primary focus is on getting where they are going instead of what is in front of them on the road. Many also get distracted by their cell phones and other electronic devices. When available use hands free devices and learn how to use them properly. *As of October 1, 2014 a hands free device law will be in effect.*

School buses can slow your commute but be sure to obey the flashing signal light system. Yellow lights mean that the bus is preparing to stop to load or unload children. Motorists should slow down and prepare to stop. Red lights and the extended stop arm indicate that the bus has stopped and children are getting on or off the bus. Motorists must stop their vehicles and wait until the red flashing lights are turned off and the stop arm is withdrawn.

When approaching a bus stop whether the bus is there or not you should slow down. Children waiting for the bus, walking or biking to the bus stop or school can be unpredictable and wander into the path of a motor vehicle. Parents should remind their children to watch for traffic and stay aware of what is going on around them.

Also be aware that there are more new drivers headed to or from school. For parents this is a good time to remind their teen drivers of the rules for school buses, the graduated license process, the electronic device while driving regulations and general safe driving procedures.

This is a great time to remind children never to take a ride from someone they do not know no matter what the person says. If approached they should also try to remember the registration plate number so the police can attempt to identify the person. Children should be reminded to just scream if someone approaches them that makes them feel uneasy. This will alert people in the area that something is wrong. If parents or their children observe any suspicious behavior they should notify the Barre Town Police Department (479-0508 or 479-0509) so the incident can be investigated.

Meeting Agendas and Minutes

To comply with Vermont Open Meeting Law amendments that went in effect July 1, 2014, the Selectboard adopted a policy for posting all board, commission and committee meeting agendas. Barre Town has been posting Selectboard meeting agendas at three stores for nearly 20 years and on the town website for about 13 years.

No less than 48 hours before a regularly scheduled meeting, agendas for all boards, etc will be posted at Graniteville General Store, Trow Hill Grocery, Hannafords and inside the Municipal Building. Also the agenda will be posted on the town website. To find agendas, from the home page (www.barretown.org) select Boards and Commission. Pick the board or committee and look for the list of agendas. Typically agendas are posted at the 3 stores on Friday evenings and in the Municipal Building and online Friday afternoons.

The new Open Meeting amendments also require draft meeting minutes be posted on the website within 5 working days of the meeting. Minutes can be found on each board, or commission's webpage, usually next to agendas.

The 4-week calendar on the website is a helpful resource. The calendar is updated weekly. When agendas are posted on the website, meeting time entries on the calendar serve as links to the agendas.

The website offers a subpage called Departments, as well as the Boards and Commission subpage. The Departments navigation button offers information about departments, about operations and contact information for the staff.

When residents think of Public Works what often comes to mind is a department that handles upkeep and maintenance of road issues. But public works handles much more than that. Public Works also handles all Sewer and Water issues. Please remember to call the Department of Public Works first when you suspect a sewer or water problem, prior to any homeowner or *(Continued on page 7)*

TRAINING AT THE POLICE ACADEMY

The Barre Town Police Department hired a new recruit and this is a sample of what he/she should experience in their own words at the Vermont Police Academy.

Day One, Week One: As I pulled in and park in the rear of the parking lot we all lined our vehicles up in a row. Each one of us standing in front of our vehicles with our bags on the ground next to us. It is easy to spot who is nervous/ scared and who was comfortable under pressure. As soon as our Training Coordinator (TC) and Training Assistants (TA's) exit the building all the excitement begins. The TC's and TA's begin pushing recruits tolerance levels with a series of tasks as simple as standing in line to making our bed with exact measurements within a special amount of time. Throughout the day we are all tested on core values such as ethics, discipline and honor. We are even quizzed on such items in the chow line.

Day Two: As we begin the second day we wake up at 6:00 a.m. to the ringing of a bell and all the recruits sounding off. Various chores need to be completed before we can start the day. The living areas need to be cleaned such a vacuuming the floors, mopping the stairs to cleaning the bathrooms. By 6:45 a.m. all chores are done, teeth brushed and all male recruits are freshly shaved and everyone is in their uniforms lined up for inspection in the gymnasium. After various corrections have been made we head to breakfast where the only talking you can hear is the asking and answering of questions posed by the TC's and TA's. After breakfast we head to class. While at the academy the cadets are put through collegiate type classes, such as; Vermont Criminal Law, Vermont Motor Vehicle Law, Crime Scene Investigation, Firearms Instruction, Driving Instruction, and Non-Lethal Use of Force. In addition we also receive instruction about patrol procedures, domestic violence, liquor control, DUI, fingerprinting, juvenile law, etc. A lot of these classes such as crash scene investigation consists of practical training like going to the local junk yard and examining the vehicle damage caused by crashes. In the late afternoon hours cadets will do their physical training. After dinner is boot polishing and uniform pressing and studying for the next days classes. By 10:00 p.m. our day is complete as we sound off before jumping into our racks.

As the days turn into weeks our class moves from phase one to phase two, which allows the class to have more privileges. For the majority of the class the excitement is the one cup of coffee allowed in the morning. Through this phase our team building exercises also become more intense as we move from trust falls to a ropes course involving repelling and zip-lining. When the TC decides you have not completed tasks or have become too complacent, you can easily be regressed back to phase one.

After proving ourselves time and time again, our TC's ultimately advance us to phase three, the highest level we can achieve while at the academy. Phase three allows for the class to operate on their own with minimal supervision at the very end of academy. This is when the TC allows the class to run itself. There is a class president, vice president and four team leaders that delegate tasks so the class is self sufficient.

All law enforcement officers (municipal, state, DMV, fish and game, or DLC) in the State of Vermont attend VTJC. This gives everyone the best advantage possible because we know when we show up on a call or ask for backup that everyone has been trained to the same standards. This gives us a crucial leg up when dealing with dangerous situations.

At the end of seventeen weeks the recruits graduate and are pinned in a ceremony where they transition to Police officers.

In the November issue of the Barre Town Municipal Newsletter we will follow our officer through the FTO (field training) process.
