BARRE TOWN SELECTBOARD MINUTES

April 9, 2019

The duly warned meeting of April 9, 2019 was held at the Barre Town Municipal Building, Selectboard Room, in Lower Websterville at 6:00 p.m.

The following members were in attendance: Tom White, Norma Malone, W. John "Jack" Mitchell, and Bob Nelson. Paul White arrived at 8:37 p.m. for executive session.

CALL TO ORDER - The meeting was called to order at 6:04 pm.

PLEDGE OF ALLEGIANCE - Those present recited the Pledge of Allegiance.

APPROVE THE AGENDA

On a motion by Bob Nelson, seconded by Norma Malone, the Selectboard voted to approve the meeting agenda as amended: #22 Executive Session add personnel and under

department head visits EMS Director will present later in the meeting. Paul White was not present for the vote.

MINUTES

On a motion by Norma Malone, seconded by Bob Nelson, the Selectboard voted to approve the Selectboard meeting minutes of April 2, 2019 with minor spelling and grammatical correction and the following: page 2-Accufund Accounting Software Consideration, paragraph one should state without prior approval from the Selectboard and should be inserted into the motion on page 3. Paul White was not present for the vote.

RESOLUTION NO. 2-19

RECOGNITION OF TOWN AND COMMUNITY VOLUNTEERS.

Background: April 8th – April 12th is National Volunteer Appreciation Week. Keeping with past practice the Selectboard will recognize the Town's and general community volunteers.

Jack Mitchell read the resolution.

On a motion by Norma Malone, seconded by Jack Mitchell, the Selectboard voted to adopt Resolution No. 2-19, A Resolution of the Town of Barre, Vermont in recognition and Appreciation of Town and Community Volunteers. Paul White was not present for the vote.

VOLUNTEER APPRECIATION

Background: Every volunteer receives a token of appreciation. This year there are many special recognitions. In addition to 5 and 10 year volunteers there are two volunteers who have served 25 consecutive years.

Bob Nelson read the list (see attached) of the volunteers along with the special recognitions which included: Mark Nicholson and Charlie Woodhams (25 years), Mike Jarvis, Mark Nicholson, Byron Atwood, Jon Valsangiacomo, Jenny Hyslop and Joe Coates (10 years), and George Clain, Dave Rouleau, Marianne Kotch and Dawn Farnham (5 years).

Door prizes were given to Mike Gilbar, Cara Lemieux, Cedric Sanborn and Sandi Kirkland.

The Selectboard members also recognized the many organizations that serve Barre Town youth such as the Aldrich Public Library, Washington County Youth Service Bureau, Girl Scouts of the Green and White Mountains and the Parent Teacher Organization - parent and grandparent volunteers at the Barre Town School.

Certificates of Appreciation were given to Brookside General Store, Graniteville General Store, Hannaford Market, Lawson Store, Quarry Hill Quick Stop and Trow Hill Grocery.

Jack Mitchell stated that society cannot exist without volunteers and it is a crucial part in making society work. Mitchell also acknowledged there are a lot of people behind the scene that don't get recognized.

REPORT FROM BARRE PARTNERSHIP

Board member David Gold is here to give an update of the current work being done. He thanked the Selectboard for their continued support. The Partnership's primary focus has been on continuing to search for an Executive Director and additional Board members. Jeffrey Tuper-Giles has stepped down from the Board and has taken the position as the interim Executive Director. There are 4 candidates for the Executive Director position. Three have had interviews and the 4th interview will take place later this week. Their expectation is to make an offer next week to fill this position. Candidate availability ranges from a couple of weeks to a month so the new Director should start by the middle of May.

Norma Malone asked if Mr. Tuper-Giles would return to the Board when he is no longer needed as interim Director and how many Board members do, they currently have. Mr. Gold stated he will return to the Board and they currently have 4 members. The Partnership is looking to increase the Board members to around 9 or 10.

Bob Nelson stated as long as there is an odd number there could be any number of Board members but the optimum number is 9. Bob Nelson also stated that with the exception of the Executive Director the Barre Partnership is an all volunteer organization. If anyone is interested in volunteering, they can visit the website or contact David.

Jack Mitchell stated there was talk in the past about collaborating more with Barre Area Development and is this still the plan. Mr. Gold said that there would absolutely be collaboration with all organizations, merchants and Barre City and Barre Town community members.

Tom White thanked Mr. Gold for taking the time to update the Selectboard on the current work they are doing.

DEPARTMENT HEAD QUARTERLY VISIT

Background: Quarterly the Department Heads provide reports to the Selectboard. Those reporting tonight are the Planning & Zoning Director and Fire Chief, EMS Director and the Town Engineer.

Town Engineer:

Harry Hinrichsen talked about road and summer work projects.

- Milling will start after the 1st of July. The contracted price with Garrity is the same as last year at \$1.40 per sq yard which is considerably lower than the \$2.00 per sq yard budgeted for.
- Paving price for hot mix has increased \$5.00 - \$6.00 per ton but is still at an 8 year low with our current price at \$70.45 per ton. The all time low was in 2016-2017 with a cost in the \$62.00 range. Ten years ago, the cost was in the \$80.00 range.
- Two people are up for re-appointment this year on the Traffic Safety Advisory Committee (TSAC). One person is stepping down and would not entertain being reappointed. One of the contentious issues with the TSAC is the truck traffic on Middle Road. The Committee has made a couple of recommendations and will be meeting on April 17th. The Committee will also be addressing parking issues on Casanova Street.

Norma Malone inquired when the milling and paving would be completed. Harry stated they try to complete the work by the 2nd week in September. Due to roads with a number of manholes in them it could be later. A list of the roads to be done is in the April Town Newsletter along with the schedule.

Norma also inquired about line striping and the quality of the paint being used. Harry explained that the paint won't be going down until the paving is completed in September and that the plows are scraping off the reflective beads that are put in the paint, so the striping has to be done yearly.

Norma also inquired about striping on the existing paved roads. Harry explained that the Town is responsible for all of the white lines on the roads the Town paves and for the center lines on Class 3 roads. The State does the center line on Class 2 roads.

Mitchell brought up the design for the Sierra Lavin Road and fixing the drainage problem. Harry stated that the road has been paved and now they have to figure out the water issues. Camp Street is also having water issues.

Planning and Zoning Director/ Fire Chief:

Chris Violette first reported on Planning and Zoning.

- 26 permits were issued January - March resulting in \$16,681 in fees collected. The Vermont Foodbank obtained multiple sewer units costing \$8,250 and \$6,000 was for JDJ Development to construct one of 4 new 4-unit dwellings off Rudd Farm Drive. Four new housing permits were issued.
- The DRB reviewed the site plan for 1 Bridge Street. Jay Carr received site plan approval to put up several more storage units on property below Jockey Hollow and received a site plan approval to put up a building to house a laundry mat and office space. The DRB also approved the phase 1 site plan for VT Creamery. Phase 2 is on the agenda for the September 10th meeting.
- The Planning Commission did not meet in January or February but did meet twice in March. They have been working exclusively on the Energy Plan. They have also been working on the Town Plan which expires in May.

Norma Malone asked when the Town Plan would be completed. Chris stated by the end of the summer. This plan is valid for 8 years.

Fire Department:

- January through March, the Fire Department responded to 63 calls. Six of the calls were to Orange where most of the fires occurred. The Department responded to a 3-bay garage fire on Cutler Corner Road and a trailer fire on Reservoir Road which burned completely to the ground. There was also an illegal burn on Reservoir

Road. The Department responded to 14 motor vehicle accidents, one required extrication. There were 13 monitored alarm activations. Most of the activations were at two locations. There were 6 mutual aid calls, the biggest one being a fire on Park Street in Barre City.

- Training over this quarter was mixed as usual. They included SCBA training, UTV training with our off-road rescue, practiced cutting holes in the ice at the Wells Lamson Quarry as well as Littlejohn Quarry because sometimes this is where the water source is and extrication training held. Also performed were truck checks and station cleaning.
- Engine 2 returned from refurbishment in February.
- East Barre Fire members did a significant amount of work remodeling the classroom in East Barre.
- Were sized for the new gear as well as took delivery of this gear at the end of this quarter. 28 sets of new fire gear are in service.
- South Barre along with members of East Barre hosted the Rabies Clinic on March 9th. The turnout was not as great as in the past, but it was still successful.
- Hosted the Capital Fire Mutual Aid meeting at the East Barre fire station on March 20th.

Jack Mitchell asked about the generator that is non-repairable. Chief Violette stated that because the rescue truck is in the 5-year plan and the cost of a new generator is around \$10,000 it doesn't make sense to replace it now. The lighting needs can be covered with the portable generators that we currently have.

Chris Violette introduced Kevin Otis to talk about Freezing Fun for Families. Over the last four years the Barre Town Fire Department has participated in this event. Kevin stated that because the Department has raised so much money, they have made it to the grand slam member status and was given an award. To date they have raised more than \$10,000.

Chris Violette announced that the Captain vacancy was awarded to Josh Stewart. Josh has 15 years of fire service with the last 7 years with Barre Town. This was effective April 8th.

Tom White had questions about the Motor Vehicle Accident Policy & Plan, whether this covers the different emergency services, and will this be revamped in the near future to add in a winter revision policy. Chris stated that no personal vehicles are used on the interstate and he will review the policy and get back to the Selectboard members.

EMS Director: Chris Lamonda will give his quarterly report at a later date.

CONTRACTS

11a: TRUCK BODY AND PLOW SYSTEM

Background: The contract is for mounting a 5-7 cubic yard dump body on the 6-wheel chassis awarded to Clark's Truck Center in December. Bidding specifications were mailed to four companies. Three bids were turned in. The low bid is from Tenco, but the plow does not meet specifications. The second low bidder is Viking-Cives which Mike Martel recommends. The last truck purchased has a Viking-Cives body. Mike also recommends the optional paving tailgate.

The '18-'19 Equipment Fund budget included \$180,000 for this truck. The chassis cost \$89,531. The complete truck will cost \$160,481 roughly \$19,500 under budget. The truck will have an angle plow to make plowing cul-de-sacs easier and quicker.

On a motion by Bob Nelson, seconded by Norma Malone, the Selectboard voted to award the contract for a dump truck body and plow system with optional paving tailgate to Viking-Cives at the price of \$70,950. Paul White was not present for the vote.

Selectboard Minutes of April 9, 2019 Continued:

Town Manager Rogers explained to the Selectboard members what an optional paving tailgate is.

11b: TRASH RECYCLING

Background: This is a one-year contract starting May 1, 2019. The contract covers the municipal buildings, EMS station, public works truck garage, Wilson Cemetery and recreation. Prices are higher than the previous 3-year contract expiring this month, but slightly lower than estimated in the '19-'20 budgets (except EMS which is slightly over). Bidding specifications were mailed to Myers and Casella. An ad was published twice in the Times Argus.

Myers is the low bidder for every location. Myers has won the contract in the past.

On a motion by Norma Malone, seconded by Bob Nelson, the Selectboard voted to award the May 1, 2019 to April 30, 2020 trash and recycling removal contract to Myers Waste and Recycle. Paul White was not present for the vote.

THUNDER ROAD RACE SEASON

Background: Thunder Road needs a special event permit for the upcoming race season. (First race is Sunday, April 28th). Thunder Road turned in everything needed: signed police services contract, \$800 permit fee, a copy of fire and rescue agreement with Speedway Safety Service, copy of the state permit, race schedule and certificate of insurance.

Town Manager Rogers will send a letter to Thunder Road addressing the need to maintain an adequate driving lane in the camper parking area for the fire trucks to access if needed.

On a motion by Bob Nelson, seconded by Norma Malone, the Selectboard voted to approve the 2019 police services contract with Thunder Road.

Jack Mitchell stated that camper parking has become an issue and asked if the Town Manager had any discussion with Thunder Road about adding more room for additional camper sites. Town Manager Rogers stated that has not been discussed with Thunder Road.

On a motion by Bob Nelson seconded by Jack Mitchell, the Selectboard voted to authorize the Town Clerk to issue Special Event Permit No. 19-1 to Thunder Road for the 2019 racing season. Paul White and Bob Nelson were not present for the vote.

CLOSED ROADS

Background: Thunder Road and Barre Partnership once again are planning the race car show on North Main Street in Barre City. The show is during the morning of Saturday, April 27th. After the show the race cars parade up to the race track. The cars are not legal for travel on a public road unless the road is closed.

Title 23, Chapter 13, Section 1010 of the VT State Statutes authorizes the Selectboard to exclude motor vehicles from town roads. Our police car escorts the race cars into Thunder Road. An officer is stationed at Quarry Hill Road and Fisher Road to stop traffic while the race cars turn left onto Fisher. The entire process of driving up Quarry Hill and down Fisher Road takes about 20 minutes in Barre Town. Posters are put up at Lawson's, Graniteville General and Quarry Hill Quick Stop. Residents along Fisher Road and the affected part of Quarry Hill Road will receive a letter of this closure.

On a motion by Jack Mitchell, seconded by Norma Malone, the Selectboard voted to authorize Fisher Road and Quarry Hill Road, from the Town/City line to Fisher Road be closed on Saturday, April 27, 2019 from approximately 12:10 to 12:40, as needed, because of a special occasion with the car show. Bob Nelson and Paul White were not present for the vote.

Norma Malone amended the motion by adding 12:10 pm to 12:40 pm.

WARNINGS

Background: Warnings for the May 8th Annual Town Meeting and May 14th Election of Officers were provided to the Board members. On the Town Meeting Warning, Article 1, the payment due dates reflect the calendar and President's Day holiday. All other articles are unchanged from prior years. On the Election Warning, the Budget Committee's adopted budget totals were used in Articles 2,3 and 4. Every group appearing on the ballot turned in their brief report confirming continued eligibility. The donation amount requested by every agency is the same as 2018. No one submitted a petition for an increase.

Norma Malone wanted clarification under Article 3, of the May 8th Warning, the due date for the February sewer installment. Town Manager Rogers stated it was February 18th.

On a motion by Norma Malone, seconded by Bob Nelson, the Selectboard voted to approve the Warnings for Annual Town Meeting and Annual Election of Officers by Australian Ballot. Paul White was not present for the vote.

LETTER OF SUPPORT

Background: The CVRPC requests a letter of support for a Transportation Resilience Planning grant application. The grant would pay for a study of the Stevens Branch watershed. The purpose is to identify bridges, culverts and road embankments vulnerable to flood damage. There is no cost to the Town. The letter, however, will have to state the Town will be represented at a meeting where the study results are presented.

On a motion by Jack Mitchell, seconded by Norma Malone, the Selectboard voted to authorize a letter of support for the CVRPC's Transportation Resilience Planning Grant Application. Paul White was not present for the vote.

BARRE CITY - LAWN WASTE SITE

Barre City has proposed using the lawn waste site located on the Upper Holden Road from April 27 through May 18, 2019 with dates and times specified. Barre City is charged 50% of all labor and equipment fees. There have been no problems in the past.

On a motion by Jack Mitchell, seconded by Bob Nelson, the Selectboard voted to approve Barre City Residents' use of the lawn waste site from April 27th to May 18th. Paul White was not present for the vote.

GRANT AGREEMENT

Background: Because of the detour needed for the I-89 Exit 6 north-bound exit ramp closure, AOT is offering the Town up to \$8,032 for law enforcement and maintenance expenses. The agreement is specific to Airport Road and Miller Road.

On a motion by Norma Malone, seconded by Jack Mitchell, the Selectboard voted to authorize the Town Manager to sign agreement #GR1354 with the VT Agency of Transportation. Paul White was not present for the vote.

Norma Malone inquired to the Town Manger what type of services does law enforcement provide, will there be addition cost for traffic control and what are the maintenance expenses? Town Manager Rogers explained that law enforcement could be trying to help keep trucks off the road and the maintenance could be to repair roads due to the extra truck weight.

Jack Mitchell asked if AOT has a contract yet. Town Manager Rogers said the contract is with BUR Construction from Claremont, NH. They are following the schedule presented last December. There has been some activity, a job trailer has been set up on Williams Road. The next step will be working on getting access roads to the top of the ledge. Blasting will begin mid to late June with the completion of the project in late August.

PERSONNEL POLICY

There are four proposed changes to consider. The first is alcohol consumption during social functions item #14 section 11. There are two options. Option A: The limited, responsible consumption of alcohol on or off municipality premises at a Town-sponsored business or social function is permitted, but only if it has been authorized by the Town Manager. Option B: The Town Manager may permit alcohol to be served at a Town-sponsored business or social function on or off municipality premises. After discussion the consensus is option A.

The second proposed change is item #12 section 15- off duty conduct of employees. Assistant Town Manager Wang quoted that in the HR Management in Local Government book it states "in many respects, government employees have greater rights than their private sector counterparts to conduct their personal life as they wish. Discipline for off-duty conduct is justified if it affects the employee's ability to do his or her job or is directly detrimental to the government employer." After discussion by the Selectboard, the consensus is to keep the off-duty conduct language.

The third item is 11K sections 6,7 and 17 - streamline all timeframes where an employee must notify their supervisor before taking time off. After discussion the consensus is to eliminate section 6 and keep section 7 and 17 as stated.

The last item is item #6 sections 3, 16 and 17 - clear up definitions of full-time employees. The consensus is to keep the wording in these sections.

Tom White suggested that the appendices that were going to be reviewed tonight be addressed at a later meeting. Email Assistant Town Manager Wang with any questions or comments.

ACCOUNTS PAYABLE WARRANT

On a motion by Norma Malone, seconded by Jack Mitchell, the Selectboard voted to approve the accounts payable warrant dated April 9, 2019. Bob Nelson recused himself from the vote. Paul White was not present for the vote.

MISCELLANEOUS

On a motion by Jack Mitchell, seconded by Bob Nelson, the Selectboard voted to approve a second-class liquor license to Lawson's Store. Paul White was not present for the vote.

On a motion by Bob Nelson, seconded by Norma Malone, the Selectboard voted to approve a second-class liquor license to Trow Hill Grocery. Paul White was not present for the vote.

‘ROUND TABLE

Jack Mitchell will deliver Dawn Farnham's volunteer recognition gift along with Lawson Store's Certificate of Appreciation.

Bob Nelson will deliver Trow Hill's Certificate of Appreciation.

Norma Malone stated she was okay with the April 29th taping of the budget presentation. Norma also wanted to know when the Selectboard would be receiving a presentation by the auditors. She would like a target date of the 30th of this month.

EXECUTIVE SESSION

On a motion by Jack Mitchell, seconded by Norma Malone, the Selectboard voted to find the need to go into executive session citing premature general knowledge would put the Selectboard at a substantial disadvantage. Paul White was not present for the vote.

Selectboard Minutes of April 9, 2019 Continued:

On a motion by Jack Mitchell, seconded by Norma Malone, the Selectboard voted to go into executive session at 8:23 p.m. for labor contracts and personnel. Paul White was not present for the vote.

On a motion by Bob Nelson, seconded by Norma Malone, the Selectboard voted unanimously to come out of executive session at 9:50 p.m.

PERSONNEL ACTION

On a motion by Norma Malone, seconded by Jack Mitchell, the Selectboard voted unanimously to approve salary increases for the Town Manager & Assistant Town Manager as discussed for FY '18-'19.

ADJOURN

On a motion by Paul White, seconded by Jack Mitchell, the Selectboard voted unanimously to adjourn at 9:53 p.m.
