November 3, 2020

The duly warned Annual Barre Town Australian Ballot Meeting was held on Tuesday, November 3, 2020 at the Barre Town Gymnasium, 7:00 a.m. - 7:00 p.m. The Board of Civil authority met on Thursday, October 28, 2020 to update the checklist.

POSTING CERTIFICATION

All advertising, postings, and meetings were administered in accordance with VSA Title 17 and the Town of Barre Charter Sections 3a and 6c. Advertising was through the Times Argus Newspaper and posting locations included: Hannaford's, Trow Hill Grocery, Graniteville General Store, Lawson's Store, the Barre Town Municipal Building, and the Town website.

Election Day

Presiding Officer Donna Kelty declared the polls open at 7:00 a.m. The polls were declared closed at 7:00 p.m. Ballots were tabulated using the Accuvote Optic Scan machine.

With the ongoing COVID-19 Pandemic many precautions were taken. Special sanitization tables, cleaning crews, plexiglass shields for check-in worker, floor markers for social distancing, and rotating crews (2 to 4 hours shifts) in the gymnasium. Early ballot processing was conducted by the BCA on October 21, 22, 23, 29 and 30, 2020 at the Barre Town Municipal Building. The events were live streamed to ensure voters the tabulation process was being followed and to provide transparency to the process. Each BCA worker signed an Election Oath which is recorded at the end of the minutes.

Throughout the day the following additions were made to the checklist either by the Statewide Checklist (VEMS) system or through paper application at the polling place.

STATISCAL INFORMATION

The end of the day there were 6,253 voter on the checklist. Of those 4,839 ballots were cast, with 3,777 by early ballot. There were 55 defective early ballots. Overall voter turnout is 78.05%.

Throughout the day many individuals were referred to other municipalities where they were currently registered to vote. There was one incident with a voter. The individual did not feel early ballots being counted at the polls was being handled correctly and refused to hear more about the process from the Presiding Officer. A complaint was filed with the Election Commission. Upon detailing our process the Commission deemed all was in order and the handling of early ballots was done appropriately, transparent, and in accordance with law.
