## ORDINANCE NO. 2013-6

AN ORDINANCE DESIGNATING AND ZONING CERTAIN RECENTLY ANNEXED PROPERTIES LOCATED WITHIN AND ADJACENT TO THE WINDTREE SUBDIVISION AS LOW DENSITY RESIDENTIAL DISTRICT WHICH FOUND TO BE CONSISTENT WITH THE SIGNAL MOUNTAIN LAND USE PLAN.

WHEREAS, on December 31, 2012, the parcels within and certain properties adjacent to Windtree Subdivision were effectively annexed into the Town of Signal Mountain by agreement following litigation; and,

WHEREAS, in accordance with the advertised Plan of Services, the Town of Signal Mountain Planning Commission held a public hearing on March 7, 2013, which resulted in a recommendation to zone said properties Low Density Residential District within the Town; and,

WHEREAS, a staff recommendation was provided at that public hearing recommending this rezoning request and the Town Planning Commission found this zoning recommendation to be consistent with the Town of Signal Mountain Land Use Plan;

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF SIGNAL MOUNTAIN, TENNESSEE, THAT:

SECTION 1. The following properties which were annexed into the Town effective December 31, 2012 which are located in and adjacent to Windtree Subdivision are hereby zoned Low Density Residential District within the Town and shall be designated as so zoned on the Town Zoning Map:

After such public hearing has been conducted, this Ordinance shall become effective immediately from and after its Final passage as provided by law and all zoning maps for the Town shall include such property as Low Density Residential District unless otherwise changed by the Town Council in accordance with Tennessee law.
