


### **FARMVIEW EXTENDED DETENTION BASIN RETROFIT-1**



### **FARMVIEW EXTENDED DETENTION BASIN RETROFIT-2**




#### SYCAMORE PARK BIORETENTION SWALE AND RIPARIAN BUFFER RESTORATION

#### FIELDVIEW & TEWKSBURY EXTENDED DETENTION BASIN RETROFITS-2

- 1. Survey & Preliminary Design complete at both basins.
- 2. Both basins need major maintenance to remove accumulated sediment and vegetation. Public Works Dept. has begun with vegetation clearing and is in process of assessing in-house capacity to remove sediment and relieve holding water. Muddy bottom conditions make the work a challenge with existing Public Works equipment.
- 3. Expect to complete detailed design and construction drawings in 2023 pending resolution of maintenance work plan and proposed construction schedule.

#### FIELDVIEW & TEWKSBURY EXTENDED DETENTION BASIN RETROFITS-3

- 4. Will need to make decision on whether work in either basin will be done in-house need to give Public Works time to assess in-house capacity based on outcome of needed maintenance work.
- 5. Ideally, we would:
  - a) complete one project between now and end of 1<sup>st</sup> quarter of 2024.
  - b) complete Sycamore Park in 2024 (likely contracted)
  - complete last project in 2024 or, maximally, we have until end of Summer 2025 to finish PRP projects.
