Traffic Light Update

A Public Meeting was held February 3, 2016 to announce that construction of the long-awaited traffic signal at the intersection of Route 191 with Friedenstahl Avenue and Schoeneck Avenue is scheduled to begin as early as April. If possible, major construction with single lane conditions and detours will be delayed until after school lets out the beginning of June. Construction updates, including anticipated single lane closures and detours will be posted to the Township's website and Facebook page. 2016 Road Program

Surface Treatments comprising of a double application of oil & chip will be applied to the following roads in 2016: Chase Ct.; Rising Sun Ct.; Nathaniel Dr.; White Fence Ln.; Georgetown Rd. Residents are advised that this process will leave loose stones on the road for a period of time before they can be swept up – please drive slowly to avoid damage to your car. This surface treatment is required to limit the development of cracks in the roads that lead to accelerated deterioration of the pavement.

All pavement line striping will be re-painted this year.

Please use caution at the time of painting to avoid crossing the lines just after they have been painted to avoid getting paint splatter on your vehicle. The paint takes about thirty (30) minutes to dry.

Notices will be posted on the Township's website and Facebook page in advance of the road work described above being completed. Please contact the Township office with any questions or concerns.

Let's recycle right!

Food Contaminates our Recyclables

Food and drink in or on our recyclables, gums up and interferes with the recycling machinery and process. Only the <u>clean</u> (no food or grease) part of your pizza boxes (or any other recyclable) should be placed in your recycling cart.

Plastic bags need to be recycled at your grocery store
Plastic bags wrap around and jam recycling equipment, contaminate paper bales, and cause problems at our compost facilities.
They blow off of landfills and wind up in waterways, oceans, and seas. To recycle them, they need to go through a special recycling process that is currently only available through our grocery stores.

Grasscycling - Let your grass clippings lie on your lawn and save time, water, fertilizer, and money

A typical lawn of 2000 square feet generates about 30 lbs. of grass clippings per mowing. Further, they represent from 20 to 50 percent of the solid waste going to landfills in the spring and summer and contribute to landfill gas and leachate production. This risks water and air quality, thereby raising environmental management costs.

PA Act 101 mandates curbside recycling of the following material:

- **CANS**: Aluminum, tin, steel, bimetallic and aerosol cans; formed aluminum containers (such as pie pans). *Rinse items before recycling*. <u>No</u> toxic or flammable materials. No paint cans.
- **GLASS**: Clear, green, and brown food and beverage jars or bottles. *Rinse containers and caps off.* No drinking glasses, window panes, light bulbs, mirrors, ceramic, china, or porcelain.
- **PLASTIC**: Plastic bottles and containers (labeled with numbers # 1-7 on the bottom) and includes soda, water, milk, juice, liquor, shampoo, detergent, condiments, salad dressing, yogurt, margarine, etc. *Rinse caps off. Rinse and place containers in your recycling cart.* No styrofoam, plastic bags, film, or plastic toys.
- **MIXED PAPER**: Office paper, phone books, junk mail, newsprint, catalogs, magazines, corrugated cardboard, and food boxes such as cereal boxes, and gift boxes. *Cut and flatten as needed to release easily from the recycling cart.*

Depending on your hauler you may even be able to recycle food and beverage cartons, such as milk and orange juice cartons, juice boxes, liquid food cartons (i.e. egg substitutes, soups and broths). Remove caps and place in your trash. Rinse and place cartons in your recycling cart.

Listed above are basic recycling guidelines. Please check with your hauler regarding their specific recycling options and rules. Apartments may have different procedures—so check with your landlord or apartment manager.

STREET SWEEPING March 28 - April 8, 2016

Upper Nazareth Township will be cleaning and sweeping the dedicated streets of Upper Nazareth Township from March 28 to April 8, 2016.

The Township requests that you please keep your vehicles, basketball hoops, and other objects off the roads during these weeks.

SPRING CURBSIDE YARD WASTE COLLECTION April 11 - April 15, 2016

The Township will be collecting curbside during the week of April 11-15, 2016. This collection will follow the same collection pattern as the fall leaf collection. Visit the Upper Nazareth Township website www.uppernazarethtownship.org for details.

ACCEPTABLE MATERIALS include: unlimited amounts of yard waste (leaves, branches, twigs, roots, bushes, flowers, house plants, garden clippings) that will be collected curbside and composted instead of placed in a landfill. Place your yard waste in a clean open-top container. **** NO PLASTIC BAGS *****. Branches must be tied with cotton or hemp twine in bundles no larger than 12' x 12' x 6', and weighing no more than 40lbs. Leaves must be bagged separately in compostable bags. (Available at various hardware and grocery stores)

UNACCEPTABLE MATERIALS will not be collected and include: grass clippings, tree stumps, loose soils, sod, food waste, plastics and synthetic fibers, lumber, any wood or tree limbs over 4" diameter; human or animal excrement, soil contaminated with hazardous substances, plastic bags, plastic pots, rocks, litter, trash or glass.

YARD WASTE COLLECTION FACILITY Saturday, April 16, 2016

The yard waste collection site at 155 Friedenstahl Avenue will be open on Saturdays from 10:00 a.m. until 2:00 p.m. and Wednesdays from 12:00 noon until 6:00 p.m. beginning Saturday, April 16, 2016. The facility is for **RESIDENTS** only. (proof of residency is required)

Please separate your leaves from your yard waste.

Branches must be limited to four (4) inches in diameter.

There is an area to drop off scrap metal.

UNACCEPTABLE MATERIALS: grass clippings, tree stumps, loose soils, sod, food waste, plastics and synthetic fibers, lumber, any wood or tree limbs over 4" diameter; human or animal excrement, soil contaminated with hazardous substances, plastic bags, plastic pots, rocks, litter, trash or glass.

THE YARD WASTE FACILITY IS <u>NOT</u> FOR COMMERCIAL USE AND WILL BE SUPERVISED.

FIRE DEPARTMENT

The Upper Nazareth Fire Dept. has had a very busy year of training since the last newsletter. Some of the training achieved was (6) Firefighters certified in Advance Rapid Intervention Teams (RIT) at Bucks County Community College which trains firefighters to rapidly ascend on firefighters that may be down or trapped in a building. We also had (3) of our fire officers attend Fire Investigations training at Northampton Community College. (5) Firefighters certified in truck ops from Bucks County Community College, which is ladders and aerial operations. (5) Firefighters certified in Firefighter Survival attended at Monroe County Department of Emergency Services. We also sent (18) Firefighters to a flashover simulator at Pike County Pennsylvania Dept. of Emergency Services. This flashover training gives Firefighters signs to watch for in a fire and detect a potential life threatening situation early to prevent a flashover explosion in a fire.

As spring is here we felt the need to advance our firefighting team with wildland firefighting. We are happy to report that one of our firefighters attended and successfully received Fire Warden status from the Pennsylvania Department of Conservation and Natural Resources (DCNR) and 18 firefighters are certified in PA-130 and PA-190 wildland firefighting. With this certification Upper Nazareth Fire Dept. is recognized by DCNR District 17 as an active response team to wildland fires. We are happy to report that we secured a \$7500.00 DCNR grant to be used to outfit 23 firefighters in wildland fire protective equipment. The listed training is just a spotlight of the many hours we train including each Monday night and other courses too long to list in this newsletter.

Why do we do all this training as a Volunteer Fire Dept.? The answer is simple. We as Firefighters have a Brother-hood and Sisterhood bond. To protect our family, the citizens of Upper Nazareth Township, and anyone who frequents the township. To be ready and prepared when an emergency strikes. To achieve this we must move forward with continued education and have a very diverse set of training to handle any Emergency that we may face. As our slogan states on our fire trucks "WE ALL GO HOME"
