RECYCLING

Residential Recycling - Place These Items in Your Recycling Cart

PA Act 101 requires residents to recycle the following materials:



- CANS: Aluminum, tin, steel, bimetallic and aerosol cans; formed aluminum containers (such as pie pans). Rinse. No toxic or flammable materials. No paint cans.
 - GLASS: Clear, green, and brown food and beverage jars and bottles. Remove and discard lids. No drinking glasses, window panes, light bulbs, mirrors, ceramic, china, or porcelain.





- PLASTIC: Plastic bottles and containers (labeled with numbers #1-7 on the bottom) and includes soda, water, milk, juice, liquor, shampoo, detergent, condiments, salad dressing, yogurt, margarine, etc. Please rinse and crush. Remove and discard caps. No Styrofoam, plastic bags of any kind, shipping or packing plastic, or rigid plastics. PLASTIC GROCERY BAGS CAN ONLY BE RECYCLED AT YOUR GROCERY STORE.
 - MIXED PAPER: office paper, phone books, junk mail, newsprint, magazines, corrugated cardboard, and food boxes such as cereal boxes, and gift boxes. Cut and flatten as needed. NO FOOD CONTAMINATED ITEMS.



Commercial Recycling - What You Need to Know

The Law

The Municipal Waste Planning, Recycling and Waste Reduction Act of 1988 (Act 101) requires commercial, institutional, and municipal establishments located in Pennsylvania's mandated municipalities to recycle paper, cardboard, newsprint, plastics, steel, aluminum, and bimetallic cans, glass, and yard and leaf waste depending on the materials generated by your business.

Annual Required Recycling Reporting

The State requires all commercial, institutional and municipal entities to provide written documentation as to the type and weight of materials recycled annually. Reporting forms are mailed to businesses in December. Completed reports and supporting documentation are due to Upper Nazareth Township by January 30th every year.

STREET SWEEPING

April 3 - April 7, 2017

Upper Nazareth Township will be cleaning and sweeping the dedicated streets of Upper Nazareth Township from April 3 to April 7, 2017.

The Township requests that you please keep your vehicles, basketball hoops, and other objects off the roads during these weeks.

SPRING CURBSIDE YARD WASTE COLLECTION

April 17 - April 21, 2017

The Township will be collecting curbside during the week of April 17-21, 2017. This collection will follow the same collection pattern as the fall leaf collection. Visit the Upper Nazareth Township website www.uppernazarethtownship.org for details.

ACCEPTABLE MATERIALS include: unlimited amounts of yard waste (leaves, branches, twigs, roots, bushes, flowers, house plants, garden clippings) that will be collected curbside and composted instead of placed in a landfill. Place your yard waste in a clean open-top container. **** NO PLASTIC BAGS ****. Branches must be tied with cotton or hemp twine in bundles no larger than 12' x 12' x 6', and weighing no more than 40lbs. Leaves must be bagged separately in compostable bags. (Available at various hardware and grocery stores)

UNACCEPTABLE MATERIALS will not be collected and include: grass clippings, tree stumps, loose soils, sod, food waste, plastics and synthetic fibers, lumber, any wood or tree limbs over 4" diameter; human or animal excrement, soil contaminated with hazardous substances, plastic bags, plastic pots, rocks, litter, trash or glass.

YARD WASTE COLLECTION FACILITY

Saturday, April 22, 2017

The yard waste collection site at 155 Friedenstahl Avenue will be open on Saturdays from 10:00 a.m. until 2:00 p.m. and Wednesdays from 12:00 noon until 6:00 p.m. beginning Saturday, April 22, 2017. The facility is for **RESIDENTS** only. (proof of residency is required)

Please separate your leaves from your yard waste.

Branches must be limited to four (4) inches in diameter.

There is an area to drop off scrap metal.

UNACCEPTABLE MATERIALS: grass clippings, tree stumps, loose soils, sod, food waste, plastics and synthetic fibers, lumber, any wood or tree limbs over 4" diameter; human or animal excrement, soil contaminated with hazardous substances, plastic bags, plastic pots, rocks, litter, trash or glass.

THE YARD WASTE FACILITY IS NOT FOR COMMERCIAL USE AND WILL BE SUPERVISED.

Phone messages are returned as soon as possible – even on weekends.

The final day to pay your Upper Nazareth Township Real Estate Tax Bill is Thursday, December 14, 2017. All unpaid bills after that date will be sent to Northampton County Tax Claim for collection.

ZONING

Please contact the Township Office for permit information. Any projects such as *decks*, *sheds*, *patios*, *pools*, *patio roofs*, *additions*, *basements*, *remodels*, *electrical and generators do require a permit*.

<u>Moving Permits</u> are required when a person/persons, firm or corporation moves into, within or out of Upper Nazareth Township.

<u>All Businesses</u> are required to register with Upper Nazareth Township.

POLICE DEPARTMENT

UPPER NAZARETH TOWNSHIP POLICE DEPARTMENT HAPPENINGS!

Upper Nazareth Township has a new Police Chief. Sergeant-William Cope was promoted to Chief after a year long interim position, after the retirement of Police Chief Alan Siegfried. Alan Siegfried held the position as Chief since 1996. Chief Cope has been a member of the Upper Nazareth Township Police Department for 12 years. Since Chief Cope has been in the position of Chief he has brought many new ideas and changes to the department. "Congratulations to Chief Siegfried on his retirement and to Chief Cope on the promotion!"

Police vehicles are one of the most expensive pieces of equipment the Upper Nazareth Township Police Department utilizes. A new vehicle costs about \$40,000 fully outfitted and they normally have a lifespan of about 100,000 miles. On December 14, 2016, we took possession of two 2012 Dodge Chargers for \$9,500.00 each. They came completely outfitted and ready to be deployed. They have been deployed around the Township to help with the enforcement of traffic and to help offset the cost of purchasing a new vehicle every year.

The Upper Nazareth Township Police Department is a very proactive Department participating in several Highway Safety Programs: Aggressive Driving, Seatbelt (Click it or Ticket), and DUI Checkpoints are just a few programs we are involved in. Over the next few months the department will be busy participating in several of these programs and you may notice officers on traffic stops more frequently. Please be vigilant when passing our officers and know that we are out there making travel safer in our Township.
