The User agrees to comply with all Township regulations, **Code of Ordinances, Chapter 16, Township Park and Recreation Policy No. 23-01** and the following rules:

- A. No alcoholic beverages
- B. No littering or property damage
- C. No concessions of any kind shall be sold without obtaining permission from Upper Nazareth Township Board of Supervisors
- D. Animals are prohibited including the running of dogs
- E. The parking of vehicles is prohibited in areas other than the designated parking lots
- F. Use of the athletic field(s)/court for anything other than their designed purpose shall first be approved by the Township
- G. The pavilion, picnic tables and surrounding area will be maintained in good condition before, during, and after utilization
- H. A Use Agreement shall be required and the approved Use Agreement must be with the User at all times while utilizing the park
- I. Proof of insurance is required
