- Mr. Brown There were long sessions reviewing the budget to be fiscally responsible. Thank you Mayor, Administration and Department Heads for your work on the budget. ♦ Thank you Lisa Collins, Public Works, the Police Department, Fire Department and everyone who made the 4th of July Parade a success! ♦ The Library will be having its annual Truck Night on July 31st at 6:30 PM. Come out to see fire trucks and rescue vehicles. ♦ World War II Veteran Andrew "Tim" Kiniry will be at the library on August 10th at 1:00 PM to speak about his experience during the war.
- Mayor Burns Thank you Colette, Jim, Joe and everyone involved in the budget process. ♦ National Night Out is Tuesday, August 6th from 6:00 9:00 PM in Washington Lake Park. ♦ The 4th of July Parade and Fireworks were a success! ♦ Councilmen Bennett, Brown and DellaPia, along with the Veterans Advisory Board, unveiled a reserved parking spot for Veterans. There are 7 total one at the Municipal Building, the Library, Dog Park, Senior Center and four spaces in the Park.
- Mr. Del Borrello Apologized for being late. ◈ We have been "Working in Your Shoes" where we work at your business to learn about your business to better serve you. He, along with the Mayor, worked with Dayna's Party Rental over the weekend. Tomorrow they are working at Stio's Water Ice and there is more to come. ◈ All candidates running for office in Washington Township have agreed to sign the Pledge to stop the negativity in campaigns. Things may seem gloomy but we are turning things around. ◈ Great things are happening on the Black Horse Pike and Delsea Drive. We are working on projects that don't cost the taxpayers money by utilizing grants. We are working hard for you!
- Mr. DellaPia The 4th of July Parade was a success! Thank you Chief Gurcsik and Chief Dolgos and their departments for everything they did for the parade. Three McDonald's restaurants in the area volunteered to help fundraise for Jake's Playground and will donate 15% of all sales tonight and next Wednesday. Thank you! The Police Department's Junior Police Academy was last week. Our town offers a lot of activities for kids. Check the website for more information. Thank you Barb for filling in tonight and continued healing to Chrissy. The cost to run the town including trash, salary and benefits has increased \$10 million over eight years; however, taxes were only raised 1 cent until last year. No business or household could operate without increasing cash flow. We had to make hard decisions but were able to balance the budget by only raising taxes half of the cost to run the town. Due to the excessive heat, Taco Palooza has been rescheduled to Sunday,

August 4th beginning at 11:00 Am in Washington Lake Park. Join us for the best fiesta of the summer and enjoy tacos, beer, sangria, music and more. National Night Out is August 6th beginning at 6:00 PM in Washington Lake Park. We encourage all residents to come be a part of this free national event promoting neighborhood and police-community partnerships for a safer nation. Please join us for movies and music in the park. More information can be found on the website. Summer hours for the Municipal Complex are in effect. We are closed every Friday until Labor Day.

PUBLIC PARTICIPATION

Mr. DellaPia asked for a motion to open the meeting to the public. Mr. Bennett motioned. Mr. Yerkes seconded the motion, which was unanimously approved by the members present.

■ **Robert Davis, 72 Saddlebrook Drive** – Suggested that Mayor and Council let the community know that the new trash company starts on August 1st and to be patient during the transition.

Mayor Burns stated that a social media post is scheduled for tomorrow.

Mr. Bennett and Mr. DellaPia note that there may be some issues in the beginning. Contact Public Works if you have any problems.

■ Susan Veasy, 209 Lake Avenue – Does not like the appearance of Grenloch Park and would like a community clean up day. She also would like the docks be replaced with Trex decking.

Mr. DellaPia noted the next Council meeting is August 14th.

Mr. Bennett noted that Clean Communities can clean up Grenloch Park.

Mr. Del Borrello invited Ms. Veasy to attend their Tuesday meeting.

• Maria Harb, Saddlebrook, 43 Saddlebrook Drive – The residents were cutting and maintaining the open space area but received a letter not to and it is now overgrown. She would like the Township to higher a contractor to maintain the area. She has not received a response from the Zoning Department.

Mr. Russo will have Public Works go out and tend to the area. We are going to do the work and ten lien the property.

Ms. Harb inquired about Resolution 211 regarding the public auction.

Mr. Russo noted that the Township is selling old vehicles and equipment. Information regarding the auction can be found on JJ Kane's website.

• Michael McCloskey, Saddlebrook, 41 Saddlebrook Drive – Would like an update on the open space issue at Block 17.11 Lot 51. The neighbors have been cutting the area for 25 years. Zoning stated the area would be cut but it still has not. When will it be cut? It would save the Township money if the residents maintained the area. He would like a copy of the survey and analysis of the trees that was completed.

Mr. Wright noted the case is in litigation and an answer was filed by the Township. As far as maintaining the area, the Township does not condone trespassing. Records can be requested through OPRA; however, if it is part of litigation, it will not be provided at this time.

Mr. Russo stated that Public Works and Zoning Officer Jay Morgan will go out and assess the area.

■ Zachary Abrams, 27 Auriga Lane – He understands the budget and the whole country is affected by the economy. He would like residents to be able to offer their services and receive a tax break. He is not happy that the skate park was eliminated. He is an electrician and owns a snowboard company. He would like to get involved as a volunteer.

Mr. Del Borrello would like to get together with Mr. Abrams to discuss his journey and his ideas.

Mr. Brown noted that the Fire Department is always looking for volunteers.

Mr. DellaPia asked for a motion to close the meeting to the public. Mr. Bennett motioned. Mr. Brown seconded the motion, which was unanimously approved by the members present.
