**RESOLUTION AWARDING A BID TO TOP DOG MAINTENANCE INC.

WHEREAS, advertisement for bids for the provision of 2019 Property Maintenance Services was duly published in the South Jersey Times; and

WHEREAS, bids were received and opened on March 7, 2019 at 10:00 A.M.; and

WHEREAS, the bid proposal of Top Dog Maintenance, Inc., 3017 Delsea Drive, PO Box 158, Franklinville, NJ 08322, in the amount of **\$40.00** for lawn care not to exceed 1 acre is the lowest responsible bidder for the 2019 Property Maintenance Services; and

WHEREAS, additional costs if needed of \$25.00 per man hour for other property Maintenance; and

WHEREAS, additional cost if needed of \$26.00 per cubic dumpster usage; and

WHEREAS, the award of the bid in the manner set forth above is necessary for the efficient operation of the Township of Washington.

WHEREAS, the maximum amount of the contract is \$ 15,000.00; and

BE IT RESOLVED by the Township of Washington as followings:

1. Top Dog Maintenance, Inc., 3017 Delsea Drive, PO Box 158, Franklinville, NJ 08322 is determined to be the lowest responsible bidder for 2019 Property Maintenance Services
2. The Mayor of the Township of Washington is hereby authorized to execute a contract with Top Dog Maintenance, Inc. in a form approved by the Solicitor of the Township of Washington.
3. The Chief Financial Officer's certification that funds are available attached hereto.

NOW, THEREFORE, BE IT FURTHER RESOLVED by the Council of the Township of Washington, in the County of Gloucester and State of New Jersey in accordance with the Local Public Contracts Law, N.J.SA 40A:11-1 et seq, the contract is awarded to Top Dog Maintenance, Inc.




