A NOTE FROM MAYOR ANDY GARDNER:

FIRST ENERGY UPDATE:

I AM PLEASED TO REPORT THAT CITY REPRESENTATIVES AND FIRSTENERGEY REPRESENTATIVES MET ON FRIDAY, JULY 9. THE FOLLOWING REPORT IS A SUMMARY OF THIS MEETING AND PROVIDES SOME HOPEFUL SOLUTIONS WITH FUTURE POWER OUTAGES:

On Friday, July 9th, representatives of the City met with Wendy Zele, FirstEnergy's Regional External Affairs Consultant for the City of Willoughby Hills to continue our discussions regarding power outages in the City, particularly the recent power outages on the East side of the City following weather events.

During the meeting, the City and FirstEnergy reviewed:

- the causes of outages during 2020 and 2021 to date,
- FirstEnergy's preventative maintenance procedures in the City, and
- what FirstEnergy and the City and its residents can do to attempt to minimize future outages.

Almost all of the significant outages in the City during 2020 and 2021 have been the result of storms damaging trees outside of the FirstEnergy right of way that fall and then break or damage distribution equipment, wires and poles within the FirstEnergy right of way. Of eight outages, all but three were caused by damage resulting from trees falling from outside the FirstEnergy right of way.

FirstEnergy has been diligently working to curtail these outages. Since February of 2020, FirstEnergy has completed the following upgrades and preventative maintenance actions in Willoughby Hills:

- (i) a full Circuit Patrol (where they physically walk the feed) (February 2020),
- (ii) a forestry patrol and tree trimming of all electric rights of way in the City (FirstEnergy's right of way is 10' on either side of their distribution lines, which are typically the highest set of lines on the utility poles, with cable, telephone and other communication lines lower on the poles) (July 2020),
- (iii) Public Utilities Company of Ohio (PUCO) required pole inspections throughout the City (August 2020), and
- (iv) additional forestry patrols and tree trimming on the East side of the City, at the request of City representatives.

What FirstEnergy is doing to help:

- (i) <u>Continued Monitoring of Performance</u>. FirstEnergy will continue monitoring their network performance and reliability to look for potential improvements (especially during the high demand summer months).
- (ii) <u>Helping Educate Residents</u>. FirstEnergy is providing its Vegetation Guidelines to help residents understand which trees are in the right of way and which are outside the right of way so that residents can help prevent trees/branches falling and causing outages.
- (iii) <u>Additional Forestry Patrols</u>. At the request of City officials, FirstEnergy is asking their forestry contractor to check several areas in the City where there may be additional trimming needed in their right of way (Chardon Road, River Road and Hanna Road areas).
- (iv) <u>Installation of new Transformer</u>. FirstEnergy is installing a new transformer at their substation that will help with reliability in the City.
- (v) <u>Evaluating installation of additional re-routing equipment.</u> FirstEnergy will be evaluating the feasibility of installing equipment that will re-route power in the event of outages to minimize the number of customers/residents affected by the outage.
- (vi) <u>Continue Communication with the City</u>. FirstEnergy is committed to continue to work with the City to evaluate the effectiveness of these steps and make future improvements to their distribution grid as needed.

What Residents can do to help:

- (i) Report all outages directly to FirstEnergy at 1-888-544-4877. **Do not call City Hall or 911!** FirstEnergy tracks this data to investigate if additional upgrades are necessary.
- (ii) Review the Vegetation Guidelines and exercise as much preventative maintenance as possible with any dead, rotting or other trees that may threaten to fall and hit FirstEnergy equipment, wires or poles during violent winds or following heavy snow. The line coming from the right of way across your property to your home is the responsibility of the homeowner, not FirstEnergy. The Vegetation Guidelines provide a list of contractors that can safely work near power lines.
- (iii) Advise the City (440-975-3550) and FirstEnergy of any trees that appear to be threatening FirstEnergy equipment, wires or poles.
- (iv) For seniors or residents in need of electricity for medical purposes, the resident may want to consider the purchase of a generator and/or battery back up to assist when power outages interrupt the service of medical equipment or basement sump pumps. Also, those individuals who have large freezers for food storage may also choose to consider this option.

Finally, if you leave your home (or let your pets out) during an outage, especially at night, <u>remember to exercise appropriate caution</u>. Power lines can be difficult to see, especially at night and can be tangled up in downed foliage. If a tree is down near power lines, avoid the area until you can safely see and identify the location of the power line. If you see a downed power line, stay clear of the line and anything that it may be in contact with (including any large puddles, saturated ground, fences other structures, trees or vehicles) and call 911 to report the hazard.

Also, please do not call 911 regarding the length of power outages, only FirstEnergy will be able to provide that information.

We will continue to keep residents apprised as we work with FirstEnergy for improvement.

ROAD WORK UPDATE:

Our road work is nearing completion on Meadowbrook Drive, Alan Drive and Diana Court. It is a great improvement to our community.

CHARTER REVIEW COMMISSION'S PROPOSED CHARTER AMENDMENTS:

ON JULY 8, 2021, THE CHARTER REVIEW COMMISSION PRESENTS NINE PROPOSED CHARTER AMENDMENTS TO CITY COUNCIL. BY CHARTER, COUNCIL CANNOT ALTER THEIR REQUESTS IN ANY WAY, BUT MUST APPROVE SENDING THEIR SUGGESTIONS TO THE BALLOT. THE COMMISSION WILL HOLD A PUBLIC FORUM TO REVIEW THESE CHANGES AT A COMMUNITY CENTER MEETING SET FOR WEDNESDAY, OCTOBER 13, 2021 AT 7:00 P.M.

HERE IS A RECAP OF THEIR CHANGES. PLEASE ATTEND THE UPCOMING MEETING TO LEARN MORE.

PROPOSED AMENDMENT #1 – ARTICLE 1 THE MUNICIPALITY – SECTION 1.5 INDEMNIFICATION:

INTENT: THAT PUBLIC OFFICIALS, EMPLOYEES, VOLUNTEERS, AGENTS AND REPRESENTATIVES OF THE CITY, WHILE ACTING FOR THE CITY SHOULD BE PROTECTED BY AN INDEMNIFICATION CLAUSE, AS CURRENTLY PROVIDED IN ORDINANCE 2020-66. WHEN PLACED IN THE CHARTER, IT MAY NOT BE REVOKED BY COUNCIL WITHOUT A VOTE OF THE PEOPLE.

PROPOSED AMENDMENT #2 – THE MAYOR – DUTIES AND RESPONSIBILITIES, SECTION 2.2:

INTENT: CLARIFYING THAT THE MAYOR'S ABILITY TO CONTROL THE EMPLOYMENT STATUS SHOULD BE LIMITED TO THOSE UNDER HIS SUPERVISION. (THIS IS SUBMITTED TO CLARIFY THAT THE MAYOR IS THE ADMINISTRATOR OF ALL CITY EMPLOYEES, BUT NOT COUNCIL).

PROPOSED AMENDMENT #3 - THE MAYOR - ANNUAL BUDGET, SECTION 2.24:

INTENT: INCREASES THE NUMBER OF DAYS FROM 30 TO 60 FOR THE MAYOR TO SUBMIT THE ANNUAL BUDGET TO COUNCIL PRIOR TO THE DEADLINE FOR THE BUDGET CERTIFICATION.

PROPOSED AMENDMENT #4 – THE COUNCIL – ORGANIZATION, SECTION 3.2

INTENT: ENSURES THAT IF A COUNCIL MEMBER LOSES AN ELECTION, RESIGNS OR IS REMOVED FROM COUNCIL, THE MEMBER WOULD NOT BE ABLE TO BE APPOINTED TO A DIFFERENT VACANT COUNCIL SEAT FOR AT LEAST 180 DAYS FROM THEIR LAST DAY IN OFFICE.

PROPOSED AMENDMENT #5 — CIVIL SERVICE COMMISSION — DUTIES/RESPONSIBILITIES, SECTION 5.52

INTENT: REMOVES THE DUTY OF CIVIL SERVICE COMMISSION REVIEWING NEW EMPLOYEE CREDENTIALS OF UNCLASSIFIED POSITIONS, ONLY PERMITTING THEM TO REVIEW CLASSIFIED (FULL-TIME POLICE AND FULL-TIME FIRE EMPLOYEES, EXCEPT THE CHIEFS) POSITIONS.

PROPOSED AMENDMENT #6 — ELECTORATE — POWERS OF THE ELECTORATE, SECTION 8.2

INTENT: INCREASES THE NUMBER OF VALID SIGNATURES ON A PETITION FOR A MAYORAL CANDIDATE: AT LEAST 1% FOR COUNCIL MEMBERS AND AT LEAST 4% FOR MAYORAL CANDIDATES OF THE NUMBER OF ELECTORS VOTING IN THE LAST GENERAL ELECTION.

PROPOSED AMENDMENT #7 - ELECTORATE - POWERS OF THE ELECTORATE, SECTION 8.2

INTENT: DECREASES THE NUMBER OF SIGNATURES NEEDED FOR RECALL OF AN ELECTED OFFICIAL FOUND GUILTY OF MISFEASANCE, MALFEASANCE OR NONFEASANCE IN OFFICE TO 20% OF NUMBER OF ELECTORS VOTING IN THE LAST GENERAL ELECTION.

PROPOSED AMENDMENT #8 — ELECTORATE — PROCEDURES, SECTION 8.3

INTENT: REMOVES THE REQUIREMENT FOR A MAYORAL CANDIDATE TO RECEIVE A MAJORITY SO THAT A RUNOFF IS NOT NECESSARY.

PROPOSED AMENDMENT #9 - PERSONNEL - REMOVAL FROM OFFICE, SECTION 9.3

INTENT: CLARIFIES THAT THE MAYOR IS THE ADMINISTRATOR OF ALL CITY EMPLOYEES, BUT HE IS NOT THE ADMINISTRATOR OF COUNCIL.


