#### **MAYOR GARDNER'S REPORT:**

Our First Energy meeting held on September 13 was very productive. There are a few items we are waiting to hear back from First Energy on and then will convey a complete report to our residents in the September 24 newsletter. Please be assured that the City continues to maintain open communication with First Energy to resolve resident concerns related to power outages.

The Service Department completed a stormwater project on River Road, at the Eddy Road intersection. This was completed by way of Lake County Stormwater Project funds. The Service Department did a fine job on this difficult project that will help with stormwater issues in that area. Thanks to all of the motorists who gave our Service Department the road clearance they needed to get the job done.

Don't forget that Touch A Truck is set for Saturday, Sept. 18. A small parade will lead the way down Chardon Road to the City Hall complex where the festivities are planned. Attendees can view the trucks and have fun at the various booths from 10am to 2pm.

The City continues to follow the guidelines set by the Governor of Ohio regarding mask mandates. At the present time, if you have been vaccinated, masks in City facilities are not mandatory; however, if you have not been vaccinated, we ask that you wear a mask when entering a City building. #### PROPOSED AMENDMENT #5 – ARTICLE 5.5-Civil Service Commission Subsection 5.52 Duties & Responsibilities

Charter Review Commission prepared Amendment #5 with the following intent: The 2021 CRC voted to recommend that the Civil Service Commission be required to review and confirm only the credentials of the "classified" employee candidates. This is in accordance with ORC 124.40 where the State of Ohio defines Civil Service Commission as responsible for specific tasks related to the "classified" positions. Our "classified" positions include the full-time members of the police and fire departments, except for the Police and Fire Chiefs. Everyone else is "unclassified." It is the duty of the Mayor to hire employees which includes ensuring that "unclassified" employees' credentials are properly reviewed and confirmed.

#### What will change in the Charter then, if this amendment is adopted by the voters?

In Section 5.52 Duties & Responsibilities, the word "classified" would be added in the second paragraph to indicate that only "classified" employees shall be reviewed by the Civil Service Commission. This would take away the responsibility of the City's Civil Service Commission of verifying the credentials of all applicants who are not full-time Police or Fire employees (except the Chiefs). The Civil Service Commission (a group of 3 volunteers appointed by the Mayor) has a process in place for verification of credentials following a history of previous issues. This work would (if adopted) be turned over to the Mayor and the Department Directors/Supervisors and the volunteers would not be used to continue this task.

A majority affirmative vote is necessary for passage.

Shall Article V, Sub-Section 3.52 – Duties and Responsibilities of Section 5.5 – CIVIL SERVICE COMMISSION of the Charter of Willoughby Hills be amended to limit the Commission's review and confirmation of credentials in a candidate's application for employment by the Municipality to classified employment positions only?"
