### PROPOSED AMENDMENT #6 – ARTICLE VIII-The Electorate Subsection 8.2 POWERS OF THE ELECTORATE

Charter Review Commission prepared Amendment #6 with the following intent: The 2021 CRC voted to recommend increasing the number of valid signatures on a petition for a mayoral candidate to appear on the ballot, and to clarify the election used to determine the number of signatures needed.

What will change in the Charter then, if this amendment is adopted by the voters?

In Section 8.21 Nominations, the current final line in this Section will be deleted (The required percentage shall be at lease one percent (1%) but not less than twenty-five (25) signatures). It will be replaced with "The required percentage shall be at least one percent (1%) for Council Member candidates and at least four percent (4%) for Mayoral candidates of the number of electors voting in the last general Municipal election.

How many electors voted in the last general Municipal election? 5,580 This means the percentages for Council and Mayor candidates in raw numbers would be: 56 for Council and 223 for Mayor.

## THIS IS HOW THE PROPOSED AMENDMENT WILL APPEAR ON THE BALLOT: ISSUE #8

### "PROPOSED CHARTER AMENDMENT- #6

A majority affirmative vote is necessary for passage.

"Shall Article VIII – Sub-8.r21 - Nominations of the Charter of the Willoughby Hills be amended to <u>remove</u> <u>the nominating petition minimum requirement of twenty-five signatures and</u> require individual nominating petitions for Municipal elective office to require at least one percent (1%) for Council Member candidate and least four percent (4%) for Mayoral candidates of the number of electors voting in the last general Municipal election, and remove the minimum requirement of twenty-five signatures?"



#### FIRST ENERGY UPDATE REPORT FROM MAYOR ANDY GARDNER:

THE CITY MET WITH OUR FIRSTENERGY REPRESENTATIVE AGAIN ON MONDAY SEPTEMBER 13 TO CONTINUE DISCUSSING WAYS THAT THE CITY AND CEI CAN CONTINUE TO WORK TOGETHER TO REDUCE THE NUMBER OF POWER OUTAGES EFFECTING THE CITY (AND THE DURATION OF ANY POWER OUTAGES THAT OCCUR).

### HERE ARE SOME KEY TAKEAWAYS FROM OUR MEETING:

- 1. AS I HAVE NOTED IN THE PAST, THE MAJORITY OF OUR EXTENDED OUTAGES ARE CAUSED BY TREES ON PRIVATE PROPERTY FALLING AND DAMAGING WIRES WITHIN THE CEI RIGHT OF WAY. IN MANY CASES, THE TREES ARE HEALTHY TREES FELLED BY THE VIOLENT WEATHER WHERE IT WOULD BE IMPOSSIBLE FOR ANYONE TO PREDICT THAT THE TREE WOULD CAUSE THE OUTAGE. OUR CITY IS NOT ALONE IN THESE OUTAGES, FOLLOWING THE STORM ON AUGUST 11TH, THERE WERE OVER 140,000 CUSTOMERS WITHOUT POWER.
- 2. THE NEW TRANSFORMER HAS BEEN INSTALLED AND IS OPERATING AT THE NEWPORT SUBSTATION, WHICH SERVES THE EASTERN END OF THE CITY. THIS REPRESENTS A SIGNIFICANT INVESTMENT BY CEI IN THEIR INFRASTRUCTURE AND SHOULD IMPROVE RELIABILITY FOR NONDAMAGE RELATED OUTAGES.
- 3. CEI IS IMPLEMENTING A NEW PROGRAM TO PROVIDE NOTICE TO CUSTOMERS TO ADVISE THEM OF THE CAUSE OF ANY FOR NON-DAMAGE RELATED OUTAGES. RESIDENTS SHOULD MAKE SURE CEI HAS AN UPDATED CONTACT NUMBER SO THESE MESSAGES CAN BE PASSED ALONG. ALSO, DURING OUTAGES, USE YOUR MOBILE DEVICE TO CHECK OUT CEI FACEBOOK PAGE AND THE CITY'S FACEBOOK PAGE AS CITY WILL PASS-ALONG MESSAGES.
- 4. AT THE CITY'S REQUEST, CEI IS CONTINUING TO REVIEW POTENTIAL UPGRADES TO THEIR INFRASTRUCTURE TO REDUCE THE NUMBER OF RESIDENTS/CUSTOMERS EFFECTED BY OUTAGES OR THE DURATION OF ANY OUTAGES (INCLUDING DAMAGE RELATED OUTAGES). AT THIS POINT, OTHER THAN THE NEWPORT TRANSFORMER, CEI HAS NOT IDENTIFIED ANY IMPROVEMENTS THAT THEY BELIEVE ARE FEASIBLE; HOWEVER, THE CITY WILL CONTINUE TO STRONGLY ADVOCATE FOR CEI TO MAKE IMPROVEMENTS TO THEIR FACILITIES.

- 5. THERE WILL BE A FORESTRY PATROL NEXT YEAR FOR THE AREAS SERVED BY THE LEO SUBSTATION (THE SUBSTATION AT THE INTERSECTION OF ROCKEFELLER ROAD AND EDDY). THEY WILL CONTINUE TO WORK WITH THE CITY TO ADDRESS FORESTRY ISSUES THE RIGHT OF WAY THAT THREATEN THEIR LINES.
- 6. WE HAVE DISCUSSED AND WILL IMPLEMENT STEPS TO IMPROVE STORM RECOVERY EFFORTS TO ALLOW OUR SERVICE DEPARTMENT TO CLEAR OBSTRUCTIONS IN THE ROADS FASTER AFTER STORMS.
- 7. WE ARE WORKING TO BETTER INFORM OUR RESIDENTS AND CUSTOMERS OF THE STEPS THAT ARE REQUIRED TO SAFELY RESTORE POWER AFTER STORMS. FOR EXAMPLE:
  - a. MANY RESIDENTS REPORT THAT THEY SEE CEI TRUCKS IN THE AREA RIGHT AFTER THE STORM, BUT THE POWER ISN'T RESTORED UNTIL A LATER TIME. IN THOSE CASES, THEY MAY BE COMING TO CONFIRM THAT ANY LINES THAT ARE DAMAGED ARE SHUT DOWN TO ALLOW OUR CREWS TO CLEAR ROADWAYS (AND PREVENT SOMEONE BEING INJURED OR KILLED IF THE DOWNED LINE IS ENERGIZING ANOTHER STRUCTURE OR EVEN THE GROUND). AGAIN, FOR YOUR SAFETY AND THE SAFETY OF THE CITY'S EMPLOYEES, AFTER STORMS, PLEASE KEEP CLEAR OF ANY DAMAGED LINES OR ANYTHING THAT COULD BE IN CONTACT WITH DOWNED LINES.
  - b. YOU MAY SEE A CREW WAITING IN THEIR VEHICLES NEAR A DAMAGED LINE AFTER A STORM. THAT CREW NEEDS TO WAIT FOR CLEARANCE THAT ALL POTENTIAL CONNECTIONS ARE SHUT DOWN AND CONFIRMED SO THAT THEY CAN SAFELY MAKE REPAIRS.
- 8. RESIDENTS SHOULD ALWAYS REPORT OUTAGES AFFECTING THEIR PROPERTY. IT HELPS QUANTIFY THE NUMBER OF CUSTOMERS AFFECTED DURING THE OUTAGE AND TO TRACK WHERE OUTAGES HAVE OCCURRED.
- 9. ANY RESIDENT WITH A SPECIAL MEDICAL NEED SHOULD CONTACT CEI TO MAKE SURE THEY ARE TAGGED IN THEIR SYSTEM AS NEEDING SPECIAL ATTENTION.
- 10.AS FALL IS NOW HERE, PLEASE TAKE SOME TIME TO CHECK AND HAVE REMOVED ANY TREES/BRANCHES THAT ARE ON YOUR PROPERTY THAT MAY THREATEN THE CONNECTION TO YOUR HOME. FOR YOUR SAFETY

AND THE SAFETY OF THE WORKERS, USE ONLY FIRSTENERGY APPROVED CONTRACTORS IF THEY ARE WORKING NEAR YOUR POWER LINES. YOU CAN CALL MY OFFICE AND WE CAN GET YOU A COPY OF CEI'S GUIDELINES.

- 11. LAST MONTH THE CITY COORDINATED WITH KIRTLAND TO REMOVE DEAD TREES WITHIN THE RIGHT OF WAY ON WORRELL ROAD. WE ARE CONTINUING TO WORK TO ADDRESS DEAD TREES WITHIN THE RIGHT OF WAY THROUHOUT THE CITY.
- 12.CEI AND THE CITY ARE BOTH COMMITTED TO CONTINUING OPEN COMMUNICATION TO ADDRESS THESE ISSUES AND WILL MEET AGAIN IN THE LATE FALL.

WE WILL CONTINUE TO KEEP OUR RESIDENTS APPRISED OF UPCOMING DEVELOPMENTS WITH FIRSTENERGY.
