Please practice your right to VOTE NOVEMBER 3RD The Road Levy renewal is the only exclusive Willoughby Hills issue on the ballot.



Whether you choose to "vote by mail", vote at the Board of Elections, or "vote in person," it is important that you review the ballot, which includes a renewal of the City's Road Levy. The issue on the ballot is a 2.5 mil five-year renewal levy which will not increase your taxes. The levy generates \$6.53 per month for each \$100,000.00 of your home's valuation by the County Auditor. These funds are used for the purpose of general construction, reconstruction, resurfacing and repaving of streets, roads and bridges and necessary repairs of road equipment, including our snow plow trucks. Additionally, these funds are used to provide our "local share" of funds in major projects, including the resurfacing of Chardon Road and River Road in the next several years. This year's funds were used to resurface or pay our local share for Evergreen Drive, Beech Hills Drive, Graylock Drive and Rockefeller Road (south of Chardon Road). Last year the funds were used for Dodd Road (local share) and Trailard Drive, Glengate Drive and Mayfriars Road. The Road Levy renewal is the only exclusive Willoughby Hills issue on the ballot.
