#### MAYOR GARDNER'S REPORT

Happy New Year Willoughby Hills!

It was exciting to attend the grand opening of the new Sheetz at the Shoppes of Willoughby Hills this morning. Thanks to Shoppes owner J. Scott Scheel and his team, including Ray Somich, and all of the Sheetz team for bringing this beautiful new store to our City.

This is our 144th electronic newsletter and my last. I hope that this has been a great resource for you and you are able to understand better what is happening in our City. As I mentioned last week, I need to thank many people for their assistance during the last four years.

We are lucky to have a great Law Department. Law Director Mike Lucas, Asst. Law Directors Tom Lobe and Stephanie Landgraf and Prosecutor Mike Kenny have been a joy to work with and have provided high quality legal services and advice to the City as well as wise counsel on many matters to the Mayor's office, City Council and City leadership.

I would like to thank City Engineer Pete DiFranco and Assistant City Engineer Kevin Trepal for their hard work. They have undertaken many significant projects, both planned and unexpected, as our engineers and zoning/building administrators. They have a tough assignment, facing challenges from seemingly never-ending snowfalls or dropping leaves to broken pipes to jammed equipment. Our Finance Department Team of Jeff and Sharen, under the leadership of Finance Director Bruce Scott, make sure that the City's finances are accessible and available to our residents, that the City's funds are carefully administered and properly accounted for, and that our invoices are collected and obligations paid when due. Thanks to Jeff and Sharen for your support and care of these important matters and special thanks to Bruce for his leadership and bringing a new perspective to the office this year.

Thanks to our Safety Forces. It has been a pleasure to get to know all of the members of our Police and Fire Departments and see how hard they work to provide the best possible services to our City. In the Police Department, I am grateful to Chief Chris Collins for his support and advice when I took office. I also am so grateful for the years of service he provided to the City creating a strong foundation for Chief Matt Naegele and Captain Greg Leonbruno. Since taking over for Chief Collins, Chief Naegele has been making his own mark on our Police Department with the addition of new programs and equipment to keep both our officers and residents safer. With the assistance of a dedicated command staff featuring Sgts. Vachet, Cocanower, Boepple and Parmertor and our Department's other veteran leadership, Chief and Capt. Leonbruno have added and trained a talented group of new officers. I am certain that the Police Department will continue to look for new ways to add talent and improve police services in our City for many years.

I am so grateful for the hard work of Chief Gandee, Lieutenants DiMattia, Heller, Serazin and Vencl and the members of our Willoughby Hills Fire Department for their hard work these last four years. Their efforts to respond to and assist everyone during the pandemic should not be forgotten. They adapted to new procedures and new protocols to treat COVID patients and were on the leading edge of vaccinating residents to bring us back to "normal". They also managed the day-to-day EMS calls, accidents, fires, wires down and other service calls that they do so very well. We have managed to upgrade much of their equipment over the last four years and I am looking forward to seeing our new engine in the next few weeks. Like the Police Department, I believe that the sky is the limit for the Fire Department. Chief Gandee and Lieutenant DiMattia have regularly brought new ideas for programs and upgrades to our staff meetings and Lieutenant Vencl's obvious passion for training will bring benefits to our Department for years.



# SENIORS SAY "THANK YOU" TO MAYOR GARDNER

In just a few short days, Mayor Andy Gardner will complete his four-year term as Willoughby Hills' Mayor. The Willoughby Hills Seniors would like to thank him for his service to the seniors, to include some of the following highlights:

- 1) COVID vaccines & booster assistance: Shortly after Mayor Gardner took Office, we were thrust into the COVID-19 pandemic. Mayor Gardner and his Team quickly responded to the call of Lake County to open up the Willoughby Hills Community/Senior Center in order to administer the vaccine to as many Lake County residents as possible. Lake County Health Commissioner Ron Graham sought out Mayor Gardner to put together a site to keep our community safe. With the assistance of our former Acting Fire Chief (& then Lake County Health Department employee) Tom Talcott, the Mayor was able to successfully convert the Community/Senior Center to a vaccination and booster station where many of our seniors travelled to get immunized.
- 2) Partnering with the County to assist with a massive number of vaccines and boosters at Lakeland Community College: Mayor Gardner met with his Firefighter and Administrative teams to review the need to vaccinate the Lake County population in an effort to do so at Lakeland Community College. The plan was to vaccinate approximately six thousand people per day in order to seek prompt resolution of the pandemic vaccination process. The Team was so pleased that the Mayor supported this endeavor. It made for an unforgettable time in their careers when they sat in the Lakeland College Building and could look out onto the campus and see an endless line of individuals line up to get their shots. Buses kept bringing people (many seniors) into the line. Unlike today's world where a line in the supermarket or bank brings out the worst in people, the people waiting to get their vaccines were patient and just happy to have the opportunity here in Lake County to get the vaccine. That was truly unforgettable and we thank Mayor Gardner for allowing us to be a part of that.
- 3) Development of the City E-newsletter for seniors and <u>all</u> residents: It was a constant battle for Mayor Gardner to try to keep residents advised of all of the rules during COVID, taking his lead from Governor DeWine on building rules, closures and social distancing. A new resident to the area mentioned that in her prior city, there was an electronic newsletter which helped get much of the important information disseminated. Mayor Gardner used this approach to begin the weekly E-newsletter, which not only got us through the COVID-19 communication needs, but continues to be a resource for City events. It is the hope of the seniors that, should the need arise for seniors who do NOT have computers or I-phones or a means to travel to City Hall to pick up an extra copy (which is minimal most likely), a paper copy may be mailed to them with the hiring of the City Communications Supervisor. The City E-newsletter has been a good addition to Mayor Gardner's administration and to disseminate the information to as many people (including seniors) as possibly, would certainly allow his tradition to continue long after he leaves office.

- 4) Mind Challenge Participation and Senior Trivia Night: When Mind Challenge representatives Art Greenberg and Phil Levine approached Mayor Gardner about trying to bring seniors out again after COVID, he recognized the challenge but liked the idea (being a trivia buff himself) and a Mind Challenge team was formed consisting of members Mary Melvin, Sandy Falck, Ira Lorber, Gloria Majeski, Michael Kline, Dave & Denise Reichelt and Mayor Gardner. In the three years of participation, the Team has taken home 2<sup>nd</sup> Place, earning \$1500 for the seniors each time. The first \$1500 prize was used to buy a projector so that the City could hold "Senior Trivia Night" once a month to keep in practice for the Mind Challenge competition and to continue to bring the seniors out. Mayor Gardner has assumed the role of "emcee" and we thank him for his interest and commitment to do this for our seniors.
- 5) Rock N Roll Day Tribute to Michael Stanley Gee (now evolved into "Music Fest"): With the passing of our resident Michael Gee (better known as Michael Stanley of Michael Stanley & the Reasonators), Mayor Gardner was gracious enough to allow for a special tribute at the Community Center to honor his life and legacy. Billed as "Rock N Roll Day in Willoughby Hills," it was a successful music event that brought Michael's family, bandmembers and friends, into our beautiful city to dedicate a large shadowbox in his memory, which still remains in our Community Center Lobby. This event has evolved to "Music Fest" and is planned for fall each year by our Recreation Commission.
- 6) Mothers' Day Remembrance: Mayor Gardner wanted to pay tribute to all of the mothers in Willoughby Hills who work so hard to keep the family unit together. His thought was to honor each one with a special "Mother's Day tumbler" and through his efforts, many mothers were the proud recipients of this beautiful gesture. It means a lot to be remembered in this manner and all of the mothers were so appreciative of this beautiful tribute from the Mayor.
- 7) Senior Tax Levy Application: Finally, thank you Mayor Gardner for submitting the Senior Tax Levy Application for our seniors. We will take some space on the next few pages to explain this to seniors and residents who may not understand what this means. We are hoping that this means that by submitting the application to the Lake County Commissioners, the City of Willoughby Hills will now be recognized as a Lake County Senior Center and be afforded the funds to begin the work of providing personnel, facilities and programs for a facility close to home for our seniors to enjoy.

Hopefully, this offers a glimpse of some of Mayor Gardner's accomplishments for our senior population. We appreciate his dedication to our cause! Best wishes as you complete your term as Mayor!



#### INFORMATION ON LAKE COUNTY SENIOR TAX LEVY:

- What is it? The Lake County Senior Levy passed (by voters) in 1992. Formally organized by the Lake County Senior Services Coalition, the 12 participating agencies (a full-time Coordinator was a prerequisite to qualify for this, which Willoughby Hills did not have) agreed to a distribution formula for the funds (made of monies from real estate tax collection), as well as specific uses of these funds by these entities. While the Coalition still exists, the role for allocation of levy funds was replaced in 2013 when the Lake County Commissioners established the Lake County Senior Citizens Advisory Panel. Historically, allocation of levy funds has only been made to the 12 original agencies, but also came to include such agencies as Lake County Council on Aging, Lifeline, RSVP and others. Willoughby Hills residents contributed \$210,509 in 2023 for this endeavor.
- Why didn't Willoughby Hills apply for Senior Tax Levy Funding before? One of the rules was that the entity needed to have a full-time Recreation/Senior Coordinator. Willoughby Hills did not have that. However, three years ago, the rules changed in that a part-time Coordinator was acceptable in order to receive funding. This was most likely due to the COVID-19 pandemic when some of the cities were forced to lay off staff, resulting in the loss of full-time Coordinators. Unfortunately, Willoughby Hills was never notified of this. In 2023, Willoughby Hills Seniors Inc. reached out to the LC Senior Citizens Advisory Panel to find out that they were indeed eligible and an application to participate was sent to Mayor Gardner for completion. He completed the application, requesting \$116,000 to provide for a full-time Recreation/Senior Coordinator and funds for programs and facility upgrades, including the software for client tracking.
- Why should Willoughby Hills get funding? 1) Despite our residents paying into the fund, the City receives nothing for the Senior Center. While it can be said that programs such as Lifeline or Western Reserve Development and others exist, as well as two Senior Centers being close to Willoughby Hills, it is only fair to add that some of the programs are income based, which disqualify many of our residents, and going to the other senior centers means paying more for non-resident membership fees and non-resident program fees. We believe our residents want to stay local.
- Didn't the MCS Consulting Service Survey that was prepared (and paid for) by the Lake County Commissioners on October 16, 2015, identify Willoughby Hills as having the second most (only to non-participating Painesville) age 65+ Black or African American population? Yes, the survey indicated that statistic, along with the fact that by the year 2030, 1 of 3 Lake County residents will be age 60 and over. This is why we need to pay attention to what we are providing for our seniors! The County has used this survey's recommendation to begin to provide the software to track clients served. It also stated that all capital and major equipment expenses should come from the "Contingency Fund" which is part of the Senior Levy, allowing that the Senior Tax Levy be used only for operations. It may be nice to pull this report and start following some of the suggestions to avoid decisions that may seem to be discriminatory or unfair to all of the County's residents. It seemed that Commissioner Regovich was on board with the unity of all seniors when he was recently quoted in the News-Herald, saying "I see people out at the senior centers, socializing, and I worry about those who don't come out." We will give you less to worry about, Commissioner Regovich, if you approve Mayor Gardner's application for Senior Tax Levy Funding!
