## CITY COMMISSION MEETING MINUTES Winfield, Kansas January 22, 2019

The Board of City Commissioners met in regular session, Tuesday, January 22, 2019 at 5:30 p.m. in the City Commission-Community Council Meeting Room, City Hall; Mayor Ronald E. Hutto presiding. Commissioners Phillip R. Jarvis and Gregory N. Thompson were also present. Also in attendance were Brenda Peters, Interim City Manager; Carina Anderson, Deputy City Clerk; and William E. Muret, City Attorney. Other staff members present were Gus Collins, Director of Utilities; Gary Mangus, Assistant to the City Manager; Vincent Warren, Fire Chief; Peter Rowley, Fire Lieutenant/EMT, and Bryan Root, Power Plant Operator I.

Mayor Hutto noted all Commissioners present.

Commissioner Jarvis moved that the minutes of the January 7, 2019 meeting be approved. Commissioner Thompson seconded the motion. With all Commissioners voting aye, motion carried.

Commissioner Thompson moved that the minutes of the January 10, 2019 meeting be approved. Commissioner Jarvis seconded the motion. With all Commissioners voting aye, motion carried.

### **BUSINESS FROM THE FLOOR**

Nick Lawrence from Boy Scout Troop 318 was present to fulfill requirements for Citizenship in the Community.

### **NEW BUSINESS**

**Bill No. 1901** – **A Resolution** – Amending the Personnel Policies and Regulations for the City of Winfield, Kansas. Interim City Manager Peters explained this Resolution would remove the last sentence of Chapter 12 section E, "Employees terminated for gross misconduct shall not be paid their accrued vacation at time of separation." This would mean that anyone terminating with the City would received any accrued vacation. The second change to the Personnel Policies and Regulations would be to introduce a new section which will re-instate the Grievance Policy. Upon motion by Commissioner Jarvis, seconded by Commissioner Thompson all Commissioners voting aye, Bill No. 1901 was adopted and numbered Resolution 0119.

Bill No. 1902 – A Resolution – Authorizing the City of Winfield, Kansas to sell a 65% undivided interest in its electric transmission facilities; approving the execution and delivery of an asset purchase agreement between Gridliance High Plains, LLC and the City; and authorizing the execution and delivery of such other documents as shall be necessary in connection therewith. Director of Utilities Collins explained to the Commissioners this Resolution authorizes the signing of the agreement with Gridliance, as well as future documents as they are presented. Collins also clarified that there would be no changes for our utility customers, as we will still be billing, reading meters and performing maintenance on our lines. Mayor Hutto commended all parties on the work that went into this partnership. Upon motion by Commissioner Thompson, seconded by Commissioner Jarvis all Commissioners voting aye, Bill No. 1902 was adopted and numbered Resolution No. 0219.

#### OTHER BUSINESS

- -Fire Chief Warren asks that the Commission award the purchase of the Osage 2019 Ford F450 Type I Ambulance in the amount of \$198,900 to Emergency Service Supply, Osage, Missouri. Emergency Service Supply has agreed to sell the ambulance for the same price as the 2018 bid price. Since it is the same price, it is under an existing contract and does not need to be submitted for bids. Commissioner Jarvis moved to approve the purchase of the Osage 2019 Ford F450 Type I Ambulance in the amount of \$198,900 from Emergency Service Supply, Osage, Missouri. Motion was seconded by Commissioner Thompson. With all Commissioners voting aye, motion carried.
- -Brett Hooten from Gridliance expressed his appreciation for all the work that went into making the partnership happen.
- -Bary Warren from Gridliance spoke to the Commissioners about the next step moving forward with the Kansas Corporation Commission, working with Director of Utilities Collins and Kansas Power Pool preparing for filing in late February.
- -Commission Jarvis moved the City Commission recess into Executive Session for consultation with the City Attorney and the Interim City Manager which would be deemed privileged in the attorney-client relationship pursuant to the consultation with the City Attorney matter exception, K.S.A. 75-4319(b)(2). The open meeting will reconvene in the Community Council Room at 6:00 p.m.



Action Requested: Seeking approval of 3 nuisance resolutions ordering the removal and abatement of a trash nuisance at 1513 Mansfield St., 607 Loomis St. and 332 Massachusetts. Consideration of a Setting Resolution setting a time and date for a public hearing for possible condemnation of 1421 E. 9<sup>th</sup> Ave.

Analysis: 1513 Mansfield: Spoke with the owner on prior occasions who explained that her deceased husband had used the property to keep scrap materials and she would have someone clean it up. Since that conversation it appears that no scrap metal remains however the property is increasingly becoming a dumping ground. A fence of metal roofing hides the junk which due to overgrowth of trees is only noticeable during the winter months. The non-conforming fence will also be removed during the clean up process.

**607 Loomis:** Spoke with the owner regarding outdoor storage in the side and back yard. He advised at the time that he would need some time to get the items removed. No action to remove has taken place since the initial conversation.

**332 N. Massachusetts:** Completed a clean-up of this property in 2017 and upon inspection found trash under the carport and furniture in the side and back yard as well as junk and trash on the alley.

**1421 E. 9**<sup>th</sup> **Ave.:** Completed internal and external inspection of two structures on the same parcel with the permission of the owner. Inspections revealed the two-story apartment is in a severe state of deterioration and should be considered for condemnation. The second structure addressed as 909 High is also in a state of disrepair however it is not irreparable and owner could affect necessary repair to bring the structure up to a habitable state.

Fiscal Impact: Unknown fiscal impact as of now. If no action is taken by the owner a contractor will be assigned to complete the demolition and removal of both structures and that cost passed to the owner.

### **RESOLUTION NO. 0819**

A RESOLUTION AUTHORIZING AND PROVIDING FOR THE CALLING OF A SPECIAL QUESTION ELECTION IN THE CITY OF WINFIELD, KANSAS, FOR THE PURPOSE OF SUBMITTING TO THE ELECTORS OF THE CITY THE QUESTION OF IMPOSING A ONE PERCENT (1%) CITY-WIDE RETAILERS' SALES TAX; AND PROVIDING FOR THE GIVING OF NOTICE OF SAID ELECTION.

**WHEREAS**, K.S.A. 12-187 *et seq.*, as amended, (the "Act") authorizes the governing body (the "Governing Body") of the City of Winfield, Kansas (the "City") to submit to the electors of the City the question of imposing City-wide retailers' sales taxes, which may be in an amount not to exceed two-percent (2%) for general purposes or in an additional amount not to exceed one percent (1%) for special purposes, provided sales taxes for special purposes shall expire not later than ten (10) years from the initial date of collection thereof; and

**WHEREAS**, pursuant to the Act, as amended by Charter Ordinance No. 23, the electors of the City have heretofore approved propositions to authorize the levy of City-wide retailers' sales taxes as follows:

- (a) one-half percent (0.50%) for general purposes, authorized in 1981; and
- (b) one-half percent (0.50%) for flood control improvements, authorized in 1984 and reauthorized in 1990; and
- (c) four-tenths of one percent (0.40%) for library, street and other capital improvements, authorized in 2014 (the "2014 Sales Tax"); and

**WHEREAS**, the Governing Body deems it advisable that additional funds, other than from ad valorem property taxation, be derived to finance the costs of police, fire, and public safety buildings and facilities, streets, and other capital improvements throughout the City, including the payment of financing costs related thereto; and

**WHEREAS**, the Governing Body deems it advisable that funds to finance such purposes be derived by the imposition of a one percent (1%) City-wide retailers' sales tax (the "2019 Capital Improvements Sales Tax") and the termination of the 2014 Sales Tax; and

**WHEREAS**, in order to authorize the 2019 Capital Improvements Sales Tax and terminate the 2014 Sales Tax, it is deemed advisable to call a special question election in the City on June 4, 2019; and

**WHEREAS**, it is deemed advisable to hold such election in accordance with the mail ballot election law (K.S.A. 25-431 *et seq.*); and

**WHEREAS**, if approved, the 2019 Capital Improvements Sales Tax will constitute a sales tax imposed for general purposes, as said term is described in K.S.A. 12-189, as amended.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF WINFIELD, KANSAS:

**SECTION 1. 2019 Capital Improvements Sales Tax.** It is hereby deemed necessary and advisable and in the best interests of the citizens of the City to finance the costs of finance the costs of police, fire, and public safety buildings and facilities, streets, and other capital improvements throughout the City, including the payment of financing costs related thereto by the imposition of the 2019 Capital Improvements Sales Tax. Collection of the 2019 Capital Improvements Sales Tax, if approved by the electors of the City, shall commence on October 1, 2019, or as soon thereafter as permitted by the Act, and to terminate 25 years after its commencement; and upon the effective date of collection of the 2019 Capital Improvements Sales Tax, the collection of the 2014 Sales Tax shall terminate.

**SECTION 2. Special Question Election.** It is hereby authorized, ordered and directed that a special question election shall be and is hereby called to be held in the City on June 4, 2019, at which time there shall be submitted to the qualified electors of the City the following proposition:

Shall the following be adopted?

Shall the City of Winfield, Kansas be authorized to impose a one percent (1%) City-wide retailers' sales tax (the "2019 Capital Improvements Sales Tax"), the proceeds of which shall be used to finance the costs of police, fire, and public safety buildings and facilities, streets, and other capital improvements throughout the City, including the payment of financing costs related thereto; the collection of the 2019 Capital Improvements Sales Tax to commence on October 1, 2019, or as soon thereafter as permitted by law, and to terminate 25 years after its commencement; and upon the effective date of collection of the 2019 Capital Improvements Sales Tax, the collection of the existing four-tenths of one percent (0.40%) City-wide retailers' sales tax imposed to finance the costs of library, street and other capital improvements throughout the City shall be terminated; all pursuant to the provisions of K.S.A. 12-187 et seq. and K.S.A. 25-431 et seq., as amended?

**SECTION 3. Special Question Election Procedures.** The vote at said special question election shall be by mail ballot, and the proposition stated above shall be printed on the ballot, together with voting instructions as provided by law. The City Clerk shall transmit a copy of this Resolution to the Cowley County Clerk to give notice of the special question election as provided by law by publishing a Notice of Special Question Election in substantially the form attached hereto as *Exhibit A* once each week for two (2) consecutive weeks in a newspaper of general circulation in the City, with the first publication to be not less than twenty-one (21) days prior to the date of the special question election, and the last publication shall be not more than forty-five (45) days prior to the date of the special question election.

**SECTION 4. Effective Date**. This Resolution shall be effective from and after adoption by the Governing Body.

#### Comments:

The City of Winfield Underground Utilities department currently has two utility trucks in its fleet. One is a 1999 Ford 1-ton truck equipped with a utility bed and power inverter. The second is a 1989 Ford F800 (two ton) truck equipped with utility bed, crane and air compressor. Both have served us very well for twenty years or more.

In 2015, we began exploring options for replacement of these trucks, with the goal being a single truck equipped with options necessary to complete the various tasks we encounter. Staff has made visits to distributors, visited with sales reps at conferences, and had a demo brought to the op center for a hands-on demonstration.

Through this, we have determined a 1 % ton truck equipped with utility bed, 7500 lb. crane, PTO driven air compressor and 3000-watt power invertor would be the best tuck overall. The 1 % ton truck is large enough to adequately tow our mini-excavator, and the added options will meet the needs of the crew in most situations.

Knowing this would be a large purchase, we began planning in 2017, requesting for the 2018 budget, a transfer of \$50,000.00 to equipment reserve fund, which was approved. We then requested an additional \$83,000.00 for the 2019 budget for a total of \$133,000.00 which was approved.

There are two distributors of large utility trucks in the Wichita area, Midwest Truck Equipment, and Kansas Truck Equipment. We requested a proposal from both companies, for a truck equipped as described in the paragraph above. Midwest Truck Equipment declined the opportunity, stating they didn't believe they would be able to fill the order in a timely manner (as determined by them). Kansas Truck Equipment provided pricing for two options, one with an aluminum bed, one with a steel bed.

Please see the attached price quote. Recommendation is to purchase the truck with a steel bed and the highlighted option upgrades.
