CITY COMMISSION MEETING MINUTES Winfield, Kansas June 3, 2019

The Board of City Commissioners met in regular session, Monday, June 03, 2019 at 5:30 p.m. in the City Commission-Community Council Meeting Room, City Hall; Mayor Ronald E. Hutto presiding. Commissioner Phillip R. Jarvis and Commissioner Gregory N. Thompson were also present. Also in attendance were Taggart Wall, City Manager, Brenda Peters, City Clerk and William E. Muret, City Attorney. Other staff members present were Gary Mangus, Assistant to the City Manager; Patrick Steward, Director of Public Improvements; and Gus Collins, Director of Utilities.

City Clerk Peters called roll.

Commissioner Thompson moved that the minutes of the May 20, 2019 meeting be approved. Commissioner Jarvis seconded the motion. With all Commissioners voting aye, motion carried.

PUBLIC HEARING

-Proposed assessments for Improvements at Country Club Estates and Country Club Villas. Mayor Hutto opened a public hearing for the proposed assessments for Improvements at Country Club Villas. Chris Jarvis, 23 Braid Hill Dr, expressed concern about the re-seeding and asked if the City will correct the landscaping. Chris Jarvis also asked if the street designation of "Braid Hill Dr" could be changed back to "Braid Hills Dr". With no one else present to comment, Mayor Hutto closed the public hearing.

NEW BUSINESS

Bill No. 1934 – An Ordinance – Levying Special Assessments on certain property to pay the costs of internal improvements in the City of Winfield, Kansas, as previously authorized by Resolution No. 0308 and Ordinance No. 4063 and Resolution Nos. 4717 and 4817 of the City; and providing for the collection of such Special Assessments. Dave Arteberry explains the bond issue and timetable to the Commissioners. Upon motion by Commissioner Jarvis, seconded by Commissioner Thompson, all Commissioners voting aye, Bill No. 1934 was adopted and numbered Ordinance No. 4107.

Bill No. 1935 – An Ordinance – Annexing certain land into the corporate limits of the City of Winfield, Cowley County, Kansas, pursuant to K.S.A. 12-520 (a)(7). Director of Public Improvements Steward explains that annexing land is covered by State Statutes, but the requirements can be waived if the owners of the property request annexation, which the owners have done. Upon motion by Commissioner Thompson, seconded by Commissioner Jarvis, all Commissioners voting aye, Bill No. 1935 was adopted and numbered Ordinance No. 4108.

Bill No. 1936 – A Resolution – Authorizing the Mayor and the City Clerk of the City of Winfield, Kansas to execute an agreement for professional services with Foster Design Associates, LLC for the purpose of updating the current Comprehensive Development Plan and preparing a Master Plan for Parks, Trails, and Recreation. Director of Public Improvements Steward explains that this Resolution would allow the City to enter into an agreement with Foster Design Associates, LLC, for an amount not to exceed \$71,450. Upon motion by Commissioner Jarvis, seconded by Commissioner Thompson, all Commissioners voting aye, Bill No. 1936 was adopted and numbered Resolution No. 3019.

Bill No. 1937 – A Resolution – Setting forth findings that the structure, a house, located on a tract of land legally described as follows Lot Seven (7), Block 98, Mansfield Addition, to Winfield, Kansas. Commonly known as 1801 Manning St. Recorded in Deed Record No. 190, in the Office of the Register of Deeds in Cowley County, Kansas, is unsafe and/or dangerous and ordering said structure to be repaired or removed in ninety (90) days. Director of Public Improvements Steward explains that this Resolution would give the owners 90 days to remove the structure or bring it into a habitable condition. Upon motion by Commissioner Thompson, seconded by Commissioner Jarvis, all Commissioners voting aye, Bill No. 1937 was adopted and numbered Resolution No. 3119.

Bill No. 1938 – A Resolution – Setting forth findings that the structure located on a tract of land legally described as follows: North 50 feet of Lot 7, and the North 50 feet of the West 30 feet of Lot 8 Block 229, Fuller's Addition, to Winfield, Kansas. Commonly known as 916 Bliss St. Recorded in Book 310 page 387, in the Office of the Register of Deeds of Cowley County, Kansas. is unsafe and/or dangerous and ordering said structures to be repaired or removed in ninety (90) days. Director of Public Improvements Steward explains that this Resolution would give the owners 90 days to remove the structure or bring it into a habitable condition. Upon motion by Commissioner Jarvis, seconded by Commissioner Thompson, all Commissioners voting aye, Bill No. 1936 was adopted and numbered Resolution No. 3219.

ORDINANCE NO. 4109

AN ORDINANCE OF THE GOVERNING BODY OF THE CITY OF WINFIELD, KANSAS, AUTHORIZING THE LEVY OF A ONE PERCENT (1%) CITY-WIDE RETAILERS' SALES TAX AND RELATED MATTERS.

WHEREAS, pursuant to the provisions of K.S.A. 12-187 *et seq.* (the "Act"), the City of Winfield, Kansas (the "City") is authorized to impose a local retailers' sales tax upon all retail sales within the boundaries of the City, except as specifically exempted by the Act; and

WHEREAS, pursuant to the Act, as amended by Charter Ordinance No. 23, the electors of the City have heretofore approved propositions to authorize the levy of City-wide retailers' sales taxes as follows:

- (a) one-half percent (0.50%) for general purposes, authorized in 1981; and
- (b) one-half percent (0.50%) for flood control improvements, authorized in 1984 and reauthorized in 1990; and
- (c) four-tenths of one percent (0.40%) for library, street and other capital improvements, authorized in 2014 (the "2014 Sales Tax"); and

WHEREAS, the Governing Body deemed it advisable that additional funds, other than from ad valorem property taxation, be derived to finance the costs of police, fire, and public safety buildings and facilities, streets, and other capital improvements throughout the City, including the payment of financing costs related thereto, and to derive funds to finance such purposes by the imposition of a one percent (1%) City-wide retailers' sales tax (the "2019 Capital Improvements Sales Tax") and the termination of the 2014 Sales Tax; and

WHEREAS, the Governing Body deemed it advisable to call a special question election in the City on June 4, 2019, for the purpose of submitting to the qualified electors of the City the following question:

Shall the following be adopted?

Shall the City of Winfield, Kansas be authorized to impose a one percent (1%) City-wide retailers' sales tax (the "2019 Capital Improvements Sales Tax"), the proceeds of which shall be used to finance the costs of police, fire, and public safety buildings and facilities, streets, and other capital improvements throughout the City, including the payment of financing costs related thereto; the collection of the 2019 Capital Improvements Sales Tax to commence on October 1, 2019, or as soon thereafter as permitted by law, and to terminate 25 years after its commencement; and upon the effective date of collection of the 2019 Capital Improvements Sales Tax, the collection of the existing four-tenths of one percent (0.40%) City-wide retailers' sales tax imposed to finance the costs of library, street and other capital improvements throughout the City shall be terminated; all pursuant to the provisions of K.S.A. 12-187 *et seq.* and K.S.A. 25-431 *et seq.*, as amended?

WHEREAS, the question of the imposition of the 2019 Capital Improvements Sales Tax was approved by a majority of the qualified electors of the City voting on that proposition at the special question election; and

WHEREAS, pursuant to the provisions of K.S.A. 12-187 *et seq.* and the special question election, the Governing Body deems it necessary and advisable to authorize the imposition of the 2019 Capital Improvements Sales Tax for the purposes described above, which constitutes a sales tax imposed for general purposes, and to provide for the termination of the 2014 Sales Tax upon the effective date of the 2019 Capital Improvements Sales Tax.

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WINFIELD, KANSAS:

SECTION 1. Implementation of the 2019 Capital Improvements Sales Tax. The levy of the one percent (1%) 2019 Capital Improvements Sales Tax and the application of the revenue received therefrom is hereby authorized. In accordance with K.S.A. 12-191, collection of the 2019 Capital Improvements Sales Tax shall commence on October 1, 2019, or as soon thereafter as permitted by law.

SECTION 2. Termination of the 2014 Sales Tax. The termination of the existing 2014 Sales Tax is hereby authorized. Such terminations shall occur upon the effective date of collection of the 2019 Capital Improvements Sales Tax, which is scheduled to occur on October 1, 2019, or as soon thereafter as permitted by law.

SECTION 3. Department of Revenue Submittal. The Clerk, upon passage of this Ordinance, shall provide a certified copy of the same to the State Director of Taxation pursuant to K.S.A. 12-189 and request the implementation of the 2019 Capital Improvements Sales Tax and the termination of the 2014 Sales Tax in accordance with the provisions hereof.

SECTION 4. Effective Date. This Ordinance shall be effective upon passage by the Governing Body, execution by the Mayor and publication once in the official City newspaper.

WHEREAS, the Issuer proposes to issue its general obligation bonds to pay a portion of the costs of the Improvements and to retire the Notes; and

WHEREAS, the Issuer has previously issued and has outstanding general obligation bonds; and

WHEREAS, due to the current interest rate environment, the Issuer has the opportunity to issue its general obligation refunding bonds in order to achieve an interest cost savings on all or a portion of the debt represented by such general obligation bonds described as follows (the "Refunded Bonds"):

WHEREAS, the City Commission of the Issuer (the "Governing Body") has selected the firm of George K. Baum & Company, Kansas City, Missouri (the "Municipal Advisor"), as municipal advisor for one or more series of general obligation bonds of the Issuer to be issued in order to provide funds to permanently finance the Improvements, retire the Notes, and refund the Refunded Bonds; and

WHEREAS, the Issuer desires to authorize the Municipal Advisor to proceed with the offering for sale of said general obligation bonds and related activities; and

WHEREAS, one of the duties and responsibilities of the Issuer is to prepare and distribute a preliminary official statement relating to said general obligation bonds; and

WHEREAS, the Issuer desires to authorize the Municipal Advisor and Gilmore & Bell, P.C., Wichita, Kansas, the Issuer's bond counsel ("Bond Counsel"), in conjunction with the Clerk/Finance Director to proceed with the preparation and distribution of a preliminary official statement and notice of bond sale and to authorize the distribution thereof and all other preliminary action necessary to sell said general obligation bonds.

BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF WINFIELD, KANSAS, AS FOLLOWS:

Section 1. There is hereby authorized to be offered for sale the Issuer's General Obligation Refunding and Improvement Bonds, Series 2019-A (the "Bonds") described in the Notice of Bond Sale, which is hereby approved in substantially the form presented to the Governing Body this date (the "Notice of Bond Sale"). All proposals for the purchase of the Bonds shall be delivered to the Governing Body at its meeting to be held on the sale date referenced in the Notice of Bond Sale, at which meeting the Governing Body shall review such bids and award the sale of the Bonds or reject all proposals.

Section 2. The Mayor and Clerk/Finance Director, in conjunction with the Municipal Advisor and Bond Counsel, are hereby authorized to cause to be prepared a Preliminary Official Statement relating to the Bonds (the "Preliminary Official Statement"), and such officials and other representatives of the Issuer are hereby authorized to use such document in connection with the sale of the Bonds.

Section 3. The Clerk/Finance Director, in conjunction with the Municipal Advisor and Bond Counsel, is hereby authorized and directed to give notice of said bond sale by publishing a summary of the Notice of Bond Sale not less than 6 days before the date of the bond sale in a newspaper of general circulation in Cowley County, Kansas, and the *Kansas Register* and by distributing copies of the Notice of Bond Sale and Preliminary Official Statement to prospective purchasers of the Bonds. Proposals for the purchase of the Bonds shall be submitted upon the terms and conditions set forth in the Notice of Bond Sale, and awarded or rejected in the manner set forth in the Notice of Bond Sale.

Section 4. For the purpose of enabling the purchaser of the Bonds (the "Purchaser") to comply with the requirements of Rule 15c2-12 of the Securities and Exchange Commission (the "Rule"), the Mayor and Clerk/Finance Director are hereby authorized: (a) to approve the form of the Preliminary Official Statement and to execute the "Certificate Deeming Preliminary Official Statement Final" in substantially the form attached hereto as *Exhibit A* as approval of the Preliminary Official Statement, such official's signature thereon being conclusive evidence of such official's and the Issuer's approval

thereof; (b) covenant to provide continuous secondary market disclosure by annually transmitting certain financial information and operating data and other information necessary to comply with the Rule to the Municipal Securities Rulemaking Board; and (c) take such other actions or execute such other documents as such officers in their reasonable judgment deem necessary to enable the Purchaser to comply with the requirement of the Rule.

Section 5. The Issuer agrees to provide to the Purchaser within seven business days of the date of the sale of Bonds or within sufficient time to accompany any confirmation that requests payment from any customer of the Purchaser, whichever is earlier, sufficient copies of the final Official Statement to enable the Purchaser to comply with the requirements of the Rule and with the requirements of Rule G-32 of the Municipal Securities Rulemaking Board.

Section 6. The Mayor, Clerk/Finance Director, and the other officers and representatives of the Issuer, the Municipal Advisor and Bond Counsel are hereby authorized and directed to take such other action as may be necessary to: (a) carry out the sale of the Bonds; (b) make provision for payment and/or redemption of the Notes from proceeds of the Bonds and other available funds; and (c) provide for notice of redemption of the Refunded Bonds.

Section 7. The Mayor, City Manager or Finance Director are hereby authorized and directed to execute the engagement letter related to services to be provided by the Municipal Advisor.

Section 8. This Resolution shall be in full force and effect from and after its adoption by the Governing Body.

Analysis: The current RFD#7 agreement terminates the end of 2019. RFD#7, which includes Beaver, Fairview, Liberty, Pleasant Valley, Salem, Tisdale, Vernon, & Walnut Townships of Cowley County, has contracted with the City for fire protection services for many years. Historic response numbers and mill levy receipts for RFD#7 are listed below. Attached for your review is the proposed 2020-2022 RFD#7 agreement.

Fiscal Impact: The mill levy receipts for 2014-2016 reflect dollars received from a 5-mill levy₄ The 2017-2019 mill levy receipts were received from a 5 $\frac{1}{2}$ -mill levy. The proposed 2020-2022 agreement remains a 5 $\frac{1}{2}$ -mill levy, however, the minimum was raised to \$200,000 from \$170,000. The balance of the Terms & Conditions of the proposed agreement remain the same.

AGREEMENT

THIS AGREEMENT made and entered into this 17th day of June 2019, by and between the City of Winfield, Kansas, hereinafter referred to as "City"; and Rural Fire District No. 7, Cowley County, Kansas, hereinafter referred to as "Fire District."

WHEREAS, the said Fire District is established and organized under the provision of K.S.A. 19-3601 to 19-3605, inclusive, and all acts amendatory thereof and supplemental thereto, which district is supervised by a Fire District Board of Trustees appointed and acting pursuant to K.S.A. 19-3612a and all acts amendatory thereof and supplemental thereto; and

WHEREAS, the said Fire District desires to receive from the City certain fire protection as hereinafter set forth, and the City is willing and able to furnish such fire protection, and both the Fire District and the City desire to contract with reference thereto.

NOW, THEREFORE, in consideration of the mutual promises, covenants, and agreements of the parties thereto, the Fire District and the City agree as follows:

SECTION ONE TERM

This agreement for fire protection service shall commence on the 1st day of January 2020, and terminate on December 31, 2022, provided, however, that either party may cancel the agreement by giving notice on or before July 1 of any year except 2022. The agreement would terminate 18 months after said July 1 notice unless the parties agree otherwise in writing. The governing body of the City and the Board of Trustees of the Fire District shall meet during the month of May of each year during the effective term of this agreement to review the terms and conditions of this agreement and the fire protection service furnished there under. Any renegotiations for extension or renewal of this agreement shall be completed prior to July 1 of the year in which the change would take effect to allow the City and Fire District sufficient time to calculate and prepare their respective annual budgets.

SECTION TWO FIRE PROTECTION

The City, during the effective term of this agreement, shall make reasonable effort to furnish fire fighting and related emergency services, road and weather conditions permitting. They shall utilize; (1) paid on-call and regular firefighters, as well as, reserve firefighters and support staff, all employed by said City, and (2) fire fighting apparatus and equipment owned and operated by said City, both as determined by the official in-charge. City has no obligation to attend fires where the value of the property which might be saved would be less than the cost to the City attending such fire. City shall not be obligated to respond to any fire call with equipment fighting a then existing fire, or where in the judgment of the fire official in-charge, a condition exists which would likely result in substantial damage to fire fighting equipment or would deplete available fire fighting forces to an extent of jeopardizing fire protection to the City.

SECTION THREE ANNUAL FEE

The Fire District shall pay to the City all revenues received from a five and one quarter (51/4) mills ad valorem property tax levy upon all of the taxable tangible property located within the Fire District as authorized by Kansas law, provided such amount shall not be less than Two Hundred Thousand (\$200,000) dollars. The proceeds of such tax levy and any other funds of any kind and source whatsoever to which the Fire District may be entitled as a result of said levy or the ability to levy taxes, shall be paid to the City for fire protection services rendered under this agreement. Said fire protection services payment shall be made by the Fire District within ten (10) days after the dates for distribution of taxes by the County Treasurer as provided by K.S.A. 12-1678a(c)(1) or as otherwise designated by state statute or legislative direction. In the event said payments are not made to the City within said time, the City may terminate this agreement by providing thirty (30) days written notice of such fact to the Fire District.

SECTION FOUR CONTROLLED BURNINGS

Any person within the territory of the said Fire District desiring to initiate a "controlled burning" of yards, pastures, or deteriorated buildings, must provide notice of and obtain consent to such burning in advance, and give notice of its completion.

SECTION FIVE INSURANCE & WAIVER

INSURANCE:

Fire District and City, at their own cost and expense, each maintain a minimum of \$500,000 each occurrence/aggregate premises and operations liability insurance and \$500,000 automobile liability insurance for all hired, owned and non-owned vehicles, in a company authorized to do business in the State of Kansas. Both parties agree to provide a certificate of insurance to each other on an annual basis.

In addition, Fire District and City, if required by law, at their own cost and expense, will each maintain Workers' Compensation Insurance throughout the duration of this contract to cover their own employees as per Statute.

WAIVER OF SUBROGATION:

Fire District waives any and all rights of recovery against City, or against the officers, employees, agents and representatives of the City, for loss of or damage caused by the acts of the City or of others under its control for such loss or damage. In addition, the City waive any and all rights of recovery against the Fire District, or against the officers, employees, agents and representatives of the Fire District, for loss of or damage caused by the acts of Fire District or of others under its control for such loss or damage.

SECTION SIX NONEXCLUSIVE CONTRACT

This agreement shall not be considered as exclusive and the said Fire District acknowledges that the City may enter into similar agreements with other fire districts, municipalities, governmental agencies, persons, firms, corporations, or any other instrumentalities.

SECTION SEVEN DISTRICT'S PUBLICATION EXPENSES

The City shall pay legal publication expenses of the Fire District which are required of said District to discharge its responsibilities under this agreement.

SECTION EIGHT FIRE REPORTS

The City agrees prior to July 1, following each calendar year included in the effective term of this agreement, to furnish Fire District an annual report for each fire alarm responded to within said Fire District including the nature, location, and other pertinent information concerning each such fire or alarm.






