Director of Public Improvements Steward explains that this Resolution authorizes the City Manager to negotiate a contract for additional work with Ditch Diggers Inc., Salina, Kansas for the Walnut River waterline replacement. Upon motion by Commissioner Thompson, seconded by Commissioner Hutto, all Commissioners voting aye, Bill No. 2018 was adopted and numbered Resolution No. 1820.

#### AN ORDINANCE

AMENDING Chapter 50, Article III of the Revised Ordinances of the City of Winfield, Kansas relating to camping regulations by the amendment of Section 50-115(a).

# NOW, THREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WINFIELD, KANSAS, THAT:

<u>Section 1.</u> Section 50-115(a) of Chapter 50, Article III of the Revised Ordinances of the City of Winfield, Kansas, is hereby deleted and replaced with the following:

Sec. 50-115(a) – No person shall park a recreational vehicle or camp at the lake for more than 14 consecutive calendar days without vacating the lake camping zone for at least seven consecutive calendar days before returning to the previously occupied lake camping zone. Having parked a recreational vehicle or camped at the lake for a minimum of four consecutive calendar days, a person must, upon moving, vacate the lake zone for at least seven consecutive calendar days before returning to the previously occupied lake camping zone. For the purpose of this Ordinance, Zone 25 and Zone 26 shall be considered as a single zone, and; Zone 22 and Zone 23 shall be considered as a single zone. Special extensions may be granted by the city manager or his representative upon submittal to the city of the designated form available at the lake office or city hall.

Section 2. This ordinance shall take effect May 1, 2020.

<u>Section 3.</u> This ordinance shall be in full force and effect from and after its adoption and publication in the official city newspaper.
