CITY COMMISSION MEETING MINUTES
Winfield, Kansas
April 6, 2020

The Board of City Commissioners met in regular session, Monday, April 06, 2020 at 5:30 p.m. in the City Commission-Community Council Meeting Room, City Hall; Mayor Phillip R. Jarvis presiding. Mayor Phillip R. Jarvis, and Commissioners Gregory N. Thompson and Ronald E. Hutto and William E. Muret, City Attorney were present by "Go to Meeting". In attendance were Taggart Wall, City Manager; and Brenda Peters, City Clerk. Other staff members present were Gary Mangus, Assistant to the City Manager; Patrick Steward, Director of Community Development; and Gus Collins, Director of Utilities.

City Clerk Peters called roll.

Commissioner Hutto moved that the minutes of the March 16, 2020 meeting be approved. Commissioner Thompson seconded the motion. With all Commissioners voting aye, motion carried.

BUSINESS FROM THE FLOOR

PROCLAMATION

-Proclaiming the Month of April as Fair Housing Month. Mayor Jarvis proclaimed the month of April 2020 as Fair Housing Month.

NEW BUSINESS

Bill No. 2022– An Ordinance – Amending Chapter 34 of the revised ordinance of the City of Winfield, Kansas by the repeal of Section 34-62, Paragraph C (1), and adoption in lieu thereof a new Section 34-62 Paragraph C (1) relating to fees for use of recreational facilities at the Winfield Fairgrounds. City Manager Wall explains that this Ordinance will amend fees at the Winfield Fairgrounds. Upon motion by Commissioner Thompson, seconded by Commissioner Hutto, all Commissioners voting aye, Bill No. 2022 was adopted and numbered Ordinance No. 4123.

Bill No. 2023– An Ordinance – Amending Chapter 34 of the revised ordinance of the City of Winfield, Kansas by the repeal of Section 34-50, Paragraph B (4), and adoption in lieu thereof a new Section 34-50, Paragraph B (4) Recreational license and camping fees (Winfield City Lake). City Manager Wall explains that this Ordinance will amend fees at the Winfield City Lake. Upon motion by Commissioner Hutto, seconded by Commissioner Thompson, all Commissioners voting aye, Bill No. 2023 was adopted and numbered Ordinance No. 4124.

Bill No. 2024– An Ordinance – Amending Chapter 50, Article III of the Revised Ordinances of the City of Winfield, Kansas relating to camping regulations by the amendment of Section 50-115(a). City Manager Wall explains that this Ordinance will amend regulations at the Winfield City Lake relating to camping. Upon motion by Commissioner Thompson, seconded by Commissioner Hutto, all Commissioners voting aye, Bill No. 2024 was adopted and numbered Ordinance No. 4125.

Bill No. 2025 – A Resolution – Authorizing and directing the Mayor and Clerk of the City of Winfield, Kansas, to execute a Consent to Annexation and Service Extension Agreement for property outside the corporate boundary of the City of Winfield. (Young) City Manager Wall explains that this Resolution

accepts a consent to annexation agreement which is required for any water service provided to customers located outside the city limits. Upon motion by Commissioner Hutto, seconded by Commissioner Thompson, all Commissioners voting aye, Bill No. 2025 was adopted and numbered Resolution No. 2220.

Bill No. 2026 – A Resolution – Authorizing and directing the Mayor and Clerk of the City of Winfield, Kansas, to execute a change order for Project No. 35-197047-001-0943, CDBG Project No. 19-IT-002 between the City of Winfield, Kansas and Ditch Diggers Inc., Salina, Kansas for waterline improvements. Director of Community Development Steward explains that this Resolution considers a change order for an alternate method of connection from the new segment of the waterline to the existing main, in the amount of \$3,200.00. Upon motion by Commissioner Thompson, seconded by Commissioner Hutto, all Commissioners voting aye, Bill No. 2026 was adopted and numbered Resolution No. 2320.

Bill No. 2027 – A Resolution – Authorizing and directing the Mayor and Clerk of the City of Winfield, Kansas, to execute a contract for Project No. 20-TI893 for microseal street improvements between the City of Winfield, Kansas and Vance Brothers, Inc., Kansas City, Mo. Director of Community Development Steward explains that this Resolution considers awarding a contract to Vance Brothers, Inc., for microseal projects within the City. The proposal given by Vance Bros. holds the same equivalent unit price that has been used for the past two years. This contract would be for \$146,309.40 for projects throughout the City. Upon motion by Commissioner Hutto, seconded by Commissioner Thompson, all Commissioners voting aye, Bill No. 2027 was adopted and numbered Resolution No. 2420.

Bill No. 2028 – A Resolution – Authorizing and directing the Mayor and the City Clerk of the City of Winfield, Kansas to execute a contract for Asplundh Tree Expert, LLC, for West Cowley County Tree Trimming Special Project, between the City of Winfield, Kansas and Asplundh Tree Expert, LLC. Director of Utilities Collins explains this Resolution would allow the City to execute a contract for \$173,858.40 for west Cowley County tree trimming special projects between the City of Winfield, Kansas and Asplundh Tree Expert, LLC. Upon motion by Commissioner Thompson, seconded by Commissioner Hutto, all Commissioners voting aye, Bill No. 2028 was adopted and numbered Resolution No. 2520.

Bill No. 2029 – A Resolution – Authorizing and directing the Mayor and the City Clerk of the City of Winfield, Kansas to execute a contract for Davis Tree Company for annual, hourly rate, tree trimming, between the City of Winfield, Kansas and Davis Tree Company. Director of Utilities Collins explains this Resolution would allow the City to execute a contract for \$152,880.00 for hourly rate tree trimming between the City of Winfield, Kansas and Davis Tree Company. Upon motion by Commissioner Hutto, seconded by Commissioner Thompson, all Commissioners voting aye, Bill No. 2029 was adopted and numbered Resolution No. 2620.

OTHER BUSINESS

-Consider purchase of a 2020 Cargo Van for use in the Customer Service Department. Assistant to the City Manager Mangus asks that the Commissioners consider the purchase of a 2020 Cargo Van from Kline Motors for \$33,860. Commissioner Thompson moved to accept the bid from Kline

Motors for the 2020 Cargo van at a cost of \$33,860. Motion was seconded by Commissioner Hutto. With all Commissioners voting aye, motion carried.

-Executive Session to Discuss Non-Elected Personnel. Mayor Jarvis made a motion that the Commission move into executive session to discuss an individual employee's performance pursuant to the non-elected personnel exception, K.S.A. 75-4319 (b)(1), and that the open meeting will reconvene in the Community Council Room at 6:30 pm, with the City Manager called in when needed. Motion was seconded by Commissioner Hutto. With all Commissioners voting aye, motion carried.

The open meeting re-convened at 6:30 p.m.

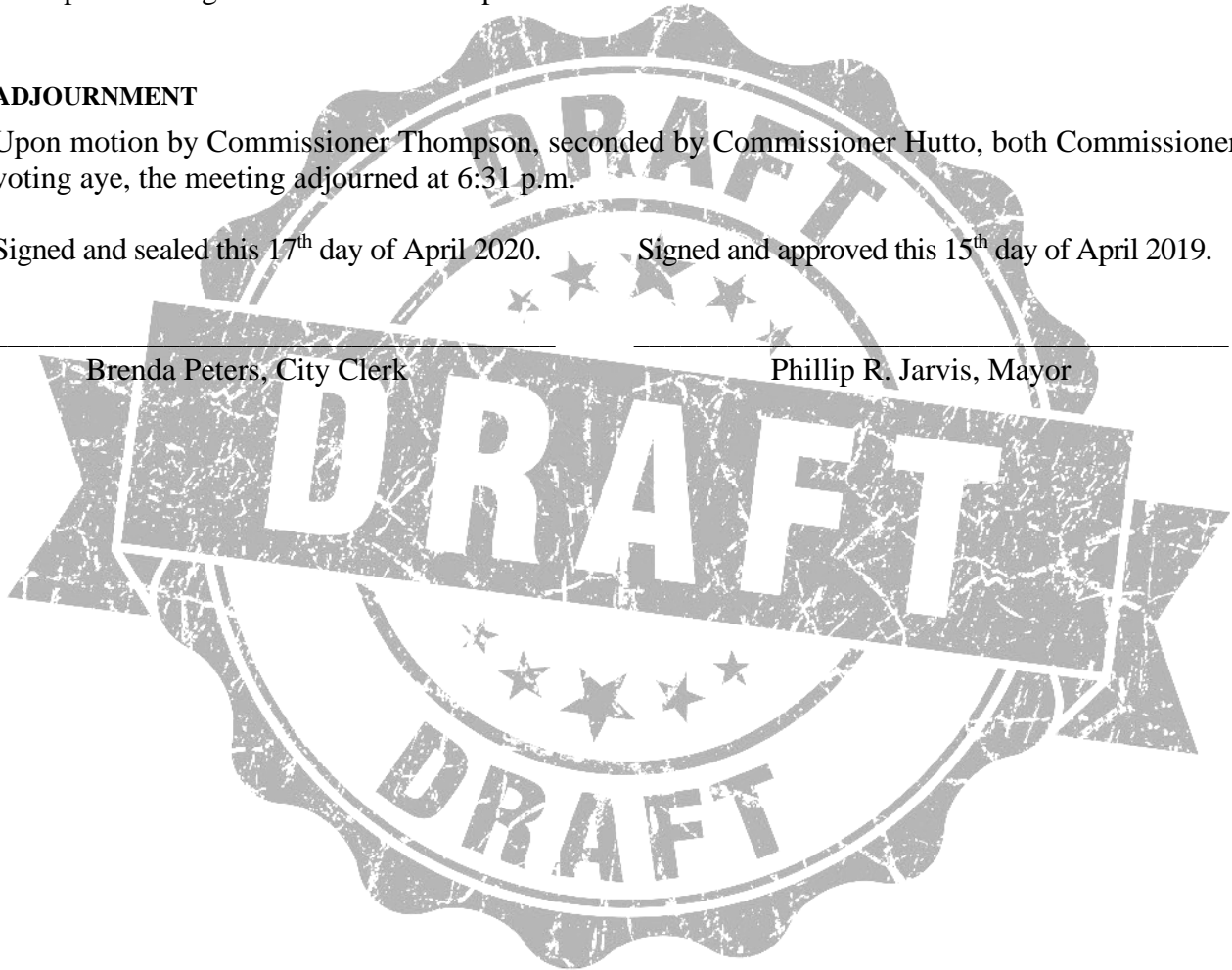

Action Requested: 4/20/2020 Commission Agenda-consider Resolution authorizing an Outdoor Community Event & Temporary Entertainment District Application from Island Park Productions.

Analysis: Island Park Productions (IPP), through an Outdoor Community Event & Temporary Entertainment District application, requests authorization to allow possession and consumption of alcohol or cereal malt beverages in Island Park from 5:00 pm to 11:00 pm during a series of outdoor concert events on May 28, June 25, July 2, July 16, and August 6, 2020.

A separate temporary Alcohol or Cereal Malt Beverage Permit is not required of Island Park Productions for possession and consumption only. The Governing Body would need to adopt a Resolution acknowledging the "Special Event" and authorizing possession and consumption.

Verbiage from previous resolutions was changed in paragraph 2 to allow postponement & rescheduling in 2020, if necessary, with notice to the City Manager's office. And, no further action required by the governing body for rescheduling in 2020. Contracts with the entertainers are signed, however, in today's environment the schedule is up in the air. "Should any of the 2020 outdoor concert events require postponement and rescheduling, notice will be given to the Winfield City Manager's office. The parties will coordinate, to the best of their abilities, rescheduling in 2020. No further action will be required by the Governing Body of the City of Winfield for said rescheduling in 2020. "

Security will be finalized for approval by WPD in advance of each event.

Fiscal Impact: The concert series is provided free to the general public. The City is a member and represented on the IPP Board. No rental fees are being sought from IPP. Their requests are for benches, trash containers, access to electricity and restrooms which are all typically on site.

The City of Winfield defines an Outdoor Community Event as follows:

- Outdoor event on public property organized for a particular and limited purpose and time. Such events shall include, but not be limited to fun runs, roadway foot races, fundraising walks, bikeathons, motor vehicle events, bike races, carnivals, festivals, cookouts, block parties, community celebrations, shows, exhibitions, circuses, fairs and temporary entertainment districts. Such term shall also include parades when held in conjunction with a community event as defined by this section, which event is sponsored or conducted by the same applicant. Such term shall not include events occurring solely on sidewalks or public rights of way immediately adjacent to public streets that do not require the closing of the sidewalk or public way.

The City of Winfield defines a Temporary Entertainment District as follows:

- A defined area, which includes City streets, alleys, parking lots and public sidewalks on which the City Commission has authorized the sale, possession or consumption of alcoholic liquor or cereal malt beverage for a specified period of time, during a Community Event which has been properly permitted.

General Information:

It is the purpose of this application to establish a process for permitting community events to use City streets, sidewalks, parks and alleys. It is unlawful for any person to conduct a community event without a community event permit. Any information required by the application must be complete upon submittal. Incomplete applications may be denied. The City of Winfield may refuse any application received less than 30 days before the event or lacking requested information. When received, an application is subject to approval of all departments involved and will be required to provide the following:

- The Winfield Police Department, the Winfield Fire Department and authorized representatives of such departments shall be responsible for the enforcement of all provisions of this application.
- No fee shall be charged for the application or permit for a Community Event itself.
- The issuance of a Community Event permit shall not negate the responsibility of the permit holder to acquire all other necessary and applicable licenses or permits which may be required for the event or pay any additional fees.
- Street closure request made to the City of Winfield.
- Certificate of General Liability Insurance naming the City of Winfield as additionally insured, *if applicable*.
- Security requirements including hiring of certified law enforcement officers.
- All Food/Beverage/Concessionaire/Amusement vendors list including contact person, contact information, and permits/licenses, as necessary.
- Outdoor Community Events shall cease between the hours of 11:00 p.m. and 8:00 a.m., Sunday through Thursday and midnight to 8:00 a.m. on Friday and Saturday.
- A detailed Security Plan will be required and approved by Winfield Chief of Police. Extraordinary Police/Fire services will be billed directly to the permit holder and will be the permit holder's responsibility.

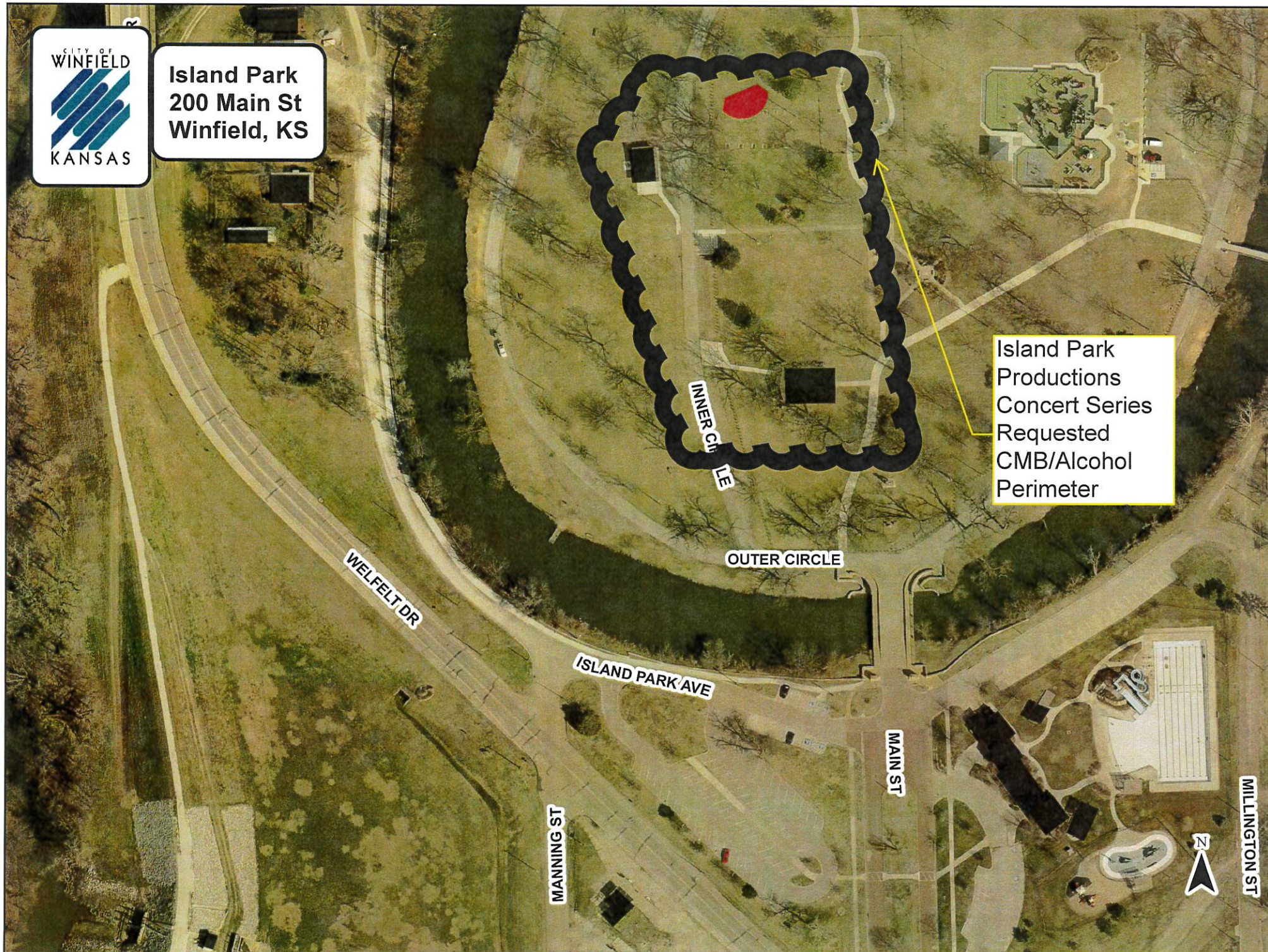

A RESOLUTION

AUTHORIZING an Outdoor Community Event and Temporary Entertainment District Application (Island Park Productions)

WHEREAS, Island Park Productions has made application for an Outdoor Community Event and Temporary Entertainment District; and

WHEREAS, Island Park Productions requests the possession and consumption of alcoholic liquor or cereal malt beverage in Island Park during a series of outdoor concert events in May, June, July and August 2020.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF WINFIELD, KANSAS, THAT:

Section 1. Within Section 6-120 of Article IV of Section 6 of the Code of the City of Winfield, Kansas, "Temporary Entertainment District" means a defined area, which includes City streets, alleys, parking lots and public sidewalks on which the City Commission has authorized the sale, possession or consumption of alcoholic liquor or cereal malt beverage for a specified period of time, during a community event which has been properly permitted under Chapter 8 of this Code.

Section 2. Island Park Productions requests the possession and consumption of alcoholic liquor or cereal malt beverage in Island Park from 5:00 pm to 11:00 pm during a series of outdoor concert events on May 28, June 25, July 2, July 16, and August 6, 2020. A Temporary Alcohol or Cereal Malt Beverage Permit is not required of Island Park Productions for possession and consumption only. Should any of the 2020 outdoor concert events require postponement and rescheduling, notice will be given to the Winfield City Manager's office. The parties will coordinate, to the best of their abilities, rescheduling in 2020. No further action will be required by the Governing Body of the City of Winfield for said rescheduling in 2020.

Section 3. The governing body of the city of Winfield Kansas hereby authorizes the Outdoor Community Event and Temporary Entertainment District Application, in accordance with the rules and procedures set forth by Article IV of Section 6 of the Code of the City of Winfield, Kansas, regarding the possession or consumption of alcoholic liquor as presented by the Island Park Productions from 5:00 pm to 11:00 pm during a series of outdoor concert events on May 28, June 25, July 2, July 16 and August 6, 2020, in Island Park, Winfield Kansas, as identified in the Outdoor Community Event and Temporary Entertainment District Application; a copy of which is attached hereto and made a part hereof.

Section 4. This resolution shall be in full force and effect from and after its passage and approval.

Request for Commission Action

Requestor: Jerred Schmidt, Director of Information Systems

Action Requested: Consider approval of the quote from Vision Communications to repair the fiber network that connects City Hall to the Operations Center.

Analysis: Over the years we've had problems with squirrels chewing on our fiber optic line that runs from City Hall to the Operations Center. We have made several repairs in the area between Main street and Mound street and all the slack has been removed so that no more splices can be made in this area. We currently have an open squirrel chew around Webster elementary and the building is not currently connected to the school's network. If this chew is left unrepaired the City of Winfield is likely to have an outage to the Operations Center and Power Plant very soon. We requested a quote for repair of the fiber line from Vision Communications and are requesting sole-source justification to move forward with this repair quickly.

The City of Winfield has used Vision Communications as our Fiber optic network contractor for repairs, maintenance and upgrades for the past 15+ years. This relationship has helped limit our network downtime and has given us a resource that we can rely on in an emergency outage situation. We have requested bids on fiber projects over the years from different vendors and have been put at the bottom of their list and have had to fight to get the project to completion.



Fiscal Impact: Total cost of the project is \$46,801.00 with a 50/50 split between USD 465 and the City of Winfield. The City's share is \$23,400.50 that would be funded with budgeted funds out of account 508.800.551200

Staff Recommendation: Award Bid to Vision Communications Inc.

Vision Communications KS, Inc. is pleased to offer our proposal for the installation of aerial fiber cable and related hardware. Included is our scope of work and pricing.

Scope of Work

- Provide and install aerial fiber cable along pathway from splice case at Mound to Webster School. Per provided information, this pathway will consist of 32 pole attachments and 2855' linear feet of cable. Slack spans have been provided for at 5 locations. Each of these spans will add 120' of fiber cable to the pathway for future splicing or maintenance. Fiber cable will be double lashed to ¼" EHS galvanized strand.
- Provide and install aerial fiber cable along pathway from Webster School to a point approximately 1 block from Main Street. Per provided information, this pathway will consist of 23 pole attachments and 2650' linear feet of cable. Slack spans have been provided for at 5 locations. Each of these spans will add 120' of fiber cable to the pathway for future splicing or maintenance. Fiber cable will be double lashed to ¼" EHS galvanized strand.
- Upon completion of fiber cable installation, new fiber strands will be fusion spliced to existing strands to restore network connectivity. At Webster School, all strands will be terminated with LC type connectors and new patch cords will be provided.
- Existing fiber cabling will be removed before installation of new strand and fiber cable. Installation of each pathway is expected to be approximately 5 days or 10 days total if both segments are replaced. This does not account for unexpected delays due to weather or unforeseen events.

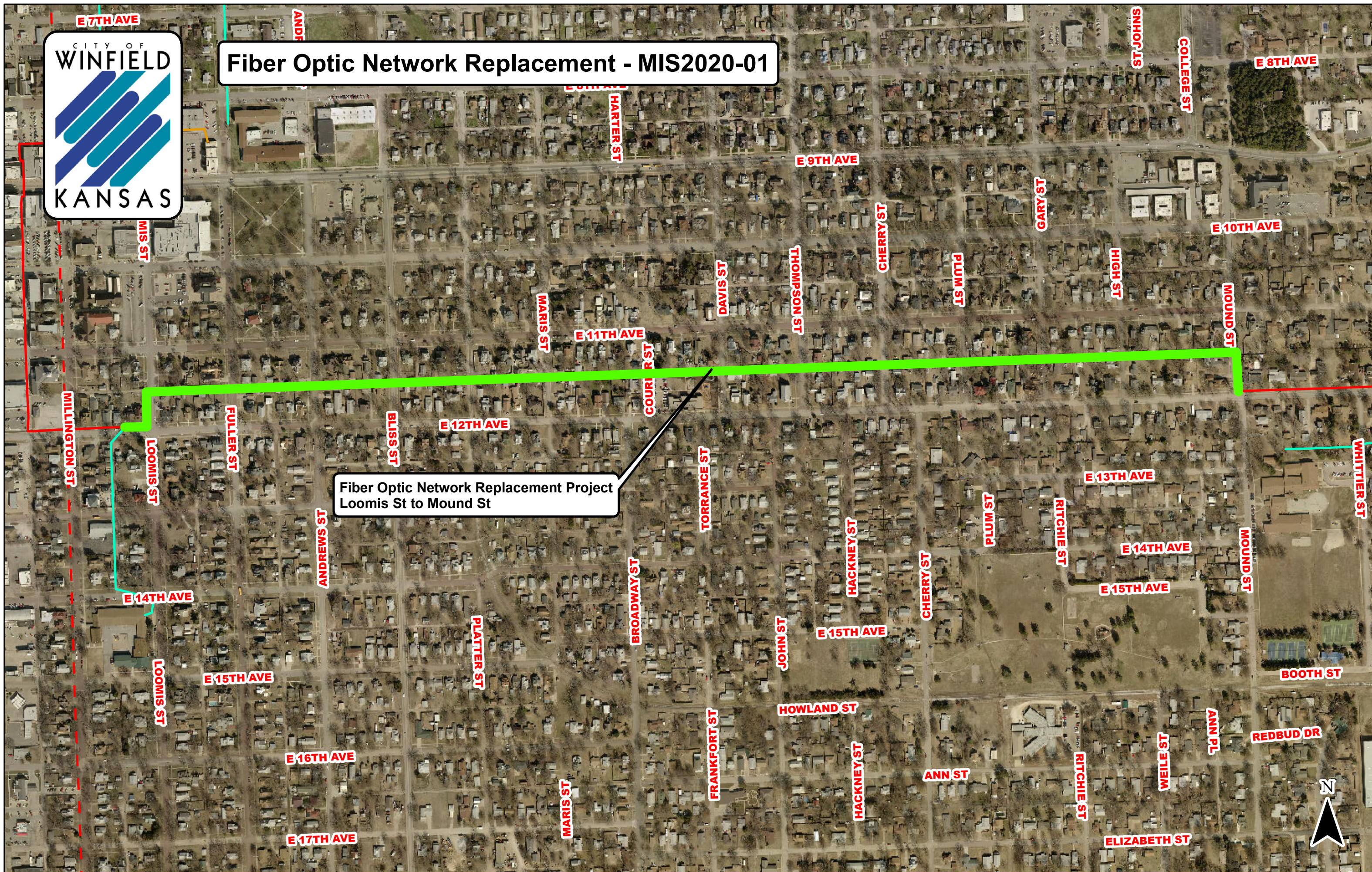

Date: April 17, 2020

Requestor: Robbie DeLong, Chief of Police

Action Requested: April 16th 2020, Work Session-discussion, April 20, 2010, Commission Agenda-Other Business: Consider Police Pursuit Sedan Quote.

Analysis: The Police Department originally had three pursuit sedans appropriated in the 2020 Vehicle/Equipment Replacement budget. In late October of 2019 staff were made aware that Dodge had changed their bidding process and due to this change staff were unable to receive quotes from local dealerships. It is also worth noting that Ford Motor Company also discontinued the production of their police sedan in the 4th quarter of 2018. Staff contacted Superior SERV out of Andover Kansas and were able to reserve three 2020 Dodge Charger Pursuit AWD vehicles (Superior SERV does all the equipment mounting for the police department). With the Pandemic growing nationwide and vehicle manufacturers slowing and even stopping production information was being received that the order from Dodge may not be filled. The owner of Superior SERV reached out to staff the week of April 10th and advised his company had received two Dodge Chargers they had ordered last year with the intent to sell them individually these vehicles are slightly different in specifications than what was originally ordered and will cost approximately five hundred dollars per vehicle more than the original vehicles that were ordered. Staff did receive a quote for a Dodge Durango in early March 2020 when it was becoming evident the sedans that were ordered may not make production. This quote came back at \$6,805 dollars higher than the quoted Sedans.

Fiscal Impact: 2020 Budget

- 2 Dodge Charger Pursuit Sedans AWD at a total price of: \$39,689.90 per unit this includes all necessary equipment and upfitting costs.
- Winfield Motor Company: Unable to Quote
- Kline Motors: No Vehicle to Quote
- Superior SERV: \$39,689.90 per vehicle (this includes equipment and install costs as well)

Staff recommendation:

- 2 Dodge Charger Pursuit Sedans: accept the quote from Superior SERV at \$39,689.90 per vehicle (fully equipped)
- Only quote that met specifications came from Superior SERV
- Ford's Police Interceptor Sedan gasoline model was discontinued, and final orders were taken in early Q4 2018. The 2020 model offers a "pursuit rated" Fusion with an inline 4-cylinder gasoline-electric hybrid engine.
- Nissan Altima and Toyota Prius hybrids are being seen more in urban police fleets. Chevrolet discontinued production of police sedans in 2017, opting to concentrate on the police SUV and pickup markets. Like many other police

departments, WPD has been watching from the sidelines while hybrid vehicles have been tested in urban settings with mixed reviews.

- During 2021 budget meetings, staff will be discussing the direction of police vehicle purchases.
