## CITY COMMISSION MEETING MINUTES

Winfield, Kansas

May 4, 2020

The Board of City Commissioners met in regular session, Monday, May 04, 2020 at 5:30 p.m. in the City Commission-Community Council Meeting Room, City Hall; Mayor Phillip R. Jarvis presiding. Mayor Phillip R. Jarvis, and Commissioners Gregory N. Thompson and Ronald E. Hutto and William E. Muret, City Attorney were present by "Go to Meeting". Also in attendance were Taggart Wall, City Manager; and Brenda Peters, City Clerk. Other staff members present were Gary Mangus, Assistant to the City Manager; and Patrick Steward, Director of Public Improvements.

City Clerk Peters called roll. All Commissioners present.

Commissioner Thompson moved that the minutes of the April 20, 2020 meeting be approved. Commissioner Jarvis seconded the motion. With all Commissioners voting aye, motion carried.

### PUBLIC HEARING

-Consider Condemnation Proceedings for 520 E 10th Ave. Mayor Jarvis opened a public hearing to consider condemnation for 520 E 10<sup>th</sup> Ave. Simon Miers, 903 W Maple St Wichita, KS 67213-5509, owner, asked the Commission for a 30-day extension. He has not received the evaluation from the City Inspector. Director of Public Improvements Steward explained to the Commission that there are back taxes on the property as well as other expenses owed. Mr. Miers stated the back taxes would be paid within 30 days, and he would have a plan in place by then.

Mayor Jarvis closed the public hearing.

### BUSINESS FROM THE FLOOR

### NEW BUSINESS

**Bill No. 2031 – A Resolution** – Setting forth findings that the structure located on a tract of land legally described as follows: Lot 12 and the East Half (E1/2) of Lot 11, Block 209 Fullers Edition, to the City of Winfield, Cowley County, Kansas. Commonly known as 520 E. 10th Ave. Recorded in Book 0857 Page 0848, in the Office of the Register of Deeds of Cowley County, Kansas. is unsafe and/or dangerous and ordering said structures to be repaired or removed in ninety (90) days. Director of Public Improvements Steward explained to the Commission that this Resolution establishes a time period that a written plan must be submitted regarding the property. Upon motion by Commissioner Hutto, seconded by Commissioner Thompson, all Commissioners voting aye, Bill No. 2031 was adopted and numbered Resolution No. 2820.

**Bill No. 2032 – A Resolution** – Authorizing and granting a Conditional Use Permit to New Century Property Management, owner and Chris Tyler, agent, at 705 E. 9th Ave., Winfield, Kansas, to allow the construction of a two-family dwelling in a "R-1" Low Density Residential Zoned District. Director of Public Improvements Steward explained to the Commission that this Resolution considers granting a conditional use permit to New Century Property Management, owner and Chris Tyler, agent, for 705

E. 9th Ave to construct a two-family dwelling in a “R-1” Low Density Residential Zoned District. The Planning Commission held a public hearing and did recommend approval of the conditional use permit. Upon motion by Commissioner Thompson, seconded by Commissioner Hutto, all Commissioners voting aye, Bill No. 2032 was adopted and numbered Resolution No. 2920.

#### **OTHER BUSINESS**

-Consider certain CDBG Walnut River water line project approvals. City Manager Wall explains that there are three items for consideration under Other Business regarding the CDBG Waterline Replacement Project at the Fairgrounds.

1. Request for Funds-1st Draw on the project, vendor payments and City reimbursement. Commissioner Hutto moved that the Commission authorize Request for Payment No. 1 for Grant No 19-IT-002 totaling \$119,468.44. Motion was seconded by Commissioner Thompson. With all Commissioners voting aye, motion carried.

2. Policy for handling a Fair Housing/Civil Rights complaint(s) with our city. This has been our process but had not been formalized by policy. Required for the grant. Commissioner Thompson moved that the Commission adopt the procedures as presented within this Fair Housing/Civil Rights Policy. Motion was seconded by Commissioner Hutto. With all Commissioners voting aye, motion carried.

3. Contractor Classification Checklists identifies the characteristics that will exist between the City and vendors selected for goods and services provided within the grant. Commissioner Hutto moved that the Commission authorize the Mayor to execute as 1st Reviewer the Contractor Classification Checklists for Ditch Diggers, Salina, Professional Engineering Consultants, Wichita, and Northwest Kansas Planning and Development Commission, Hill City, Kansas Motion was seconded by Commissioner Thompson. With all Commissioners voting aye, motion carried.

-Consider Transmission Project Materials Procurement Letter with GridLiance, LLC. City Wall explains to the Commission that this letter between the City of Winfield and GridLiance, LLC, discusses the procurement of materials to build the transmission asset. Approval of this action would allow the City to reimburse GridLiance for the materials. Commissioner Thompson moved that the Commission authorize the letter to GridLiance be signed. Motion was seconded by Commissioner Hutto. With all Commissioners voting aye, motion carried.

#### **ADJOURNMENT**

Upon motion by Commissioner Hutto, seconded by Commissioner Thompson, all Commissioners voting aye, the meeting adjourned at 5:59 p.m.

**Action Requested:** 05/18/2020 Regular Commission Meeting-Consider an Ordinance authorizing an agreement between the Cities of Winfield and Arkansas City, and the Rural Fire District No. 6 (Strother Field), for fire protection services.

**Analysis:** The current Rural Fire District #6 fire protection service agreement terminates December 31, 2020. Staff from both Cities were in concurrence that a renewal agreement for 2021-2023 with the same terms and conditions as the current was suitable for services provided. The RFD#6 Bd approved the proposed 2021-2023 agreement, as presented, during their annual meeting, May 5th. Included are the alarm/response sheets presented by Winfield Fire/EMS.

**Fiscal Impact:** For the City of Winfield, the annual fee, 5 mills not less than \$55,000 split between the two cities, generated \$30,310 in 2018, \$27,968 in 2019, and \$15,453 in 2020 to date.

## AGREEMENT

THIS AGREEMENT, made and entered into this 5<sup>th</sup> day of May, 2020, by and between the City of Arkansas City, Kansas; the City of Winfield, Kansas, municipal corporations, hereinafter referred to as "Cities"; and Rural Fire District No. 6, Cowley County, Kansas, hereinafter referred to as "Fire District".

WHEREAS, the said Fire District is established and organized under the provision of K.S.A. 19-3601 to 19-3605, inclusive, and all acts amendatory thereof and supplemental thereto, which district is supervised by a Fire District Board of Trustees appointed and acting pursuant to K.S.A. 19-3612a and all acts amendatory thereof and supplemental thereto.

WHEREAS, the said Fire District desires to receive from the Cities certain fire protection as hereinafter set forth, and the Cities are willing and able to furnish such fire protection, and both the Fire District and the Cities desire to contract with reference thereto.

NOW, THEREFORE, in consideration of the mutual promises, covenants, and agreements of the parties thereto, the Fire District and the Cities agree as follows:

### SECTION ONE TERM

This agreement for fire protection service shall commence on the 1st day of January 2021, and terminate on December 31, 2023, provided, however, that either party may cancel the agreement by giving notice on or before July 1 of any year except 2023. The agreement would terminate 18 months after said July 1 notice unless the parties agree otherwise in writing. The governing body of the Cities and the Board of Trustees of the Fire District shall meet during the month of May of each year during the effective term of this agreement, to review the terms and conditions of this agreement and the fire protection service furnished thereunder. Any renegotiation for extension or renewal of this agreement shall be completed prior to July 1<sup>st</sup> of the year in which the change would take effect to allow the Cities and Fire District sufficient time to calculate and prepare their respective annual budgets.

### SECTION TWO FIRE PROTECTION

The Cities, during the effective term of this agreement, shall make reasonable effort to furnish fire fighting and related emergency services, road and weather conditions permitting. They shall utilize paid on-call and regular firemen employed by said Cities and fire fighting apparatus and equipment owned and operated by said Cities as determined by the official in charge. Cities have no obligation to attend fires where the value of the property which might be saved would be less than the cost to the Cities attending such fire. Either or both Cities shall not be obligated to respond to any fire call with equipment fighting a then existing fire, or where in the judgment of the fire official in charge, a condition exists which would likely result in substantial damage to fire fighting equipment or would deplete available fire fighting forces to an extent of jeopardizing fire protection to the Cities.



### SECTION THREE ANNUAL FEE

The Fire District shall pay to the Cities all revenues received from a five (5) mil ad valorem property tax levy on all taxable tangible property within the Fire District as authorized by Kansas law, provided such amount shall not be less than Fifty Five Thousand (\$55,000.00) Dollars. The proceeds of such tax levy and any other funds of any kind and source whatsoever to which the Fire District may be entitled as a result of said levy or the ability to levy taxes, shall be paid to the Cities with an equal amount going to each City for fire protection services rendered under this agreement. Said fire protection services payment shall be made by the Fire District within ten (10) days after the dates for distribution of taxes by the County Treasurer as provided by K.S.A. 12-1678a(c)(1). In the event said payments are not made to the Cities within said time, the Cities may terminate this agreement by providing thirty (30) days written notice of such fact to the Fire District.

### SECTION FOUR CONTROLLED BURNINGS

Any person within the territory of the said Fire District desiring to initiate a "controlled burning" of yards, pastures, or deteriorated buildings, must provide notice of and obtain consent to such burning in advance, and give notice of its completion.

### SECTION FIVE INDEMNITY

Cities shall not be liable in any way whatsoever to Fire District, its inhabitants, taxpayers, or employees, or to any other person, firm or corporation for failure of its fire department to attend any fire or for failure to extinguish a fire, for damage to goods, property or persons for any reason whatsoever, including but not limited to, negligence. Said Fire District agrees to indemnify and hold Cities harmless for any claim or judgment rendered against it or monies paid out in settlement or payment thereof or in cost of defense.

### SECTION SIX NONEXCLUSIVE CONTRACT

This agreement shall not be considered as exclusive and the said Fire District acknowledges that the Cities may enter into similar agreements with other fire districts, municipalities, governmental agencies, persons, firms, corporations, or any other instrumentalities.

SECTION SEVEN  
DISTRICT'S PUBLICATION EXPENSES

The Cities shall pay legal publication expenses of the Fire Districts which are required of said District to discharge its responsibilities under this agreement.

IN WITNESS WHEREOF, the parties have caused this agreement to be executed on their behalf respectively by the Mayors of the City of Arkansas City and the City of Winfield, Kansas, duly attested by the respective City Clerks, and by the Chairman of the Board of Trustees of Rural Fire District No. 6, Cowley County, Kansas, duly attested by the Secretary, the date and year first above written.


