# CITY COMMISSION MEETING MINUTES Winfield, Kansas August 17, 2020

The Board of City Commissioners met in regular session, Monday, August 17, 2020 at 5:30 p.m. in the City Commission-Community Council Meeting Room, City Hall; Mayor Phillip R. Jarvis presiding. Commissioner Gregory N. Thompson was also present and Ronald E. Hutto was present by "Go to Meeting". Also in attendance were Taggart Wall, City Manager; Brenda Peters, City Clerk and William E. Muret, City Attorney. Other staff members present were Gary Mangus, Assistant to the City Manager; Patrick Steward, Director of Public Improvements; Robbie DeLong; Police Chief; and Gus Collins, Director of Utilities.

Commissioner Thompson moved that the minutes of the August 3, 2020 meeting be approved. Commissioner Hutto seconded the motion. With all Commissioners voting aye, motion carried.

#### **BUSINESS FROM THE FLOOR**

#### NEW BUSINESS

**Bill No. 2047 – A Resolution** – Authorizing the offering for sale of Taxable General Obligation Bonds, Series 2020-a, of the City of Winfield, Kansas. Dave Arteberry, with Stifel Nicolaus present by "Go to Meeting", explained the benefits of private placement of bonds, and explained the process that the City will be going through for the sale of the bonds, and the timeline for the sale. Upon motion by Commissioner Hutto, seconded by Commissioner Thompson, all Commissioners voting aye, Bill No. 2047 was adopted and numbered Resolution No. 3820.

**Bill No. 2048 – An Ordinance –** Relating to and providing an amount of ad valorem tax to be levied as provided for under K.S.A. 79-1801 et seq. for the purpose of raising revenue for the General Fund, Bond & Interest Fund, Library Fund, Special Liability Fund, and the Industrial Development Fund. City Manager Wall explains that this Ordinance levies the taxes to support the 2021 Budget, and that there is a total ad valorem tax of \$3,908,676. Upon motion by Commissioner Thompson, seconded by Commissioner Hutto, all Commissioners voting aye, Bill No. 2048 was adopted and numbered Ordinance No. 4132.

**Bill No. 2049 – An Ordinance –** Adopting an annual budget of the City of Winfield, Kansas, for the year ending December 31, 2021, and providing for expenditures not to exceed amounts stated herein. City Manager Wall explains that this Ordinance adopts the 2021 Budget. Upon motion by Commissioner Hutto, seconded by Commissioner Thompson, all Commissioners voting aye, Bill No. 2049 was adopted and numbered Ordinance No. 4133.

**Bill No. 2050** – An Ordinance – Granting Gridliance High Plains LLC, a franchise for nonexclusive use of the public rights-of-way within the City of Winfield, Kansas to provide electric transmission service within the city. Director of Utilities Collins explains this Ordinance will complete the franchise agreement with Gridliance. Upon motion by Commissioner Thompson, seconded by Commissioner Hutto, all Commissioners voting aye, Bill No. 2050 was adopted and numbered Ordinance No. 4134.

**Bill No. 2051** – **An Ordinance** – Granting to USCOC Nebraska/Kansas, LLC, (USCOC), its successors and assigns, a Telecommunications Franchise and prescribing the terms of said grant and relating thereto. Director of Public Improvements Steward explains that this Ordinance approves a franchise agreement that specifies the responsibilities of the vendor for operating and maintaining their infrastructure. Upon motion by Commissioner Thompson, seconded by Commissioner Hutto, all Commissioners voting aye, Bill No. 2051 was adopted and numbered Ordinance No. 4135.

**Bill No. 2052 – A Resolution** – Authorizing and directing the Mayor and Clerk of the City of Winfield, Kansas, to execute a an agreement by and between the City of Winfield, Kansas, and USCOC Nebraska/Kansas, LLC ("USCOC") for joint use of poles associated with the City of Winfield's electric distribution and transmission systems. Director of Public Improvements Steward explains that this agreement would cover any poles that USCOC connects to, and the fees associated with the agreement. Upon motion by Commissioner Thompson, seconded by Commissioner Hutto, all Commissioners voting aye, Bill No. 2052 was adopted and numbered Resolution No. 3920.

**Bill No. 2053 – A Resolution** – Requesting the board of County Commissioners of Cowley County make a finding to determine that the annexation of land will not hinder or prevent the proper growth and development of the area or that of another incorporated city located in the County. City Manager Wall explains that this Resolution would request the board of County Commissioners of Cowley County to allow an annexation of 87 acres south of Winfield. Upon motion by Commissioner Hutto, seconded by Commissioner Thompson, all Commissioners voting aye, Bill No. 2053 was adopted and numbered Resolution No. 4020.

**Bill No. 2054 – A Resolution** – Authorizing and directing the City Manager of the City of Winfield, Kansas to execute a Farm Lease Agreement between the City of Winfield, Cowley County, Kansas and Charles Pilkington for property located at Highway 77 and Country Club Road (71st Road). City Manager Wall explains that this Resolution authorizes a farm lease agreement with Charles Pilkington who is the current tenant farmer for this property. Upon motion by Commissioner Thompson, seconded by Commissioner Hutto, all Commissioners voting aye, Bill No. 2054 was adopted and numbered Resolution No. 4120.

**Bill No. 2055 – A Resolution** – Authorizing the granting and filing of a certain permanent easement necessary to provide right-of-way for installation, construction, maintenance, repair, and removal of the utilities and the necessary appurtenances therefore, in, over, under, and across real estate in the East half of Section 33, Township 32 South, Range 4 East of the 6th Principal Meridian, Cowley County, Kansas. (City of Winfield) Director of Utilities Collins explains that the next three Bills are for easements for the river crossings on conjunction with Gridliance for the upcoming transmission project south of the City. Upon motion by Commissioner Thompson, seconded by Commissioner Hutto, all Commissioners voting aye, Bill No. 2055 was adopted and numbered Resolution No. 4220.

**Bill No. 2056 – A Resolution** – Authorizing the granting and filing of a certain permanent easement necessary to provide right-of-way for installation, construction, maintenance, repair, and removal of the utilities and the necessary appurtenances therefore, in, over, under, and across real estate in the East half of Section 33, Township 32 South, Range 4 East of the 6th Principal Meridian, Cowley

County, Kansas. Upon motion by Commissioner Thompson, seconded by Commissioner Hutto, all Commissioners voting aye, Bill No. 2056 was adopted and numbered Resolution No. 4320.

**Bill No. 2057 – A Resolution** – Accepting and authorizing the filing of a certain permanent easement necessary to provide right-of-way for installation, construction, maintenance, repair, and removal of the utilities and the necessary appurtenances therefore, in, over, under, and across real estate as described as the East 70 feet of the South 1280.35 feet of the Southeast Quarter of Section 33, Township 32 South, Range 4 East of the 6th P.M., less existing county road right-of-way. Upon motion by Commissioner Hutto, seconded by Commissioner Thompson, all Commissioners voting aye, Bill No. 2057 was adopted and numbered Resolution No. 4420.

**Bill No. 2058 – A Resolution** – Authorizing the Mayor and City Clerk of the City of Winfield, Kansas, to execute a Quit Claim Deed between the City of Winfield, Kansas, and Scott McNown and Andrea McNown regarding the transfer of real property as listed in Section 1 of this resolution. City Manager Wall explains that this Resolution authorizes the Mayor to execute a deed which completes the previous actions in relation to the upcoming transmission project. Upon motion by Commissioner Thompson, seconded by Commissioner Hutto, all Commissioners voting aye, Bill No. 2058 was adopted and numbered Resolution No. 4520.

# **OTHER BUSINESS**

Mayor Jarvis explains that there was a discussion at work session, including all the City Commissioners and Tom Langer, Director of Cowley County Health Department. #### **ORDINANCE NO. 4136**

### AN ORDINANCE APPROVING THE FORM OF AND AUTHORIZING THE EXECUTION OF AN INTERLOCAL COOPERATION AGREEMENT RESPECTING THE FINANCING OF THE ACQUISITION OF CERTAIN REAL PROPERTY AT STROTHER FIELD AIRPORT/INDUSTRIAL PARK.

WHEREAS, K.S.A. 12-2901 *et seq*. (the "Act") provides that in order for public agencies to make the most efficient use of their powers, such public agencies may cooperate with other public agencies on a basis of mutual advantage to provide services and facilities in a manner that will best accord with geographic, economic and other factors influencing the needs and development of such public agencies; and

**WHEREAS**, the Act authorizes public agencies to enter into interlocal agreements with one or more other public agencies for joint or cooperative action pursuant to the provisions of the Act; and

**WHEREAS**, the City of Winfield, Kansas (the "City") and the City of Arkansas City, Kansas ("Arkansas City") have heretofore entered into an interlocal agreement pursuant to the Act to provide for the management and operation of the Strother Field Airport/Industrial Park, which such cities jointly own as tenants in common, and to provide for the creation of the Strother Field Commission, a separate legal entity and body corporate and politic, to which such cities have delegated operation and management responsibilities respecting the Strother Field Airport/Industrial Park; and

**WHEREAS**, the City is a public agency within the State of Kansas and, pursuant to the Act, it is necessary and advisable to enter into an interlocal agreement with Arkansas City and the Strother Field Commission, other public agencies of the State of Kansas, to jointly provide for certain matters respecting the acquisition of certain real property and the building thereon located at the Strother Field Airport/Industrial Park (the "Project") for use by the cities and the Strother Field Commission and the financing and payment of the costs thereof.

# NOW THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WINFIELD, KANSAS:

**SECTION 1.** The City is hereby authorized to enter into an "INTERLOCAL COOPERATION AGREEMENT RESPECTING THE ACQUISITION OF CERTAIN REAL PROPERTY AT STROTHER FIELD AIRPORT/INDUSTRIAL PARK AND THE FINANCING THEREOF" (the "Agreement") with Arkansas City and the Strother Field Commission to jointly provide for certain matters respecting the Project and the financing and payment of the costs thereof. The form of the Agreement presented to the governing body of the City this date is hereby approved, and the Mayor and Clerk are hereby authorized to execute the Agreement in that form, with ministerial changes as may be approved by the Mayor, whose execution of the Agreement shall evidence any such approval.

**SECTION 2.** This Ordinance shall take effect and be in full force from and after its passage by the governing body and publication of the Ordinance or a summary thereof in the official City newspaper.

### INTERLOCAL COOPERATION AGREEMENT RESPECTING THE ACQUISITION OF CERTAIN REAL PROPERTY AT STROTHER FIELD AIRPORT/INDUSTRIAL PARK AND THE FINANCING THEREOF

This Interlocal Agreement, made pursuant to the statutory provisions of K.S.A. 12-2901 *et seq.*, and all acts amendatory thereof or supplemental thereto (the "Act"), is entered into as of [Effective Date], by and between:

#### The City of Arkansas City, Kansas

herein referred to as "Arkansas City," and

#### The City of Winfield, Kansas

herein referred to as "Winfield," and

#### The Strother Field Commission

herein referred to as the "Strother Field Commission"

WHEREAS, Winfield and Arkansas City own, as tenants in common, certain real estate in Cowley County, Kansas, and Sumner County, Kansas, which is described as follows (the "Strother Field Airport/Industrial Park"): Strother Field in Cowley County, Kansas consisting of approximately 1,440 acres; and

WHEREAS, Arkansas City and Winfield have heretofore entered into an interlocal agreement pursuant to the Act, dated September 19, 1966, respecting the management and operation of Strother Field Airport/Industrial Park for the mutual benefit, protection, advantage and economic development of Arkansas City and Winfield, and pursuant to that agreement have established a separate legal entity and body corporate and politic known as the "Strother Field Commission" and prescribed that such entity be responsible for such management and operation; and

**WHEREAS**, it is necessary and advisable to acquire certain real property and the building thereon located at the Strother Field Airport/Industrial Park for use by the cities and the Strother Field Commission at an estimated cost of approximately \$1,300,000 (the "Project"); and

**WHEREAS**, it is necessary and advisable that the costs of the Project be financed and paid through the issuance of general obligation bonds by Winfield (the "Bonds"); and

**WHEREAS**, the Project will benefit all parties to this Agreement and it is necessary and advisable to prescribe the manner in which each of the parties will share and contribute to the payment of the Bonds issued to finance the Project.

NOW, THEREFORE, IN CONSIDERATION OF THE AFORESTATED PREMISES and the mutual benefits to the participants which shall accrue by virtue of this Agreement, the parties hereto covenant and agree:

**Section 1. Obligations of Strother Field Commission**. Strother Field Commission shall be fully responsible for all amounts necessary to pay the principal of and interest on the Bonds (the "Debt

Service Requirements") as the same become due. Upon the sale and delivery of the Bonds, Winfield shall provide to Strother Field Commission and Arkansas City a debt service schedule (the "Debt Service Schedule") setting forth the amounts of the Debt Service Requirements due on the Bonds and the dates on which such amounts are due (the "Bond Payment Dates"). Strother Field Commission shall remit full payment for its obligations hereunder to Winfield, with such amounts being received by Winfield not less than 30 days prior to the respective Bond Payment Date, as shown by the Debt Service Schedule. If the Strother Field Commission fails to satisfy its payment obligations hereunder, Arkansas City and Winfield may exercise any remedy then available at law or in equity.

Section 2. Allocation of Costs between Arkansas City and Winfield. If the Strother Field Commission does not for any reason satisfy its payment obligations prescribed in the preceding *Section 1*, Arkansas City and Winfield shall each be responsible for paying one-half of the Debt Service Requirement as the same become due. If payment from the Strother Field Commission is not received by Winfield as prescribed in the preceding *Section 1*, Winfield will promptly give notice thereof to Arkansas City and Arkansas City shall, within 10 days of receipt of such notice, remit to Winfield payment for one-half of the Debt Service Requirement due on the Bonds, for which payment from the Strother Field Commission was not remitted. The parties hereto acknowledge that the obligations of Arkansas City under this Agreement are subject to K.S.A. 10-1101 *et seq.* and as such Arkansas City is obligated hereunder only to the extent that it has funds actually on hand in its treasury at the time for such purpose.

**Section 3.** Acquiring, Holding, Disposing of Property. Winfield and Arkansas City, as tenants in common, are authorized to acquire, own, and hold property for the use and benefit of the Strother Field Commission. The Strother Field Commission shall enforce the performance of all contracts and work, and have charge and custody of all the property, assets, books, and records belonging to the Strother Field Airport/Industrial Park; providing that nothing herein shall be construed to authorize a sale of Strother Field Airport/Industrial Park properties without an affirmative vote of the governing body of both cities as provided by law; but said Strother Field Commission may provide for the sale or other disposition of any useless, worn-out, obsolete, or surplus supplies, equipment, or structures not then useful in the operation of the Strother Field Airport/Industrial Park.

**Section 4. Term and Termination**. This Agreement shall remain in full force and effect until the Bonds issued by Winfield (for a primary term of ten (10) years) mature and are paid, unless earlier terminated by consent of Winfield, Arkansas City and Strother Field Commission. Notwithstanding any termination of this Agreement, the obligations of the parties with respect to the Bonds shall continue until the Bonds and interest thereon are paid in full and retired. Upon termination as herein set forth, the manager of the Strother Field Airport/Industrial Park shall, with assistance of authorized auditors, account to Winfield and Arkansas City as tenants in common.

**Section 5.** Administration. Winfield shall be responsible for administering the undertaking set forth in this Agreement.

**Section 6. Provisions**. This Agreement shall be in full force and effect upon execution by the parties hereto. If one or more provisions of this Agreement are hereafter found void or unenforceable as contrary to the law, the remaining provisions shall nevertheless remain in full force and effect and only such provisions as are specifically found invalid shall be null and without effect.

**THIS AGREEMENT** is authorized by K.S.A. 12-2901 *et seq.* as each of the contracting parties hereto are public agencies as described therein.

<u>Section 2.</u> The Clerk of the City of Winfield, Cowley County, Kansas, is hereby authorized and directed to file a certified copy of this ordinance with the Register of Deeds for Cowley County, Kansas.

Action Requested: September 8, 2020 Commission Agenda-Resolution authorizing an Outdoor Community Event and Temporary Entertainment District Application (TED), Winfield Arts & Humanities.

**Analysis:** The 2020 Art in the Park OCE/TED application by Winfield Arts & Humanities requests that Kansas farm winery licensees, again, be authorized to serve samples free of charge and sell unopened containers of their domestic wines during Art in the Park, a special event, from 10:00 am to 5:00 pm, on October 3, 2020, in Rotary Pavilion within Island Park.

A Kansas farm winery licensee may serve samples free of charge and sell unopened containers of its domestic wine off the farm winery premises at "special events monitored and regulated by the division of ABC" [Subsection (a)(4) of K.S.A. 41-308a]. The farm winery licensee must complete and submit form ABC-842 not less than 10 days prior to the event. A separate Temporary Alcohol Permit is not required of Winfield Arts and Humanities Council or the Kansas farm winery licensees.

## **A RESOLUTION**

# **AUTHORIZING** an Outdoor Community Event and Temporary Entertainment District Application (Winfield Arts and Humanities Council)

**WHEREAS**, Winfield Arts and Humanities Council has made application for an Outdoor Community Event and Temporary Entertainment District; and

**WHEREAS**, Winfield Arts and Humanities Council requests that Kansas farm winery licensees be authorized to serve samples free of charge and sell unopened containers of their domestic wines during Art in the Park, a special event, from 10:00 am to 5:00 pm, on October 3, 2020, in a designated area within Island Park, 200 Main Street.

# NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF WINFIELD, KANSAS, THAT:

<u>Section 1.</u> Within Section 6-120 of Article IV of Section 6 of the Code of the City of Winfield, Kansas, "Temporary Entertainment District" means a defined area, which includes City streets, alleys, parking lots and public sidewalks on which the City Commission has authorized the sale, possession or consumption of alcoholic liquor or cereal malt beverage for a specified period of time, during Art in the Park, a special event, which has been properly permitted under Chapter 8 of this Code.

Section 2. A Special Event is defined by K.S.A. 41.719(a)(2). Alcoholic liquor may be consumed at a special event held on public streets, alleys, roads, sidewalks or highways when a temporary permit has been issued pursuant to K.S.A. 41-2645 for such special event. Such special event must be approved, by ordinance or resolution, by the local governing body of any city, county or township where such special event is being held. No alcoholic liquor may be consumed inside vehicles while on public streets, alleys, roads or highways at any such special event.

<u>Section 3.</u> A Kansas farm winery licensee may serve samples free of charge and sell unopened containers of its domestic wine off the farm winery premises at "special events monitored and regulated by the division of ABC" [Subsection (a)(4) of K.S.A. 41-308a]. "Special Event" is defined as a public or private gathering of two or more persons, arranged for a specific commercial, charitable or social purpose, having a limited duration and not conducted in the ordinary course of business. "Monitored and regulated" is not defined. The ABC therefore construes the term to require the Director's permission before a farm winery licensee may

participate in special event. The farm winery licensee shall complete and submit form ABC-842 not less than 10 days prior to the event. No special event can be held on a premise that possesses a private club liquor license or cereal malt beverage license; or, in a location where liquor by the drink or retail sales are not authorized. A separate Temporary Alcohol Permit is not required of Winfield Arts and Humanities Council or Kansas farm winery licensees.

Section 4. The governing body of the city of Winfield Kansas hereby authorizes the Outdoor Community Event and Temporary Entertainment District Application, in accordance with the rules and procedures set forth by Article IV of Section 6 of the Code of the City of Winfield, Kansas, regarding the sale, possession or consumption of alcoholic liquor as presented by the Winfield Arts and Humanities Council for an event from 10:00 am to 5:00 pm, on October 3, 2020, in a designated area within Island Park, 200 Main, as identified in the Outdoor Community Event and Temporary Entertainment District Application; a copy of which is attached hereto and made a part hereof.

Section 5. This resolution shall be in full force and effect from and after its passage and approval.

The City of Winfield defines an Outdoor Community Event as follows:

Outdoor event on public property organized for a particular and limited purpose and time. Such events shall include, but not be limited to: fun runs, roadway foot races, fundraising walks, bikeathons, motor vehicle events, bike races, carnivals, festivals, cookouts, block parties, community celebrations, shows, exhibitions, circuses, fairs and temporary entertainment districts. Such term shall also include parades when held in conjunction with a community event as defined by this section, which event is sponsored or conducted by the same applicant. Such term shall not include events occurring solely on sidewalks or public rights of way immediately adjacent to public streets that do not require the closing of the sidewalk or public way.

The City of Winfield defines a Temporary Entertainment District as follows:

A defined area, which includes City streets, alleys, parking lots and public sidewalks on which the City Commission has authorized the sale, possession or consumption of alcoholic liquor or cereal malt beverage for a specified period of time, during a Community Event which has been properly permitted.

#### General Information:

It is the purpose of this application to establish a process for permitting community events to use City streets, sidewalks, parks and alleys. It is unlawful for any person to conduct a community event without a community event permit. Any information required by the application must be complete upon submittal. Incomplete applications may be denied. The City of Winfield may refuse any application received less than 30 days before the event or lacking requested information. When received, an application is subject to approval of all departments involved and will be required to provide the following:

-The Winfield Police Department, the Winfield Fire Department and authorized representatives of such departments shall be responsible for the enforcement of all provisions of this application.

-No fee shall be charged for the application or permit for a Community Event itself.

-The issuance of a Community Event permit shall not negate the responsibility of the permit holder to acquire all other necessary and applicable licenses or permits which may be required for the event or pay any additional fees. -Street closure request made to the City of Winfield.

-Certificate of Liability Insurance naming the City of Winfield as additionally insured, if applicable.

-Security requirements including hiring of certified law enforcement officers.

-All Food/Beverage/Concessionaire/Amusement vendors list including contact person, contact information, and permits/licenses, as necessary.

-Outdoor Community Events shall cease between the hours of 11:00 p.m. and 8:00 a.m., Sunday through Thursday and midnight to 8:00 a.m. on Friday and Saturday.

-A detailed Security Plan will be required and approved by Winfield Chief of Police. Extraordinary Police/Fire services will be billed directly to the permit holder and will be the permit holder's responsibility.



**Requestor: Kyle Gillett, Interim Power Plant Supervisor** 

**Action Requested:** Consider approval of funds for replacement of hydrogen control system at Winfield Power Plant (see attached configuration)

**Analysis:** The Winfield Power Plant uses hydrogen as a means for cooling of the generator. The current hydrogen control system at the Winfield Power Plant is original to the facility which began construction in 1968. The system has become unreliable. The control panel gives the Power Plant Operators an indication of the purity of the H2, but the accuracy of the readings has been become a concern.

The replacement system offered by MD&A includes an automated purge package that would allow the Operators to purge the system in 20 - 40 minutes, with it currently being a manual all-day process. It would restore reliability and ensure accurate readings regarding hydrogen purity levels. Hydrogen can become explosive when the purity levels are not properly maintained.

The GE proposal does not include an automated purge package. I contacted GE and they informed me to include the automated purge system would increase the cost by over \$300,000.

Fiscal Impact: We obtained estimates for a replacement hydrogen control system from two companies. The companies were GE, and MD&A Control Systems. The estimates were as follows.

- GE \$173,328
- MD&A Control Systems \$257,600

The proposal from MD&A is for a turn-key hardware and installation package with the automated purge system included. The quote from GE only covers material and five days of technical direction by the cabinet vendor, with additional time costing extra and again, it does not include automated purge capabilities.

Taking these factors into consideration, staff recommends proceeding with MD&A as the contractor for this project.

Action Requested: Consider approval of funds for replacement of technology system servers.

**Analysis:** The City has planned for server replacement to occur in the 2020 and 2021 budgets. The current servers are 8 years old and have exceeded their useful life. Currently, the City is undertaking a large software project as well as a move to a new facility in 2021 for Fire/EMS that will coordinate with this project.

This summer, the City received bids on the replacement of one server and an alternative bid for total replacement of all three servers.

The replacement of all three servers at once will afford the City significant savings, rather than spreading them out over two years. The low bidder price for one server is  $\sim$ \$47k vs.  $\sim$ \$98k for three.

Two manufacturers with similar specs were competed for the project: HP and Dell. The HP servers were selected as the best option for the City. Dell pricing was ~\$212k for the same project.

The HP servers will have higher end specs than the Dells and are about 1/2 the cost.

We have used HP server for at least 15 years and have been very pleased with their Support and reliability.

Staff recommends moving forward with the full project in 2020 vs spreading the cost over two years.
