**Action Requested:** Approval of an ordinance modifying the prohibition of minors in drinking establishments.

**Analysis:** A new business in downtown Winfield, a microbrewery, has requested the governing body consider an ordinance change that would allow for minors, when accompanied by a parent or legal guardian, to be present with them inside the microbrewery up until 8:00p.m.

Staff recommends the time be set at 10:00p.m. to allow for anticipated evening use during the summer months and to reduce the likelihood of challenges to the rule.

The ordinance would be congruent with industry standards that have been made applicable to microbreweries in other parts of the state including Wichita.

Fiscal Impact: None.

**ORDINANCE NO. 4159** 

#### AN ORDINANCE

AMENDING Chapter 6 of The Winfield City Code pertaining to the prohibition against allowing minors on the premises of licensed drinking establishments and permitting exceptions thereto.

## NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WINFIELD, KANSAS, THAT:

<u>Section 1</u>. Chapter 6, Section 164 of the Municipal Code of the City of Winfield shall read as follows:

It is unlawful for any person under the age of 21 years to enter or to remain in a drinking establishment, and it is unlawful for the proprietor or agent or servant thereof to permit any such underage person in such drinking establishment, with the following exceptions:

- (1) A licensee's employee who is not less than 18 years of age may work on the premises where alcoholic liquor is sold under the on-premises supervision of either the licensee or permit holder or an employee who is 21 years of age or older.
- (2) Underage persons are permitted if the licensee's place of business is a restaurant, as defined by state law, and not less than 30 percent of the gross receipts from the licensee's place of business is derived from the sale of food for consumption on the premises of the licensee's place of business.
- (3) An independent contractor with the licensee who is not less than 18 years of age, including, but not limited to, a member of a performing musical group or person doing repairs or renovations, may be on the premises if under the on-premises supervision of either the licensee or permit holder or an employee who is 21 years of age or older.
- (4) The provisions of this section apply only to drinking establishments, as defined in Section 6-1 of this Code and amendments thereto but not to drinking establishments also licensed as a microdistillery or a microbrewery by the State of Kansas. Provided, however, minors will be allowed on the premises of drinking establishments also licensed as a microbrewery by the State of Kansas only when accompanied by the minor's parent or legal guardian and are not allowed on such premises after 10:00 p.m. on any day."

<u>Section 2</u>. This ordinance shall be in full force and effect from and after its publication in the official city newspaper.

**Action Requested:** Approval of an ordinance modifying camping regulations in the City of Winfield for Parks and other public streets, right of way, etc.

**Analysis:** The current ordinances have certain omissions when it comes to camping in parks and other public areas. In some cases, undue resources have been required for the public health and safety from parks crews and police services related to camping outside defined camping areas.

To most efficiently manage the use of these spaces, staff has worked with the city attorney to construct language that mirrors regulatory language used in the federal park system. In addition, some modifications to "open" hours in parks has been recommended to provide uniformity.

The changes still allow fee-based camping in designated areas, which are currently set as the fairgrounds, Tunnel Mill Dam and the Winfield City Lake. The city manager may designate additional camping spaces.

Fiscal Impact: Reallocation of existing resources including labor and equipment.

#### AN ORDINANCE

AMENDING Chapter 62 and Chapter 70 of The Winfield City Code by the modification of closing hours for parks, defining camping within the within the Winfield Parks system and on public streets or right-of-way.

## NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WINFIELD, KANSAS, THAT:

Section 1. Chapter 62, Section 54 of the Municipal Code of the City of Winfield shall read as follows:

Closing hours for certain parks

The areas designated as Island Park, Winfield Aquatic Center, Cochran Park, Memorial Park, Lion's Club Park, Albright Park, Hyatt Hills Park, Cherry Street Park, Jaycee Park, Black Creek Park and the Broadway Recreation Complex as set forth in section 62-32, shall be closed to use by the public from the hours of 11:00 p.m. to 5:00 a.m. daily, except as authorized by the city manager or his designee.

Section 2. Chapter 62, Section 55 of the Municipal Code of the City of Winfield shall read as follows:

(a) Camping means the erecting of a tent or shelter of natural or synthetic material, preparing a sleeping bag or other bedding material for use, parking of a motor vehicle, motor home or trailer, or mooring of a vessel for the apparent purpose of overnight occupancy.

(b) To provide for the efficient and effective utilization of the park and fairground camping facilities, the city manager, or his authorized representative, is hereby authorized to designate those areas of the city parks and fairgrounds wherein camping shall be permitted.

(c) No person shall park a recreational vehicle or camp in the park or fairground camping areas for more than 14 consecutive days without vacating the campgrounds area for at least five consecutive days before returning to the previously occupied campground area. Special extension provisions, upon request, may be granted by the city manager or his authorized representative on city forms available at the lake office or city hall.

(d) No person shall camp in a park without paying the fee specified in section 34-62.

(e) No person occupying an authorized camp in a public space shall allow for the camp to cause, keep or permit any nuisance as defined in section 54-2.

Section 3. Chapter 70, of the Municipal Code of the City of Winfield shall be amended to add Section 70-19, which shall read as follows:

Sec. 70-19

(a) No person shall camp within any public sidewalk, public parking-lot, public street, public right-of-way, public alley or public drainageway except as authorized by the city manager or his designee. Camping shall be defined as set forth in Sec. 62-55.

Section 4. This ordinance shall be in full force and effect from and after its publication in the official city newspaper.

Analysis: The Jayhawk Advisory Council requests the possession and consumption of alcoholic liquor or cereal malt beverage at Quail Ridge Golf Course, including the clubhouse, parking, on the golf course or on the driving range from 7:00 am-7:00 pm during the Kansas Air National Guard Lyle Houghton Cancer Benefit Golf Tournament, Saturday, August 14, 2021.

There will be no sales of alcohol or beer as part of the event. All is provided via sponsor. With adoption of this Resolution, identifying the Kansas Air National Guard Lyle Houghton Cancer Benefit Golf Tournament as a special event, the Governing Body would authorize the request for possession and consumption of alcoholic liquor or cereal malt beverage as a Temporary Entertainment District. A Temporary Alcohol or Cereal Malt Beverage Permit is not required of Jayhawk Advisory Council for possession and consumption only.

Fiscal Impact: Winfield/Quail Ridge Golf Course will host the Kansas Air National Guard Lyle Houghton Cancer Benefit Golf Tournament for the second time in 2021. 216 golfers and 30+ volunteers support this long running event.

#### **A RESOLUTION**

AUTHORIZING an Outdoor Community Event and Temporary Entertainment District Application (Jayhawk Advisory Council)

**WHEREAS**, the Jayhawk Advisory Council, McConnell AFB/KS has made application for an Outdoor Community Event and Temporary Entertainment District; and

**WHEREAS**, the Council requests the possession and consumption of alcoholic liquor or cereal malt beverage at Quail Ridge Golf Course, including the clubhouse, parking, on the golf course or on the driving range during the Kansas Air National Guard Lyle Houghton Cancer Benefit Golf Tournament, Saturday, August 14, 2021.

#### NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF WINFIELD, KANSAS, THAT:

<u>Section 1.</u> Within Section 6-120 of Article IV of Section 6 of the Code of the City of Winfield, Kansas, "Temporary Entertainment District" means a defined area, which includes City streets, alleys, parking lots and public sidewalks on which the City Commission has authorized the sale, possession or consumption of alcoholic liquor or cereal malt beverage for a specified period of time, during a community event which has been properly permitted under Chapter 8 of this Code.

Section 2. The Jayhawk Advisory Council requests the possession and consumption of alcoholic liquor or cereal malt beverage at Quail Ridge Golf Course, including the clubhouse, parking, on the golf course or on the driving range, from 7:00 am to 7:00 pm during the Kansas Air National Guard Lyle Houghton Cancer Benefit Golf Tournament on Saturday, August 14, 2021.

A Temporary Alcohol or Cereal Malt Beverage Permit is not required of the Jayhawk Advisory Council for possession and consumption only. Should events require postponement and rescheduling of the tournament, notice will be given to the Winfield City Manager's office. The parties will coordinate, to the best of their abilities, rescheduling in 2021. No further action will be required by the Governing Body of the City of Winfield for said rescheduling in 2021.

<u>Section 3.</u> The governing body of the city of Winfield Kansas hereby authorizes the Outdoor Community Event and Temporary Entertainment District Application, in accordance with the rules and procedures set forth by Article IV of Section 6 of the Code of the City of Winfield, Kansas, regarding the possession or consumption of alcoholic liquor or cereal malt

beverage at Quail Ridge Golf Course, including the clubhouse, parking, on the golf course or on the driving range, from 7:00 am to 7:00 pm during the Kansas Air National Guard Lyle Houghton Cancer Benefit Golf Tournament on Saturday, August 14, 2021, as identified in the Outdoor Community Event and Temporary Entertainment District Application; a copy of which is attached hereto and made a part hereof.

Section 5. This resolution shall be in full force and effect from and after its passage and approval.

#### The City of Winfield defines an Outdoor Community Event as follows:

• Outdoor event on public property organized for a particular and limited purpose and time. Such events shall include, but not be limited to fun runs, roadway foot races, fundraising walks, bikeathons, motor vehicle events, bike races, carnivals, festivals, cookouts, block parties, community celebrations, shows, exhibitions, circuses, fairs and temporary entertainment districts. Such term shall also include parades when held in conjunction with a community event as defined by this section, which event is sponsored or conducted by the same applicant. Such term shall not include events occurring solely on sidewalks or public rights of way immediately adjacent to public streets that do not require the closing of the sidewalk or public way.

#### The City of Winfield defines a Temporary Entertainment District as follows:

• A defined area, which includes City streets, alleys, parking lots and public sidewalks on which the City Commission has authorized the sale, possession or consumption of alcoholic liquor or cereal malt beverage for a specified period of time, during a Community Event which has been properly permitted.

#### General Information:

It is the purpose of this application to establish a process for permitting community events to use City streets, sidewalks, parks and alleys. It is unlawful for any person to conduct a community event without a community event permit. Any information required by the application must be complete upon submittal. Incomplete applications may be denied. The City of Winfield may refuse any application received less than 30 days before the event or lacking requested information. When received, an application is subject to approval of all departments involved and will be required to provide the following:

- The Winfield Police Department, the Winfield Fire Department and authorized representatives of such departments shall be responsible for the enforcement of all provisions of this application.
- No fee shall be charged for the application or permit for a Community Event itself.
- The issuance of a Community Event permit shall not negate the responsibility of the permit holder to acquire all other necessary and applicable licenses or permits which may be required for the event or pay any additional fees.
- Street closure request made to the City of Winfield.
- Certificate of General Liability Insurance naming the City of Winfield as additionally insured, *if applicable*.
- Security requirements including hiring of certified law enforcement officers.
- All Food/Beverage/Concessionaire/Amusement vendors list including contact person, contact information, and permits/licenses, as necessary.
- Outdoor Community Events shall cease between the hours of 11:00 p.m. and 8:00 a.m., Sunday through Thursday and midnight to 8:00 a.m. on Friday and Saturday.
- A detailed Security Plan will be required and approved by Winfield Chief of Police. Extraordinary Police/Fire services will be billed directly to the permit holder and will be the permit holder's responsibility.
