CITY COMMISSION MEETING MINUTES Winfield, Kansas April 4, 2022

The Board of City Commissioners met in regular session, Monday, April 04, 2022 at 5:30 p.m. in the City Commission-Community Council Meeting Room, City Hall; Mayor Ronald E. Hutto presiding. Commissioners Gregory N. Thompson and Brenda K. Butters were also present. Also in attendance were Taggart Wall, City Manager; Brenda Peters, City Clerk; and William E. Muret, City Attorney. Other staff members present were Patrick Steward, Director of Community Development; Eryn Ebach Freund, Community Development Coordinator/Planner; and Gus Collins, Director of Utilities.

City Clerk Peters called roll.

Commissioner Butters moved that the minutes of the March 17, 2022 meeting be approved. Commissioner Thompson seconded the motion. With all Commissioners voting aye, motion carried.

PROCLAMATION

-Proclaiming the Month of April as Fair Housing Month. Mayor Hutto proclaimed the month of April 2022 as Fair Housing Month.

PUBLIC HEARING

-Regarding the issuance of Taxable Industrial Revenue Bonds (Petra Winfield Residences Project), in a principal amount not to exceed \$27,550,000 and an exemption from ad valorem taxation of property constructed or purchased with the proceeds of such Bonds. Mayor Hutto opened a public hearing regarding the issuance of Taxable Industrial Revenue Bonds. Vince McMullen, 2109 Mound St, appeared to ask the Commission about the bonds. After some discussion, the Mayor closed the public hearing.

BUSINESS FROM THE FLOOR

NEW BUSINESS

Bill No. 2229 – A Resolution – Of the Governing Body of the City of Winfield, Kansas determining the advisability of issuing Taxable Industrial Revenue Bonds for the purpose of financing the acquisition, construction, and equipping of a commercial facility to be located in the City, and authorizing execution of related documents. City Manager Wall explains these bonds would support a development containing approximately 203 units located at Bliss Street and 19th Avenue in Winfield. Upon motion by Commissioner Thompson, seconded by Commissioner Butter, all Commissioners voting aye, Bill No. 2229 was adopted and numbered Resolution No. 3021.

Bill No. 2230 – An Ordinance – Accepting and authorizing the filing of the final plat of Petra Win Residences, a Subdivision in the Northeast Quarter of Section 33, Township 32 South, Range 4 East of the 6th P.M., Cowley County, Kansas. Community Development Coordinator/Planner Ebach Freund explains the Planning Commission received a Petition for final plat approval of Petra Win Residences.

Based on the planning commission's findings, the property met the necessary criteria to recommend approval of the final plat. Upon motion by Commissioner Butters, seconded by Commissioner Thompson, all Commissioners voting aye, Bill No. 2230 was adopted and numbered Ordinance No. 4154.

Bill No. 2231 – A Resolution – Authorizing an Outdoor Community Event and Temporary Entertainment District Application. (Island Park Productions) City Manager Wall explains this Resolution authorizes the possession and consumption of alcoholic liquor or cereal malt beverage in Island Park during a series of outdoor concert events over the summer. Upon motion by Commissioner Jarvis, seconded by Commissioner Hutto, all Commissioners voting aye, Bill No. 2231 was adopted and numbered Resolution No. 3121.

OTHER BUSINESS

-Consider approval for 2022 substation technical support program with Southwest Electric Company. Director of Utilities Collins explains this program provides substation equipment maintenance and testing by an electrical contractor on a three-year rotation. Commissioner Thompson moved to accept the bid from Southwest Electric Company at a cost of \$39,425.00 for the 2022 substation technical support program. Motion was seconded by Commissioner Butters. With all Commissioners voting aye, motion carried.

The City of Winfield defines an Outdoor Community Event as follows:

• Outdoor event on public property organized for a particular and limited purpose and time. Such events shall include, but not be limited to fun runs, roadway foot races, fundraising walks, bikeathons, motor vehicle events, bike races, carnivals, festivals, cookouts, block parties, community celebrations, shows, exhibitions, circuses, fairs and temporary entertainment districts. Such term shall also include parades when held in conjunction with a community event as defined by this section, which event is sponsored or conducted by the same applicant. Such term shall not include events occurring solely on sidewalks or public rights of way immediately adjacent to public streets that do not require the closing of the sidewalk or public way.

The City of Winfield defines a Temporary Entertainment District as follows:

• A defined area, which includes City streets, alleys, parking lots and public sidewalks on which the City Commission has authorized the sale, possession or consumption of alcoholic liquor or cereal malt beverage for a specified period of time, during a Community Event which has been properly permitted.

General Information:

It is the purpose of this application to establish a process for permitting community events to use City streets, sidewalks, parks and alleys. It is unlawful for any person to conduct a community event without a community event permit. Any information required by the application must be complete upon submittal. Incomplete applications may be denied. The City of Winfield may refuse any application received less than 30 days before the event or lacking requested information. When received, an application is subject to approval of all departments involved and will be required to provide the following:

- The Winfield Police Department, the Winfield Fire Department and authorized representatives of such departments shall be responsible for the enforcement of all provisions of this application.
- No fee shall be charged for the application or permit for a Community Event itself.
- The issuance of a Community Event permit shall not negate the responsibility of the permit holder to acquire all other necessary and applicable licenses or permits which may be required for the event or pay any additional fees.
- Street closure request made to the City of Winfield.
- Certificate of General Liability Insurance naming the City of Winfield as additionally insured, *if applicable*.
- Security requirements including hiring of certified law enforcement officers.
- All Food/Beverage/Concessionaire/Amusement vendors list including contact person, contact information, and permits/licenses, as necessary.
- Outdoor Community Events shall cease between the hours of 11:00 p.m. and 8:00 a.m., Sunday through Thursday and midnight to 8:00 a.m. on Friday and Saturday.
- A detailed Security Plan will be required and approved by Winfield Chief of Police. Extraordinary Police/Fire services will be billed directly to the permit holder and will be the permit holder's responsibility.

Action Requested: Consideration of Modification to Curbside Delivery of Cereal Malt Beverage

Analysis:

The Winfield Walmart store has requested a change in Municipal Code to allow for the curbside pickup and delivery of CMB.

This ordinance would allow for the curbside pickup of CMB, but specifically prohibits the delivery of CMB as it is currently not allowed under state law.

Fiscal Impact: The impact of this change from a revenue standpoint is hard to predict given the market total of CMB sales is likely fairly constant in the community.

AN ORDINANCE

AMENDING Chapter 6 of The Winfield City Code by the modification of enhanced cereal malt beverage curbside service.

WHEREAS, the City of Winfield received a request from a business in the community to examine and consider revising the ordinance relating to enhanced cereal malt beverage curbside and delivery service; and

WHEREAS, the City of Winfield has considered such modification in consultation with the Kansas Department of Revenue, Division of Alcoholic Beverage Control, finding favorable reasoning to approve such request related to curbside service, excepting the request related to delivery service due to restrictions by the State of Kansas;

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WINFIELD, KANSAS, THAT:

Section 1. Chapter 6, Section 6-31 of the Municipal Code of the City of Winfield shall read as follows:

General retailer licensees shall be permitted to furnish curbside service. Off premises delivery service by general retailer licensees is prohibited.

Section 2. This ordinance shall be in full force and effect from and after its publication in the official city newspaper.

Ladybird Brewing will apply for an extension of existing premises under current licensing for the duration of the event.

Fiscal Impact: The event is expected to bring in approximately 300 participants to Winfield. The tourism impact is positive for the community.

A RESOLUTION

AUTHORIZING an Outdoor Community Event and Temporary Entertainment District Application (Boneshaker Rides, LLC.)

WHEREAS, Boneshaker Rides, LLC. has made application for an Outdoor Community Event and Temporary Entertainment District; and

WHEREAS, Boneshaker Rides, LLC. requests the sale, possession, and consumption of alcoholic liquor or cereal malt beverage on city streets, alleys, parking lots, and public sidewalks during the Elrod's Cirque cycling ride/race, a special event, from 7:00 a.m. to 7:00 p.m., on May 14, 2022, on W. 6th Ave. between Manning and Main St.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF WINFIELD, KANSAS, THAT:

Section 1. Within Section 6-120 of Article IV of Section 6 of the Code of the City of Winfield, Kansas, "Temporary Entertainment District" means a defined area, which includes City streets, alleys, parking lots and public sidewalks on which the City Commission has authorized the sale, possession or consumption of alcoholic liquor or cereal malt beverage for a specified period of time, during a community event which has been properly permitted under Chapter 8 of this Code.

<u>Section 2.</u> A Special Event is defined by K.S.A. 41.719(a)(2). Alcoholic liquor may be consumed at a special event held on public streets, alleys, roads, sidewalks, or highways when a temporary permit has been issued pursuant to K.S.A. 41-2645 for such special event. Such special event must be approved, by ordinance or resolution, by the local governing body of any city, county, or township where such special event is being held. No alcoholic liquor may be consumed inside vehicles while on public streets, alleys, roads, or highways at any such special event.

Section 3. Ladybird Brewing, LLC, is a licensed Drinking Establishment, by the Kansas Department of Revenue, Alcoholic Beverage Control Division, and the City of Winfield. A "drinking establishment" means premises, which may be open to the general public, where alcoholic liquor by the individual drink is sold. Kansas Department of Revenue, Alcoholic Beverage Control Division granted Ladybird Brewing, LLC liquor license #10699, attached and made a part hereof, effective 02/12/2022 and expiring 02/12/2024. A separate Temporary Alcohol Permit is not required of Ladybird Brewing. Ladybird Brewing will obtain an extension of premises for their existing license.

<u>Section 4.</u> The governing body of the city of Winfield Kansas hereby authorizes an Outdoor Community Event and Temporary Entertainment District Application in accordance with the rules and procedures set forth by Article IV of Section 6 of the Code of the City of Winfield, Kansas, regarding the sale, possession or consumption of alcoholic liquor or cereal malt beverage as presented by Boneshaker Rides, LLC for the Elrod's Cirque, a special event, from 7:00 a.m. to

7:00 pm, on May 14, 2022, on W. 6th Ave between Manning and Main St., Winfield Kansas, as identified in the Outdoor Community Event and Temporary Entertainment District Application; a copy of which is attached hereto and made a part hereof.



Action Requested: Approval of a Right-Of-Way Use Agreement

Analysis: Brew Crew LLC, dba Scooter's Coffee has submitted preliminary plans for the construction of a new drive-through-coffee shop at 1802 Main Street. Due to corporate requirements for the site, the local Scooter's owner has requested to construct and maintain seven off-street parking stalls within the right-of-way of E. 18th Avenue. This agreement provides the parameters for the construction and maintenance of the seven parking stalls.

Fiscal Impact: None. The agreement requires the owner of the property to construct and maintain the improvement, therefore the City shall not be responsible for any associated costs.

RIGHT-OF-WAY USE PERMIT AGREEMENT

This Agreement made and entered into by and between the City of Winfield, Kansas hereinafter referred to as "City" and Brew Crew LLC, dba Scooter's Coffee, Sarah Kromer, Chief Executive Officer, hereinafter referred to as "Owner"

WHEREAS, the Owner wishes to improve their property and construct a new drive-through coffee shop at the property located at 1802 Main Street.

ADDITIONAL CONSIDERATION:

l. A temporary easement is hereby granted to the Owner along adjoining portions of City right-of-way for the purpose of constructing the improvement. This temporary easement will expire upon the completion date of the proposed improvements.

2. The Owner shall return the surface of City right-of-way excepting the improvements specified herein to the same or better condition as was found prior to construction.
