Date: June 26, 2018

Requestor: Patrick Steward, Dir. Of Public Improvements / City Engineer

Action Requested: Seeking approval of a modification to the existing Ordinance pertaining to four cubic yard trailer dumpsters.

Analysis:

The City has provided these dumpsters for a rental fee for use by customers. These containers are typically utilized by customers when they are doing specific projects or a clean-up that goes beyond their typical waste disposal needs. Currently, there are three rates: one for residential demolition materials, one for commercial demolition materials, and one for yard waste.

The container is the same regardless of the waste material to be disposed of and they are paid for at the time of rental. Often, customers intend to only have yard waste but end up including items that do not meet the definition of yard waste which causes confusion and additional billing. The requested amendment is primarily to simplify the system to two rates. One for commercial and one for residential.

In addition, the proposed amendments specifically define prohibited items. The landfill accepts most of the prohibited items directly but they either require special handling by staff or cause damage to the equipment. Therefore, the amendment proposes an additional charge if prohibited items are included at the time of collection.

Fiscal Impact: There may be a very slight increase in revenue due to the change of fee schedule. However, most rentals already were paying the higher rate so it would be negligible.

AN ORDINANCE

AMENDING

the Code of Ordinances of the City of Winfield, Kansas by of the repeal of Chapter 34, Section 34-78 (q), charges for collection of solid waste, and the adoption in lieu thereof, a new Section 34-78 (q).

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WINFIELD, KANSAS, THAT:

Section 1. Section 34-78 (q) of Chapter 34 of the Code of Ordinances of the City of Winfield Kansas is hereby amended by the repeal of section and the adoption in lieu thereof the following:

- (q) Charges for collection of solid waste. The charges referenced in section 78-556 are as follows:
 - (1) Residential dwellings, commercial, office or other establishments, not serviced by a city container. The charge for once-a-week collection of solid waste for each location shall be the sum of the solid waste & recyclables fee and the landfill disposal fee. That total shall be billed and payable monthly. Any commercial, office or other establishment that weekly requires more than once-a week collection shall pay solid waste & recyclables fee plus the landfill disposal fee, multiplied by the number of collections per week.

- (2) Two cubic yard and larger container rates. The charge for one or more containers used by a single customer shall be based on a schedule of fees as established by Resolution No. 0105, adopted January 3, 2005.
- (3) Use of a four-cubic-yard trailer. The charge for the use of a four-cubic-yard solid waste collection trailer for the collection and disposal of light building demolition materials and/or light construction waste and/or the collection and disposal of yard waste and/or similar items from residential premises shall be based on the schedule of rental fee of \$50.00 for 24 hours or per dump in a day from time trailer is set unless on weekend/holiday (Friday morning to Monday morning) as follows:

Definitions:

Light Building Demolition Materials, Construction Waste, Yard Waste, and Similar items:

<u>Items Accepted</u>: include but not limited to lumber, pipe, tree branches, shrubbery trimmings when all these items are cut in four foot lengths and NO limbs over four inches in diameter, glass, tile, floorcoverings, old shingles, grass clippings, leaves, and metal.

<u>Items Prohibited</u>: include vehicle tires, oil, fuel, chemicals, batteries, paint, concrete, bricks, utility poles, railroad ties, appliances (stove, washer, dryer, refrigerator, freezer, air-conditioner, or other bulky items).

(1) Additional charge for Prohibited Items. Prohibited Items that are found in the dumpster trailer when picked up from renter will receive one phone call to remove items first or if not removed renter will be accessed an additional \$50.00 charge added to the customer's city utility bill.

(2) Collection outside city limits. The charges for collection of solid waste from property outside the corporate limits of the city shall be 125 percent of the charges for collection with in the city limits.

<u>Section 2.</u> This ordinance shall be in full force and effective after its publication in the official city newspaper.

RESOLUTION NO. 5418

A RESOLUTION DETERMINING THE ADVISABILITY OF THE MAKING OF CERTAIN INTERNAL IMPROVEMENTS IN THE CITY OF WINFIELD, KANSAS; MAKING CERTAIN FINDINGS WITH RESPECT THERETO; AND AUTHORIZING AND PROVIDING FOR THE MAKING OF THE IMPROVEMENTS IN ACCORDANCE WITH SUCH FINDINGS (WATER MAIN IMPROVEMENTS/STONEBROOK ADDITION, PHASE 1).

WHEREAS, a petition (the "Petition") was filed with the City Clerk of the City of Winfield, Kansas (the "City") proposing certain internal improvements; and said Petition sets forth: (a) the general nature of the proposed improvements; (b) the estimated or probable cost of the proposed improvements; (c) the extent of the proposed improvement district to be assessed for the cost of the proposed improvements; (d) the proposed method of assessment; (e) the proposed apportionment of the cost between the improvement district and the City-at-large; and (f) a request that such improvements be made without notice and hearing as required by K.S.A. 12-6a01 *et seq.*; and

WHEREAS, the governing body of the City hereby finds and determines that said Petition was signed by the owners of record of more than one-half of the area liable for assessment for the proposed improvements, and is therefore sufficient in accordance with the provisions of K.S.A. 12-6a01 *et seq.* (the "Act").

THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF WINFIELD, KANSAS:

Section 1. Findings of Advisability. The governing body hereby finds and determines that:

(a) It is advisable to make the following improvements (the "Improvements"):

Install water main improvements to serve Lots 1 through 3, Block A; and Lots 15 through 17, Block A, Stonebrook Addition, City of Winfield, Cowley County, Kansas, in accordance with the City of Winfield Standard Specifications.
