BACKGROUND

This ordinance is a house-keeping item to clean up previous Ordinances that established the four Municipal Court Fees: Technology Fee, Building Security Fee, Truancy Prevention Fee and Jury Fund. Previous ordinances lined out the court costs to be paid and the percentage split between the four fees. Every legislative session, these percentages are changed. This new ordinance reflects Local Government Code Section 134 so it will stay current regardless of legislative changes.

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF WOLFFORTH, TEXAS, AMENDING THE WOLFFORTH CODE OF ORDINANCES BY AMENDING CHAPTER 7 MUNICIPAL COURTS BY AMENDING ARTICLE 7.02 MUNICIPAL COURT BUILDING SECURITY FUND AND DELETING ARTICLE 7.03 MUNICIPAL COURT TECHNOLOGY FUND; PROVIDING A REPEAL CLAUSE; PROVIDING A SEVERABILITY CLAUSE; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Texas legislature consolidated all municipal court fees, including the building security fee and the court technology fee, into one local consolidated fee on conviction of nonjailable misdemeanors;

WHEREAS, the local consolidated fee is mandatory for all convictions of nonjailable misdemeanor offenses and does not require adoption by the governing body for the jurisdiction of a municipal court; and

WHEREAS, the City Council of the City of Wolfforth finds that it is in the best interest of the good governance of the City to amend the Wolfforth Code of Ordinances to match current state law; **NOW THEREFORE**,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WOLFFORTH, TEXAS, THAT:

Part 1. Enacted.

Chapter 7 Municipal Court is amended by amending Article 7.02 Municipal Court Building Security Fund and deleting Article 7.03 Municipal Court Technology Fund. Article 7.02 shall read as follows:

ARTICLE 7.02 CONSOLIDATED FEE

§ 7.02.001 Established.

The Wolfforth Municipal Court shall collect the local consolidated fee on conviction of nonjailable misdemeanors in accordance with Texas Local Government Code Sec. 134.103 and maintain such funds and accounts for the local consolidated fee in accordance with Sec. 134.151.

Part 2. Severability

The provisions and sections of this Ordinance shall be deemed to be independent, and the invalidity of any portion of this Ordinance shall not affect the validity of the remainder.

Part 3. Repeal of Conflicting Ordinances

Part 4. Effective Date

BACKGROUND

On June 6th of 2023 the Wolfforth EDC agreed to propose an economic development project granting approximately \$225,000 to the city of Wolfforth for monument construction and landscaping. This will be located at the northwest corner of Donald Preston and Alcove Ave. The City of Wolfforth and Wolfforth EDC will be working alongside Kimley Horn and Skyrite to design a "Welcome to Wolfforth" monument sign to be placed on the property at Donald Preston Drive and Alcove. The monument will be double faced with an overall height of about 7'-7"5 and width of about 12'. This pricing includes Kimley Horn's architecture work. All landscaping is to be drought resistant and represent native plant life. The pecan tree that is currently on that property is healthy and will be pruned.

The EDC and city council will receive comments from the public between June 26, 2023 and August 24, 2023. The Council will then be presented with a Resolution for execution in support of this project.
