

Wyandotte Municipal Services (WMS) Save A Watt in Wyandotte – Energy Smart Program Residential Energy Efficiency Program 2022 Incentive Application for Rebate Program

Ready to start your project? Follow these 3 simple steps.

Step #1: Make Sure Your Project is Eligible

Check the specifications listed in this application and/or speak with an Energy Smart advisor by calling 734-324-7194 to make sure your project is eligible for Energy Smart incentives. All equipment must be new and installed or operated in a residential dwelling, whose electric service is provided by Wyandotte Municipal Services.

Step #2: Complete Your Project

Install your new, energy-efficient equipment and remove your old equipment, following the specifications listed in this application.

Step #3: Apply for Your Incentive

Once your project is complete, it's time to request your incentive, you must submit:

1. A completed and signed application; include WMS utility bill account number.
2. Itemized invoice(s) for contractor-installed equipment, including installation date, costs for equipment installed, installation labor, and model numbers.
3. For furnace and central air conditioning units, the AHRI certificate (available from contractor).
4. For ENERGY STAR® products/equipment, cut out the ENERGY STAR® logo and include a copy of invoice/receipt.
5. For intelligent surge protectors or 'smart strip' units, a copy of the invoice/receipt.



Your completed application and the required materials listed above must be received by December 31, 2022.

Limited funds are available. Please allow 6-8 weeks to receive your WMS utility bill credit from the time your completed application is received by Energy Smart.

Program begins January 1, 2022 and expires December 31, 2022. See page 4 for full list of rules.

Equipment Specifications & Documentation Requirements

GENERAL PROGRAM RULES

This offer is valid only for Wyandotte Municipal Services (WMS) residential electric customers for a limited time. Offer is good while funds are available, on a first-come, first-served basis. Program begins January 1, 2022 and expires December 31, 2022. WMS reserves the right to withdraw or change this offer without notice. Incentives may not exceed purchase price. Ineligible incentive requests are subject to denial or repayment to program. Incentive requests must be received by December 31, 2022. Call 734-324-7194 for more information. Products MUST be purchased during current calendar year to be eligible for rebate incentives. Products purchased in prior calendar years will be subject to denial.

EQUIPMENT SPECIFICATIONS

Central Air Conditioning: AHRI Certificate is required to verify efficiency. SEER 15, 16, or 17 required.

Furnace: AFUE \geq 95%. Condensing furnaces must have a sealed combustion unit. Air handlers must have ECM motor to be eligible for the incentive. AHRI Certificate is required to verify efficiency. Chimney liners must be installed where a high efficiency natural gas furnace replaces atmospherically drafter equipment that was vented through the same flue as a gas water heater. Flue closure protocol must be used when a high efficiency furnace is installed and the chimney is no longer in use. Incentives are limited to current furnace capacity.

ENERGY STAR® Room/Window AC unit, Dehumidifier, Refrigerator, Ceiling Fan, Freezer, LED Bulbs, TV, Monitor, and Personal Computer Products.

*ENERGY STAR® logo cut from the box in which the product was purchased is required to verify purchase, together with a copy of the receipt with model numbers on it. Limit 40 LED bulbs per customer.

ENERGY STAR® Heat Pump Water Heater: ENERGY STAR® logo from the box in which the product was purchased is required to verify purchase together with a copy of the invoice. Limit 1 incentive per customer.

Electric Water Heater: Must replace an existing electric water heater and have an Energy Factor (EF) \geq .93.

Electric Clothes Dryer: Must replace a standard efficiency electric clothes dryer. New unit must be high efficiency and contain a moisture sensor.

Programmable Thermostat: Must replace a non-programmable thermostat and be capable of maintaining two (2) separate programs and up to four (4) temperature settings for each program to address the different comfort needs of weekdays and weekends.

Intelligent Surge Protectors: Does not require ENERGY STAR® qualification. The Intelligent Surge Protector must be new and have one or more outlets that have integrated automatic (controlled) shut-off, when connected equipment is not being used (automatic control used to save energy). A copy of the receipt from the store where the intelligent surge protector was purchased is required. Limit 4 rebates per customer.
